## RESOLUTION

**WHEREAS**, the Mission of the School District of Lee County is to provide a quality education in a safe and well-managed environment; and

**WHEREAS**, one of the top priorities of the School Board of Lee County is to ensure a safe environment for all of its students, whereby every student is entitled to attend school without fear of bullying or harassment during education programs or activities, on school buses, or through use of data of computer software; and

**WHEREAS**, Florida Senator Carey Baker, from Eustis, and Florida Representatives Nick Thompson and Gary Aubuchon, of the Lee County Legislative Delegation, introduced a Bill entitled "Jeffrey Johnston Stand Up for All Students Act"; and


**WHEREAS**, the "Jeffrey Johnston Stand Up For All Students Act" would require all school districts to develop anti-bullying policies as a condition to receive federal Safe and Drug Free Schools money as well as a prerequisite to receipt of safe schools funds; and


**WHEREAS**, the "Jeffrey Johnston Stand Up For All Students Act" would allow schools to discipline students who bully or harass their peers, even if the behavior takes place off campus or during non-school hours; and

**WHEREAS**, the School Board of Lee County desires to have a complete copy of the "Jeffrey Johnston Stand Up For All Students Act" permanently attached to this Resolution upon its enactment;




