AGENDA TOPICS

Welcome

Mr. Ryan Richards welcomed everyone and thanked them for their service to CAC. He called for introductions around the room with each member introducing themselves with a brief description.

Meeting Minute Approval

Mr. Richards, called for a vote to approve the minutes of October 11, 2017. Motion by Mr. Darren Watkins, seconded by Mr. Ron Tyre. **Carried 10-0**.

Board Member Update – Mrs. Cathleen Morgan

Mrs. Morgan spoke on the School District's current debt and called on the CAC membership's expertise to help with ideas to raise money for schools. She passed out data that explained the approved Capital Plan; the 2018-2022 Capital needs and different scenarios of increased debt. Several comments were made from the committee on what could be done:

- Impose higher impact fees pros and cons politics and economics
- Impose sales tax
- The District cannot solicit but can get outside organizations to advocate on the District's behalf
- Media is free start early to plant seed to spread the word regarding sales tax
- Poll the tax payers
- Is there another organization asking for a tax increase? Mrs. Morgan stated that "Pennies for Community Progress" is asking for ½ cent
- PR needs to be forceful
- Get senior citizens involved to promote sales tax
- Build a story line to tell a vision to acquire sales tax
- Compare Lee County with other counties what are they doing to raise money for their schools?

Mr. Greg Blurton indicated that we need to find ways to achieve not only the building of new schools, but also maintenance, upgrades, additions, technology, safety and security in the next five (5) years. All comments from CAC will be shared with the internal committee working on the sales tax initiative.

Presentation – District Property and Growth – Greg Blurton

Mr. Greg Blurton displayed a PowerPoint presentation to show 22 buildable District-owned properties, and based on the next five (5) years, the proposed schools to be built in each zone. He stated the acreage needed for each level of school and pointed out that the highest growth was in the East, followed by South, then West. After identifying the properties for future schools, the next steps are to:

- Seek more brokerage firms for properties be sold, exchanged or acquired,
- Permitting properties for near-future schools and,
- Implementing the selling, exchanging or acquiring specific property that will benefit the District

Discussion:

- Can we consider going into a public/private partnership concept?
- Add on to already built schools portables are not a long-term solution
- When thinking about adding on to a school, must take into account all the other resources that are needed to expand a school, i.e., staff, cafeteria, sports, parking, etc.
- What about prototypes vs. designing from scratch

Mr. Blurton reminded everyone to study the Construction Manager at Risk (CMaR) project that was discussed at the October CAC meeting. After finance and procurement fills in their projections, the project will be brought back to CAC for feedback.
