#### Board Member Update – Mr. Steven Teuber

Mr. Teuber updated the committee on the H.B. 7069. At the beginning, Lee Schools was a part of 12 districts to sue the State for H.B. 7069 being unconstitutional. A couple of small districts dropped out, leaving 10 to file a motion to bypass the Appeals Court and go straight to the State Supreme Court. Hoping to hear a response soon.

#### **Elementary Prototype Design**

Mr. Mora spoke on the SREF mandatory needs of construction of any school. Space requirements are a huge additional expense and are not on an equal playing field of charter schools. He also mentioned that there are new legislations to build a cheaper school based on student stations. Fortunately, MMM will not have to fall under the new requirements based on having an architect under contract prior to the change. Mr. Mora will bring the new requirements to CAC for discussion. He also asked for the committee to go through the SREF manual and highlight items that could be brought to our legislatures for changes.

Mr. Mora stated that the Superintendent wants to go forward with a project plan and for CAC members to empower people who have to make decisions to pinpoint the milestones, find what decisions need to made and to do it methodically. Mr. Mora would like to implement a survey to principals who have been in prototypes, along with others who would have suggestions going forward. He then directed the committee's attention to the task of deciding what the pros and cons are for a general prototype design vs. a new build. After meeting in groups for 25 minutes, Pat Johnson was instructed to type up the results to be discussed at the June meeting.

It was determined to keep the June 6<sup>th</sup> meeting at the Lee County Public Education Center, Training Room "D" and schedule the August 1<sup>st</sup> meeting to be held at the new high school.
