Welcome

The meeting was called to order by Vice Chair Patti Lochner at 6:03 pm. Ms. Lochner announced Chair Latino was unable to attend the current CAC meeting due to another commitment. Ms. Lochner introduced Dr. Rodney Winkler, soon to be a Curriculum Advisory Committee Member. Dr. Winkler will be appointed by the Board on Tuesday, March 17, 2015. Dr. Winkler has been with the District in various roles for almost 29 years. He is a teacher advocate and his background is in curriculum.

Vice Chair Patti Lochner reported she presented the Curriculum Advisory Committee's recommendations to the Board regarding changes in Policy 2.18 on February 24, 2015.

Mrs. Pamela LaRiviere reported a good week while she attended committee meetings in Tallahassee. Mrs. LaRiviere reported legislators are hearing us regarding our concerns about the testing. Our Board members also discussed and shared documentation with legislators their request to have the school grades waived this year. Mrs. LaRiviere stated the House will be releasing their estimated budget very soon and legislators advised our members not to get upset or be discouraged by it. The Senate will then release their version and compromises will be reached.

Mrs. LaRiviere offered Kudos to all parents and community members who have expressed their concerns to our legislators regarding testing and funding for education.

Update - Policy 2.18:

Mrs. LaRiviere and Mr. Martin will be looking at the wording in the policy to include all subjects, not just core subjects. Once the correction is made, it will be presented to the Board in April. Once the Draft is completed, Mrs. LaRiviere will forward to the Curriculum Advisory Secretary to be shared via E-Mail with all committee members.

Questions:

Q. Is the Legislature pursuing allowing teachers to carry guns in the classroom? (John Traube)

A. There is a Bill that will most likely go forward that will allow the Superintendent and Staff (if there is a need) to bring forth discussion to the Board to determine if they should seek volunteer staff to assist. This Bill would affect smaller counties. (Mrs. LaRiviere)

Spelling, Grammar, Vocabulary and Writing

Instructional Materials to be used for ELA-Reading (Grades K-5) include *Reading Street, My Sidewalks, FL Social Studies & NatGeo Science.* For 6-12 include *Collections Anchor Text, and Close Reading.* Material for Reading Grades 6-8 are *Achieve3000 Lessons.* Materials for Reading Grades 6-12 (Level 1 & 2 students) include Achieve3000 Lessons, Intensive Reading (I.R.), & Close Reading (I.R.).

Instructional Materials to be used for ELA Writing include *Pearson Reading Street-Writing to Sources* (Grades K-5) and *Houghton Mifflin Performance Assessment Booklet* (Grades 6-12).

Instruction for ELA Reading and ELA Writing will be Standards Based. ELA Writing will also use Writer's Workshop.

District-Provided Assessments for K-5 ELA Reading & Writing are Progress Monitoring Assessments. For 6-12 ELA and Reading are Progress Monitoring Assessments. Performance Tasks for 6-12 ELA are embedded in Academic Plans and 3-11 Quarter 1 and mid-year Text —based writing prompts will be used.

Spelling and Grammar on the FSA ELA-Reading – Editing Task Items:

- Assesses the use of grammar, usage, and language conventions
- Task stimuli is a 3 to 4 paragraph passage with 5 to 6 grammatical, spelling and punctuation errors
- The first and last sentences in the passage will not contain errors
- The word(s) or phrases to be edited will be indicated by a highlight in the passage
- For each grade, the editing task will be similar to a students' essay in quality & difficulty
- Topics will be varied within and across grades
- Topics will be literary and informational
