New Business

Presented by Dr. Richard Itzen, Director, Accountability, Research and Continuous Improvement

Richard Itzen provided an update on the State FSA Writing testing currently being conducted in Lee County and across the State. He explained that the Writing component was now part of the overall English Language Arts test along with Reading. He also reminded the committee members that passing the Grade 10 FSA ELA (Writing and Reading) assessment is a requirement to receive a high school diploma in Florida.

He indicated that the Writing tests for grades 4-7 were on paper and grades 8-10 were being conducted online. He indicated that during the first few days of the testing window (March 2-13, 2015) there were many reports of login issues with the computer-based testing. Lee County delayed administration of the Grade 10 Writing test until the technical issues subsided because of the importance for the students for graduation purposes. By Thursday of the first week testing seemed to be going much more smoothly in Lee County and across the State.

Summary statistics from the first week of computer-based testing (March 2-6) indicate that Lee County was about 52% finished with testing at grade 8 testing, about 63% completed with grade 9, and 42% completed with grade 10. The testing window continues until March 13, 2015.
