Board Member Report

Ms. Fischer informed the committee that the Bonita High School property moves forward for Board approval on April 19, 2016. She also mentioned that the School District is doing its due diligence about the asbestos concern.

Ms. Fischer attended a Community Action Poverty Simulation on April 11, 2016. The Early Childhood staff offered the simulation to members of the District's Central Office Staff. This learning tool was created as a way to help people understand the realities of poverty. During the simulation, participants role-played the lives of low-income families. Ms. Fischer also noted that 70% of Lee County students are in the free and reduced lunch program.

On April 8, 2016 Ms. Fischer attended the 2015-2016 Golden Apple Teacher Recognition Banquet to honor our Lee County teachers.

Ms. Fischer recognized Talia Fernandez, who was inducted into the Football Hall of Fame.

Ms. Fischer stated that she had an editorial in both the Breeze and News-Press about the proposed half-penny sales tax.
