Dr. Pete Bohatch, Director, Student Services and Ken Dobson, Director, Safety and Security presented Focus Area 3: *Ensure a Safe and Healthy Environment for All*. Ms. Shiner-Nunes asked that the committee consider a recommendation in bringing city police officers back into schools as School Resource Officers. Ms. Shiner-Nunes also asked that the Safety Committee consider a recommendation to include PTO or other parent members to sit on school safety committees. Ms. Traiger asked for data related to dress code policy and enforcement (specifically uniforms) consistency across District by level and by zone. Ms. Shiner-Nunes asked if students are provided with CPR/AED training.
