## DISCUSSION - VIRTUAL VS FACE TO FACE MEETINGS

The committee began a discussion regarding whether to continue with face to face meetings or zoom meetings.

He then made the following motion, "The Finance Advisory Committee has a desire to meet face to face, but recognizes that some members will only continue to meet via a virtual environment, but there is a preference to meet face to face." This motion was seconded by Ken Boyd and a discussion ensued. The final vote was 4 for zoom meetings and 5 for face to face.

Kelly Letcher stated that she would check to see if a hybrid, in person/zoom model would be possible due to the requirement to record meetings.

### **BOARD MEMBER'S REPORT**

Debbie Jordan began by thanking the Finance Advisory Committee for the information that was given to her regarding RSM.

She shared that the School Board is still working on the formation of an Audit Committee and will share with the committee all information as it develops.

### DISCUSSION - DAVE LAROSA, DIRECTOR, ATHLETICS & ACTIVITIES

Mr. Dave LaRosa began by sharing some of the changes that needed to happen concerning the District's sports, due to COVID. He stated, "There is a protocol for each sport." "In the fall, the Florida High School Athletic Association made provisions for fall sports, but there were no provisions provided for winter sports." He added the biggest hurtle so far has been developing the protocol for wrestling.

Mr. LaRosa added, "Financially, we have taken a big hit due to the District limiting attendance...it will be a lean year".

## DISCUSSION - ROGER LLOYD, DIRECTOR, TRANSPORTATION SERVICES

Obstacles for the Transportation Department:

- \* National Shortage of Drivers
- \* 94% of drivers are over 65 years of age
- \* Some are taking FMLA during this time

The following shows a portion of the savings between 2019-20 and 2020-21:

Shawn Williams suggested to survey the parents to see why the students are not ride the bus. (More riders/more efficiency)

Mr. Lloyd shared that the students are loaded from the back to the front of the bus. Also, so far, there has not been more than 24 students on a bus.
