- > We continue to monitor Legislative bill activity through our lobbyists, Capital Strategies.
- New session began January 11, 2022
- Our legal team continues work on updating policies and keeping us in compliance with statutes. We are awaiting information regarding NEOLA, a company who monitors for statutory changes. There is work to be done on the Polivy4.221 Suicide Prevention and a collaborating Mental Health Policy.
- > We will evaluate the Board Attorney by April 15.
- Also, we are in the process of working with Audit Committee to hire a Board Internal Auditor as required for our district!
- Work by our Healthy Living Collaboration continues, and they are involved in Policy 4.223, Allergy Management, as we prepare to introduce PB&J as a protein rich and cost effective food into our schools for the first time since 2004.
- Superintendent Search continues and there are 5 Semi-Finalists. We will begin interviews on the 18th and 19th of January. A Search Critique committee will be appointed to assist in the process. Information can be found on the district website.
