- Welcome by Chair Hertz
- Discussion
  - Patricca: Thinking it may not make sense to keep the topic we had planned which was the book challenge and Miller test. There isn't much room for feedback from DAC since the district is already following the mandated guidelines. If we stick with it, it would be more to educate families.
  - Cupid-McCoy: Future legislation may cause changes soon so it makes sense to put this topic on hold for now.
  - Topic suggestions:
    - Naviance: Covered already but could discuss again
    - IB -vs- AICE -vs- AP -vs- Dual Enrollment: Beneficial to educate families on the differences and similarities and how each would affect the student's future. Elementary will have difficulty contributing to this conversation.
    - Bill (HB 733) which changes school start times effective July 2026: Too soon for this. We need to start the new year and see where we land as far as transportation is concerned once we implement the Proximity Plan.
    - Locations for future school sites: Are we looking at population distribution and planning for growth?
