Approval to award ITN No. N237454MG for Gate and Fencing Service, Installation and Repair, to V Enterprises of SWFL, LLC d/b/a Smith Fence Company of Fort Myers, Inc., as indicated on the attached tabulation sheet. This ITN will be effective for three years, beginning November 1, 2023 through October 31, 2026, with renewal options for three additional one-year periods, upon the written agreement of the vendor and the District, for up to \$2,000,000.00, for the first year of the base contract period of November 1, 2023 through October 31, 2024. Services include installation and repair of gates and fencing, which includes firm pricing for hourly labor rates and the contractor's cost and markup of fencing materials. Anticipated projects (Capital / Hurricane Ian Funds) are \$2,000,000.00, and are broken out as follows:

o \$1,194,000.00 - Hurricane Ian repairs/replacements (33 locations)

o \$400,000.00 - Safety & security upgrades o \$350,000.00 - Day to day repairs/parts

o \$56,000.00 - Ida S. Baker High School - Fence Replacement damaged by Hurricane Ian

It is recommended the award be made to V Enterprises of SWFL, LLC d/b/a Smith Fence Company of Fort Myers, Inc., as indicated on the attached tabulation sheet, effective for three years, beginning November 1, 2023 through October 31, 2026, with renewal options for three additional one-year periods, for up to \$2,000,000.00, for the first year of the base contract period of November 1, 2023 through October 31, 2024. Thirty-five (35) vendors were notified of the ITN, one(1) vendor submitted a Proposal, zero (0)vendors submitted a No Bid and Thirty-four (34)vendors did not respond.
