This ITN will be effective for three years, beginning November 15, 2023 through November 14, 2026, with renewal options for three additional one-year periods, upon the written agreement of the vendors and the District, for up to \$32,910,000.00, for the first year of the base contract period of November 15, 2023 through November 14, 2024.
