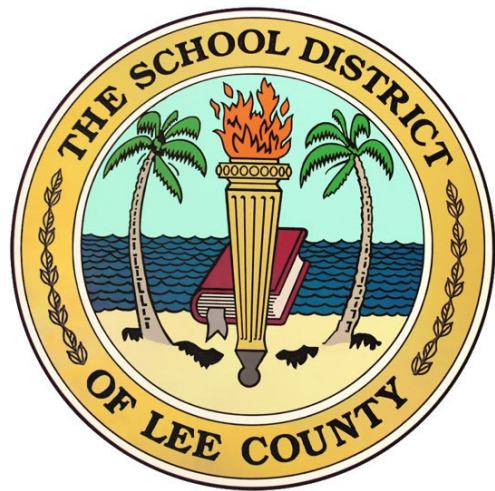

PREAMBLE

1 The Support Personnel Association of Lee County (SPALC) Contract includes the terms of employment
2 for all support staff, who are part of the SPALC bargaining unit regardless of whether they are dues
3 paying SPALC members. The SPALC Contract is a collective bargaining agreement made between The
4 School Board of Lee County and SPALC who is the Union and legal representative of the support staff
5 who serve the students of The School District of Lee County. The purpose of the SPALC Contract is to
6 promote a harmonious relationship between employees and their employer, to establish equitable
7 procedures for resolution of differences, and to memorialize specified terms of employment. The
8 SPALC Contract is a living document that through the mutual agreement of the parties, the District
9 and SPALC, can be modified to ensure responsiveness to the educational needs of our community
10 without interruption to educational programs. The School District of Lee County prides itself on the
11 positive relationship that has been built with the representatives of SPALC and seeks to continue this
12 positive relationship through open, honest, and regular communication.

DEFINITIONS

1 **(1) EMPLOYEE:** The term "employee" shall refer only to employees in the bargaining unit as defined
2 in Article 1.03.

3 **(a) FULL-TIME:** An employee who works twenty (20) or more hours per work week.

4 **(b) PART-TIME:** An employee who works less than twenty (20) hours per work week.
5

6 **(2) BOARD:** The School Board of Lee County, Florida, or its duly authorized representative(s).
7

8 **(3) SUPERINTENDENT:** The Superintendent of Schools for Lee County, Florida, or their designated
9 representative(s).
10

11 **(4) ASSOCIATION:** The Support Personnel Association of Lee County (SPALC), which is the sole and
12 exclusive certified bargaining agent for collective bargaining for the employees in the bargaining unit.
13

14 **(5) SUPERVISOR**

15 **(a) Assigned to Single School/Site:** In a school, the employee's supervisor is the building
16 principal or ~~his~~their designee.

17 **(b) Assigned to Multiple Schools/Sites:** if an employee works at more than one work site, the
18 employee's supervisor shall be the supervisor with whom a grievance is filed.

19 **(c) Not Assigned to a School/Site:** if an employee is not assigned to a school, the employee's
20 supervisor is the administrator by whom the employee is evaluated.
21

22 **(6) DAYS:** All references in this Agreement to days shall refer to calendar days except ~~when~~if
23 specified otherwise.
24

25 **(7) WORKPLACE:** "Workplace" is defined as the site for the performance of work done in connection
26 with the duties of an employee of The School Board of Lee County. That term includes any place where
27 the work of the School District is performed, including a school building or other school premises; any
28 school-owned vehicle or any other school-approved vehicle used to transport students to and from
29 school or school activities; and off school property during any school-sponsored or school-approved
30 activity, event or function (such as a field trip, workshop, or athletic event). The workplace does not
31 include duty-free time at conventions or workshops at which students are not present.

ARTICLE 1 –PARTIES TO AGREEMENT

1 **1.01 – PARTIES:** This agreement is entered into by the School Board of Lee County, also referred to as
2 the District, and the Support Personnel Association of Lee County, also referred to as the Association
3 or SPALC. The Articles of this contract are in compliance with Chapter 447, Florida Statutes, and shall
4 continue in effect as specified in Article 15 (Acceptance, Duration, and Reopening).
5

6 **1.02 – CERTIFICATION:** Pursuant to Chapter 447, Florida Statute, the District recognizes that The
7 Support Personnel Association of Lee County is certified by the Florida Public Employees Relations
8 Commission as the sole and exclusive collective bargaining agent for all employees in the Bargaining
9 Unit described herein with respect to wages, hours and terms, and conditions of employment. See
10 also PERC Case No. RA-93-009, Order No. 93E-249, Case No. RC-86-018, Order No. UC-86-044, Order
11 No. UC-87E-050, Case No. RC-86-009, 86E-132, 87E-050 and subsequent orders issued by PERC.
12

13 **1.03 – BARGAINING UNIT:** Included in the bargaining unit are all regular employees who are included
14 in the SPALC Salary Schedule. This includes, but is not limited to all full-time and part-time support
15 staff in the job classifications listed in Appendix C.
16

17 **1.04 – EXCLUSIONS:** Excluded from the bargaining unit are all casual employees and other regular
18 employees listed as part of other bargaining units or salary schedules. This includes instructional staff;
19 supervisory, technical, and confidential staff; and all administrative staff. Specifically excluded are all
20 members of management, including but not limited to the Superintendent, Chiefs, Principals,
21 Assistant Principals, Executive Directors, Directors, Assistant Directors and administrative
22 coordinators.

ARTICLE 2 – RIGHTS, PRIVILEGES, AND RESPONSIBILITIES

1 **2.01 – EMPLOYEES:** Employees shall have the right to join or not join the Association. Employees
2 shall have the right to engage in lawful concerted activities for the purpose of collective bargaining as
3 it relates to conditions of employment or compensation or other mutual aid or protection. The
4 employees shall have the right to refrain from engaging in such activities. They shall have the right
5 to express and communicate views in accordance with state and federal law and have the right to
6 a fair and equitable grievance procedure administered without regard to membership or non-
7 membership or by virtue of their holding or not holding office in the Association. This article shall
8 be applied to all employees by the employer and Association. Employees shall have all the rights
9 secured to them by PERC, Chapter 447, Part 2, Florida Statute, and as otherwise provided by law.

10
11 **(1) Non-Discrimination:** The Articles of this Agreement shall apply to all employees without regard to
12 race, color, religion, sex, sexual orientation, national or ethnic origin, marital status, pregnancy,
13 political affiliation, Association membership, age, creed, gender identity or expression, disability if
14 otherwise qualified, or any other unlawful factor.

15
16 **(2) Duty to Self-Report:** Each employee shall self-report to the District's Department of Professional
17 Standards and Equity, within two business days, any arrests and/or charges involving the abuse of a
18 child or the sale and/or possession of a controlled substance. Such notice shall not be considered an
19 admission of guilt. In addition, each employee shall self-report any conviction, finding of guilt,
20 withholding of adjudication, commitment to a pretrial diversion program, or entering of a plea of
21 guilty or Nolo Contendere (No Contest) for any criminal offense other than a minor traffic violation
22 within two business days after the final judgment. Unit employees, who regularly or incidentally
23 operate Board vehicles shall, as soon as they become aware, notify their supervisor of any moving
24 violation, suspension or revocation of their driver's license. Failure to comply with any article may be
25 cause for appropriate disciplinary action, up to and including termination. Such disciplinary action
26 shall be subject to the grievance procedure.

27
28 **2.02 – MANAGEMENT:** The Board hereby retains and reserves to itself, the Superintendent and all
29 administrative personnel the right to unilaterally determine its purposes, set standards of services,
30 and exercise control and discretion over its organization and operations. Management shall have
31 all of the rights secured to them by PERC Chapter 447, Part 2, Florida Statutes, and as otherwise
32 provided by law.

33 **2.03 – ASSOCIATION**

34
35
36 **(1) Facilities:** The Association shall have the privilege of using school facilities and equipment as
37 provided in Board policy.

38
39 **(2) Association Representatives:** The District shall recognize and deal with the Association
40 representatives designated in writing by the Association President. Any changes shall be submitted to
41 the District in writing. Upon arrival at any school or work site, such representative shall report to the
42 principal of the school or the supervisor of the work site and shall indicate the purpose of the visit.
43 In no event shall the Association representative interfere with or disrupt the work of an employee.
44

1 **(3) School Board Meetings:** The Association President or ~~his~~their designee shall have the right to
2 attend School Board meetings. The Association President or ~~his~~their designee will make arrangements
3 with the Superintendent to attend any Board meeting held during working hours. The Association will
4 reimburse the District for the wages of the Association employee who attends a Board meeting during
5 working hours.

6
7 **(4) Posting:** The Association shall have the privilege of posting notices concerning Association business
8 on bulletin board space not less than 24" x 36" exclusively assigned to the Association by the principal
9 or supervisor. The Association shall be given a list of the location of each bulletin board space and be
10 informed of any intended changes. The Association shall provide a copy of each notice to the
11 principal or supervisor prior to each posting.

12
13 **(5) Mailboxes:** The Association shall have the right to distribute Association materials in employee
14 mailboxes at school sites where such mailboxes are provided. ~~When~~If the Board and the Association
15 must communicate items of mutual concern to the employees of the District, the courier service
16 may be utilized to disseminate such communications. The Association agrees to indemnify the Board
17 for any claim that might arise on the issue of private express, including all costs, penalties, and
18 attorney's fees.

19
20 **(6) Dues Collection:** Each pay day, including final pay, the Board shall deduct Association dues from
21 the pay of every member who has signed an authorization card.(see Appendix A). Upon termination
22 from employment, any amount due the Association shall be deducted from the employee's final
23 paycheck. The authorization is revocable by the employee upon thirty (30) days' written notice to the
24 Board and the Association. The Board will provide the Association with a complete list of deductions
25 made each month. Dues deduction authorization cards must be presented to the Payroll Department
26 by the Association six (6) work days before the pay period in which the deduction begins. The Payroll
27 Department will notify the Association of a member's request to drop membership within seven business
28 days. Any dispute as to the amount of dues deducted shall be solely between the Association and the
29 employee. The Association and the employee shall hold the School Board harmless from any liability
30 arising from the deduction of any dues. In cases of deduction errors, adjustments will be made in
31 subsequent checks. ~~There shall be a charge for each deduction of five cents (\$.05) per deduction~~
32 ~~per member to be paid by the Association.~~

33
34 **(7) Association Leave:**

35 **(a) Members:** Upon written request of the Association President, ~~his or her~~their designee may
36 be allowed up to a total of 320 hours of leave per year without pay to conduct Association
37 business. A leave request shall be submitted to the Superintendent and the employee's
38 supervisor. The cumulative total granted to the Association shall not exceed 320 hours of leave
39 per year. The leave must be scheduled in a manner that will not adversely affect the operation
40 of the School District. No individual may use more than 80 hours of Association leave per year.
41 In the event the Association requires additional leave hours, a request will be submitted to
42 the SPALC Labor/Management Committee for review and possible agreement.

43 **(b) President:** The President of the Association may be granted personal leave for the
44 school year(s) of ~~his/her~~their term of office. Such leave shall be granted with the same privileges
45 and benefits approved with personal leave for other employees.

46 **(c) Bargaining Team:** An employee who is a member of the bargaining team shall be
47 released from work on paid leave if the bargaining calendar conflicts with the employee's work

1 schedule. In such event, the Association shall pay a qualified substitute except for impasse,
2 mediation, or upon mutual agreement of the parties. Otherwise, the employee's supervisor
3 may adjust the employee's work schedule with the consent of the employee.
4

5 **(8) Public Records:** Upon written request, the Board shall furnish the Association with other public
6 records. Inspection, examination and the cost of duplication of such public records shall be in
7 accordance with Board Policy and Chapter 119, Florida Statute.

8 **(a) New Hires:** The Board will furnish the Association a list of all new employees hired each
9 month. Such information shall include the employee's name, date of hire, department and job
10 classification. The Association shall pay the Board actual cost thereof.

11 **(b) New Employee Orientation:** A video featuring SPALC will be shown at all New Employee
12 Orientations and available at other meetings.
13

14 **(9) Consultation:** The Association may request meetings with management for the purpose of
15 discussing issues of mutual concern. The request must be in writing and include items to be
16 discussed. Management shall respond to such requests within five (5) days. Any written agreements
17 resulting from such meeting shall be ratified by the appropriate governing body of the Association and
18 the School Board or its designee.
19

20 **(10) Agreement:** For the duration of the Agreement the Board agrees to provide one copy of this
21 Agreement to the Association for every 20 employees governed by the Agreement within 30 days after
22 a print ready draft is approved by the parties. The Board further agrees to provide access to the
23 Agreement from the home page of the District's Website and to provide computer access to
24 employees in the unit for the purpose of reviewing the Agreement.
25

26 **(11) Strikes:** The Association agrees not to engage in a strike, work stoppage or other similar forms
27 of interference with the operations of the Board. Any employee, who participates in or promotes
28 a strike, work stoppage or other similar form of interference with the operation of the Board, shall
29 be subject to disciplinary action, up to and including discharge. In the event of a strike, work stoppage
30 or interference with the operation of the School Board administration, the President of the Association
31 shall promptly and publicly disavow such strike or work stoppage and strongly recommend that the
32 employees return to work and attempt to bring about a prompt resumption of normal operations.
33 The Association President shall notify the Superintendent within twenty-four (24) hours after the
34 commencement of such strike, about the measures it has taken to comply with this article. Failure to
35 abide by the terms of this article will automatically terminate this Agreement.

ARTICLE 3 – NEGOTIATION PROCEDURES

1 **3.01 – BARGAINING SESSIONS:** The meeting place, time and agenda for each collective bargaining
2 session shall be as agreed upon by the Superintendent and the Association's designated
3 representative. The parties agree to use the Interest-Based process. The SPALC Labor/Management
4 Committee shall meet to determine the agenda, training schedule, and calendar for bargaining of re-
5 openers and successor agreements. Bargaining team members shall receive temporary duty leave as
6 required for the purpose of attending to bargaining related duties.

7
8 **(1) Re-opener:** Re-openers are restricted to two (2) articles per party in addition to Article 10
9 (Compensation) and Article 11 (Benefits). One (1) additional article may be re-opened upon mutual
10 agreement of the parties.

11
12 **(2) Successor Agreement:** Successor agreements involve negotiation of all articles unless otherwise
13 agreed to by the parties.

14
15 **3.02 – TENTATIVE AGREEMENT:** Articles tentatively agreed upon at the table shall be signed by both
16 parties.

17
18 **3.03 - RATIFICATION:** No final agreement between the parties may be executed without ratification by
19 the bargaining unit and the Board. Following tentative agreement by the negotiating teams, the SPALC
20 Labor/Management Committee will prepare timelines for implementation. The Association shall
21 submit the full agreement to the members of the bargaining unit for ratification or rejection. The
22 Superintendent shall promptly submit the full agreement to the Board for consideration and
23 ratification or rejection.

24
25 **(1) Non-Ratification Procedure:** Should either the bargaining unit or Board not ratify the tentative
26 agreement, meetings between the negotiating teams must be convened within twenty (20) days.
27 This section shall not apply if impasse is invoked.

28
29 **(2) Impasse Procedure:** Impasse may occur only as provided for in Florida Statutes 447.

ARTICLE 4 –GRIEVANCE PROCEDURE

1 **4.01 – DEFINITION:** A grievance is defined as a claim by a named employee, or a group of named
2 employees, or the Association through the President, that there has been a violation,
3 misinterpretation or misapplication of articles in this Agreement. A grievance shall be processed as
4 hereinafter provided.

5 6 **4.02 – JURISDICTION**

7
8 **(1) Representation:** All members of the unit have the right to be represented by the Association in the
9 resolution of a grievance. Nothing herein shall be construed to mandate Association representation of
10 a unit member who is not also a member of the Association; nothing herein shall be construed to
11 prevent any member of the unit from presenting ~~his~~-~~their~~ own grievance in person or by counsel and
12 having such grievance adjusted without the intervention of the Association, if the adjustment is
13 consistent with the terms of this Agreement, and if the Association has been given the opportunity
14 to be present at the meeting called for the resolution of such grievances.

15
16 **(2) Rights:** Nothing contained in the grievance procedure shall be construed to deny the Board,
17 the Superintendent, the Association or any employee the rights otherwise guaranteed by law.
18 Retaliation for filing a grievance is strictly prohibited.

19
20 **(3) Responsibilities:** The filing of a grievance shall not interfere with the right of the Board to carry out
21 its management responsibilities to the final resolution of the grievance. The employee shall abide
22 by management's decision prior to and during the time the grievance is pending.

23
24 **(4) Expenses:** The fees and expenses of the arbitrator and witness fees for witnesses called by the
25 arbitrator shall be paid equally by the Board and the Association. Otherwise, each party shall bear its
26 own expenses.

27
28 **(5) Waiver:** ~~When-If~~ the Association and the supervisor agree that the supervisor will waive Level I,
29 the grievant may file the grievance and proceed through the grievance procedure from the informal
30 proceeding to Level II. In the case where an alleged violation exists at multiple work sites or affects a
31 broad class of employees, the parties may by mutual agreement begin at Level II of the grievance
32 procedure. The commencement of proceedings against the Board in a court or before PERC or any
33 administrative agency, by an employee(s) or the Association, for misapplication or misinterpretation of
34 the terms of this Agreement shall be deemed a waiver by said employee(s) and the Association of their
35 right to resort to the grievance procedure.

36 37 **4.03 - FILING**

38
39 **(1) Grievance Forms:** Grievance forms shall be available in electronic format on the District's
40 website or may be copied from Appendix B of this Agreement.

41 **(a) Time Limits:**

42 Failure of the grievant to process a grievance within the time limits herein provided
43 shall bar the grievance. The time limits provided in this article may be extended by
44 written agreement between the parties.

45 Whenever illness or any other incapacity of the grievant prevents attendance at any

grievance hearing, the time limits shall be extended to such time that the grievant can be present.

(b) Working Days: For the purpose of this grievance procedure, working days are defined as days that the District office is open for business.

(c) Withdrawal: A grievance may be withdrawn by the grievant at any time and at any level of this procedure. Once the grievant withdraws a grievance and/or arbitration request, the matter shall be considered closed and final. The same grievance may not be filed a second time by the same grievant. A written record of the withdrawal of the grievance and/or arbitration request shall be maintained in the grievance file.

4.04 - HEARINGS

(1) Informal Grievance: In the event that an employee believes that there is a basis for a grievance, ~~he/she/they~~ shall, within ten (10) working days of the alleged violation, schedule a meeting with ~~his-their~~ immediate supervisor to informally discuss the alleged violation. This meeting is often the best opportunity for the parties to achieve a positive resolution to avoid a formal written grievance. The meeting will take place within seven (7) working days of the date the employee notifies the supervisor, unless otherwise agreed upon by the parties. If after the informal discussion has concluded and the violation still exists, after seven (7) working days the grievant may utilize the formal grievance procedure. The grievant must initiate the grievance within seven (7) working days of the informal discussion. The grievant may choose to have an Association representative present during the informal discussion. It is the intention of the parties that the Level I Grievance Hearing shall not be an exact repeat of the Informal Grievance Hearing. The Level I Grievance Hearing will be waived if the same Administrator who conducted the unresolved Informal Grievance Hearing, would under normal circumstances, be the same individual conducting the Level I Grievance Hearing.

(2) Formal Grievance

(a) Level I: A copy of the grievance shall be forwarded by the grievant to the Superintendent and to the Association at the same time the grievance is filed with the supervisor. The supervisor shall meet with the grievant and ~~his-their~~ representative(s). Such meeting shall require at least seven (7) working days' notice and shall be held within seven (7) working days of the date of filing the formal grievance. The supervisor shall furnish ~~his-their~~ written disposition of the grievance to the grievant within seven (7) working days of the meeting and shall furnish a copy thereof to the grievant, the Superintendent, and the Association.

(b) Level II: If the grievant is not satisfied with the disposition of the grievance, or if no disposition has been made within the time limits as specified in Level I, the grievant may submit the same grievance to the Superintendent within seven (7) working days of the date of disposition or the expiration of the time limits for a disposition. The Superintendent shall meet with the grievant and ~~his-their~~ representative(s) within seven (7) working days of the date of filing. The Superintendent shall furnish ~~his-their~~ written disposition of the grievance to the grievant within seven (7) working days of such meeting and shall furnish a copy thereof to the supervisor and to the Association.

(c) Level III: In the event the grievant is not satisfied with the disposition of the grievance at Level II, or if no disposition has been made within the time limits as provided in Level II, the grievant, with approval from and representation by the Association, may submit the grievance to arbitration in accordance with the rules of the American Arbitration Association.

1 Submission of a grievance to arbitration shall be initiated by the grievant, ~~his~~their counsel or
2 by ~~his~~their designated Association representative, by filing a written request with the
3 American Arbitration Association and with the Superintendent within ten (10) working days of
4 the date of the Level II disposition of the grievance or the expiration of time limits for a
5 disposition. The disposition of the grievance made by the arbitrator shall be binding on both
6 parties; providing that the arbitrator shall have no power to add to, subtract from, modify, or
7 otherwise alter the terms of the collective bargaining agreement. The grievance may be
8 settled while the arbitration procedure is pending.
9

10 **(3) Confidentiality:** All meetings and hearings under the grievance procedure shall be held in private and
11 shall include only such parties, their representatives, and witnesses. Arbitration hearings shall be in
12 public.
13

14 **(4) Release from Work:** Grievances shall be processed during times which do not interfere with the
15 grievant's assigned duties, unless the parties agree otherwise. Temporary duty, without loss of pay,
16 shall be granted to employees whose attendance is essential ~~when~~if grievance meetings are held
17 during working hours.
18

19 **4.05 – DISPOSITION:** The date of disposition shall be defined as the date on which the supervisor
20 delivers the written disposition to the grievant if hand delivered in person; or the date of postmark in
21 those instances where delivery is by mail; or the date upon which the document is faxed to the grievant
22 or ~~his/her~~their representative; or the date upon which the document is delivered by electronic mail to
23 the grievant or ~~his/her~~their representative.
24

25 **(1) Records:** No records of a grievance shall be filed in an employee's personnel file.
26

27 **(2) Adjustments:** The adjustment of any grievance shall be consistent with the articles of this Agreement.

ARTICLE 5 –GENERAL EMPLOYMENT PRACTICES

5.01 – CONTRACT STATUS AND REAPPOINTMENT

(1) Probation: All employees shall be on probationary status for a period of twelve (12) calendar months from the date of initial employment. The employee shall be credited with work experience upon verification. Any recommendation for annual appointment must include the supervisor's written assessment of the employee in accordance with Article 8.02.

(2) Recommendation for Non-Reappointment: During the first two (2) years of employment the District may choose not to renew an employee's contract at the end of the employee's contractual year regardless of performance. After two (2) years of successful employment, no employee's contract shall be non-renewed.

(a) Notification An employee who is being considered for non-reappointment shall receive written notice from the supervisor by May 1.

(1) Employees Under Investigation: Employees with school or site based disciplinary investigations pending on or after May 1, who have not yet received notice of their reappointment status, will receive notice of their reappointment status after the completion of the investigation and a pre-determination conference. The only due process required under this article is a pre-determination conference. The decision to non-reappoint is final and is not subject to arbitration or administrative appeal. Supervisors will notify applicable employees on May 1 that their reappointment status will be provided after the completion of the investigation and predetermination conference.

(b) Appeal: Upon written request, the employee shall be granted a conference with the Superintendent for the purpose of reviewing the Supervisor's recommendation not to renew the employee's contract. The employee must request the conference within five (5) work days after receiving notification from his/her/their supervisor that non-renewal is being recommended. The Superintendent shall conduct the conference within ten (10) working days of the employee's request.

(c) Final Disposition: The decision of the Superintendent shall be in writing and shall be furnished to the employee within ten (10) work days after the conference. The decision is final and not subject to the grievance procedure unless it is arbitrary or capricious.

5.02 – SENIORITY: Seniority is the length of continuous service with the Board as a full-time or part-time employee. Any tie in seniority shall be decided by the Superintendent.

(1) Loss of Seniority: Employees lose their seniority as a result of the following:

- (a) Termination;
- (b) Retirement;
- (c) Resignation;
- (d) Layoff exceeding two (2) years;
- (e) Unexcused absence for more than three (3) consecutive work days;
- (f) Failure to report to Human Resources an intention to return to work within ten (10) calendar days of receipt of recall by certified mail with restrictive delivery;
- (g) Failure to report from military leave within the time limits prescribed.

1
2 **(2) Seniority List:** The Superintendent agrees to provide the President of the Association a current
3 seniority list by March 1 of each year and prior to any reduction-in-force. The seniority list shall include
4 only position titles listed in the salary schedule in Appendix C of this Agreement.
5

6 **5.03– TRANSFER**

7

8 **(1) Voluntary**

9 **(a) Request:** Each employee may request a transfer by contacting the supervisor or principal
10 at the site in which a vacancy exists and request an interview.

11 **(b) Seniority:** ~~When-If~~ two (2) or more employees apply for the same position, the employee with
12 the most in-county seniority will be given first consideration.

13 **(c) Notice:** All transfer applicants granted interviews shall be notified in writing by the
14 principal or supervisor of ~~his/her~~their decision.

15 **(d) Conflicts**

16 **(1) Administrator Agreement:** ~~When-If~~ an employee has been offered a new position
17 which will involve a voluntary transfer or promotion to another school or site, the two
18 (2) site administrators must reach agreement on the transfer within one week from the
19 date of acceptance.

20 **(2) Superintendent Approval:** If the two (2) site administrators do not agree to a
21 voluntary transfer decision, then an appeal can be made to the Superintendent for a
22 final decision regarding the transfer disposition.

23 **(3) Retention of Right:** The employee offered the new position retains a right to that
24 position during the period of transfer disposition resolution.
25

26 **(2) Involuntary:** Involuntary transfers may occur in response to financial needs, student needs,
27 discipline, resolution of work place civility concerns, and conflicts of interest.

28 **(a) Correct and Proper Operation:** Transfers shall be made on a voluntary basis, whenever
29 possible; however, correct and proper operation of the school district will necessarily require
30 that involuntary transfers be made.

31 **(b) Financial or Student Need:** Involuntary transfers may be made in the event of a school
32 closing. Involuntary transfers may be made to achieve a reduction in the number of employees
33 assigned to a school. Subject to job requirements and student needs, employees selected for
34 involuntary transfers shall be those with the least District seniority.

35 **(c) Criteria:** The Board shall determine the criteria for the selection of employees to be
36 involuntarily transferred. Such criteria shall be applied uniformly throughout the District.

37 **(d) Notice**

38 **(1) Association:** Prior to notices of involuntary transfers, SPALC will be notified and
39 given the opportunity to work out the timelines and guidelines for accomplishing the
40 involuntary transfer process and surplus.

41 **(2) Employee:** An employee selected for an involuntary transfer shall be given the
42 reason for such transfer and the opportunity to object to ~~his~~their supervisor about
43 such transfer. If requested by the employee, the reason shall be given in writing.

44 **(e) Training:** Prior to an involuntary transfer, employees with seniority may be provided an
45 opportunity to receive training for a similar position if available at their current work site. The
46 training must occur during a natural break in the employee's work schedule (i.e. summer
47 break) and not affect the efficient operation of the work site and/or the District. The

employee will participate voluntarily in the training and will not be provided pay and/or benefits for the time spent in training. If, at the conclusion of the training, management determines that the employee will not be capable of performing the functions of the new position the employee will be involuntarily transferred to a new location. Training will not be implemented solely due to an involuntary transfer and must already be available as a part of the District's normal or scheduled Professional Development offerings.

(f) Process

(1) Voluntary: Prior to determining involuntary transfers, employees shall be given an opportunity to volunteer.

(2) Order: A list of employees to be involuntarily transferred will be compiled by Human Resources. Vacancy information shall be provided to these employees.

(3) Preference: Thereafter, employees shall indicate the positions, in order of preference, which they desire.

(4) Seniority: After consideration of job requirements and student needs, employees who have the highest seniority shall be placed first.

(5) Job Classification: No new employee shall be hired in a job classification until all employees in that classification have been placed.

(6) Employee Refusal: Should an employee refuse to accept an assignment substantially equal to their current assignment, said refusal shall constitute a resignation by the employee.

(3) Reassignment: A reassignment of duties at the same school or site is not a transfer.

5.04 –REDUCTION IN FORCE: The Board will determine the classification by departments and schools to be reduced. The Board will notify the Association in advance of any reduction-in-force or reduction in hours action. Employees will be laid off or reduced in hours in the inverse order of their seniority in the District. Employees who are laid off, surplus, or reduced in hours may fill a vacant position, if qualified.

(1) Recall

(a) Time Limit: Employees in layoff or reduced in hours status will retain recall rights for two (2) years and shall have preference over applicants.

(b) Notice: Recall will be made by certified mail with restrictive delivery to the last address in the employee's records.

(c) Failure to Respond: Within ten (10) calendar days after receiving notice, laid off or reduced employees must respond to Human Resources. Failure to respond shall constitute a resignation by the employee.

(d) Exception: Recall will be offered to laid off or reduced employees if they are qualified to perform the job. A laid off or reduced employee, ~~when-if~~ offered recall, who is temporarily unable to return due to medical reasons certified by a licensed medical provider, may request an extension of recall.

(e) Seniority: Employees with the greatest seniority in that classification shall be recalled first.

5.05 – ASSIGNMENT OF DUTIES

(1) Job Description: The District will prepare, review, revise, and maintain job descriptions for those

1 jobs in the bargaining unit as it deems necessary. Human Resources will provide the Association copies of
2 new or revised job descriptions through the SPALC Labor/Management Committee and afford the Association
3 an adequate opportunity to review and provide written feedback prior to implementation. The role of the
4 Association in this regard will be advisory in nature. All job descriptions shall be posted on the Human
5 Resources section of the District website. The job descriptions shall list the required qualifications as
6 completely as possible. Every job duty in a job description need not always be specifically described,
7 and any omission does not preclude the required performance of all duties that are job related.

8 **(a) Regular Review:** The District agrees to review job descriptions to ensure that an accurate
9 reflection of performance expectations is maintained. The SPALC Labor/Management
10 Committee will review proposed changes in job descriptions prior to placement of these
11 proposed changes on the Board agenda. The SPALC Labor/Management Committee will
12 recommend job groups for consideration as-in the established-establishment of career
13 advancement paths.

14 **(b) Request for Review:** An employee may request a formal review of his-their job description
15 when-if the employee believes the current duties as assigned do not match the job description.
16 Requests for review shall be made in writing and submitted to the SPALC Labor/Management
17 Committee.

18 **(c) Supervisor Directives:** Nothing in a job description shall be construed that any employee
19 has the right to refuse to follow instructions.

20 **(d) ~~TALC-Instructional~~ Supplements:** ~~TALC-Instructional~~ sSupplement positions will not
21 conflict with an SPALC employee's primary job duties, work schedule, or hours.

22
23 **(2) Temporary Reassignment:** When-If an employee is assigned to perform all the essential functions
24 and duties of a position in a pay grade higher than the employee's regular pay grade the employee
25 shall be paid at the higher pay grade. Any suspected abuse of the temporary assignment article or
26 unfair assignment of opportunities for short term assignment practices will be referred to the SPALC
27 Labor/Management Committee.

28 **(a) Mileage:** If an employee is asked by a supervisor to leave the work site on District
29 business, using his-their personal vehicle, the Board shall reimburse the employee for
30 actual mileage and furnish liability insurance coverage as provided by the District's self-
31 insurance plan. No employee shall be required to use his-their personal vehicle for District
32 business.

33
34 **(3) Temporary Duty:** Upon the approval of the supervisor, an employee may be assigned to be
35 temporarily away from his/her/their regular duties and/or place of employment for the purpose
36 of performing other job-related services, including but not limited to participation in surveys,
37 professional meetings, study courses, workshops, professional organization meetings and similar
38 services of direct and long-term benefit to the work group.

39 **(a) Training Opportunities:** Employees will be given an opportunity for training in job
40 advancement skills.

41
42 **(4) Substitutes:** If an employee is on an approved leave of absence, and no substitute is utilized, no
43 additional duties shall be distributed to other employees unless comparable duties are specified by
44 the principal, supervisor or designee as duties not to be completed.

45
46 **(5) Interns:** Interns may be identified as needed for the efficient operation of the school system and
47 to provide advancement opportunities for employees. At the end of the internship, employees not

promoted to positions in which the internship was served shall be returned to a position comparable to the position held prior to serving the internship.

(6) Satellite Work Sites: In departments where zones, regions or satellite work sites are established, employee preferences by seniority will be considered. The Superintendent reserves the right to assign employees as needed. Bidding procedures shall be established through labor/management meetings in each department affected.

(7) Subcontracting: The ~~Board~~ District agrees to utilize subcontractors only for a specific need or in case of an emergency.

5.06 – EMPLOYMENT OPPORTUNITIES: Job openings and new positions shall be filled as herein provided.

(1) Advertising Vacancies: A list of job openings shall be provided to Association representatives at each work site upon request. Job openings shall also be posted on the District website for five (5) consecutive work days prior to filling the position. Posted job openings shall include the beginning hourly rate.

(2) Filling Vacancies: ~~When-if~~ job vacancies occur, the applicant whose qualifications, seniority, work experience and interview responses are superior, shall be offered the position.

(3) Job Specific Skills: Any job specific skills, knowledge, abilities and qualifications in addition to the approved job description expected of applicants shall be determined prior to considering any applicants for a vacancy. Additional skills, knowledge, abilities and qualifications shall not be to the extent that it would create a new job classification or be equivalent to an existing job classification and job description.

(a) Notice to Employees: Employees shall be informed about practices, policies and procedures relating to filling of vacancies.

(b) Association Participation Request: SPALC may request to have a member participate in the process used to fill vacancies; however, management is under no obligation to permit the participation of the SPALC member.

(c) Pre-Employment Testing: SPALC shall be involved in the selection of tests, assessment tools and scoring guides used in the selection process. If tests are used, applicants shall be informed of any tests and the process that will be used prior to the interview. Training shall be provided to employees about the process to be used and the skills necessary for each job.

(4) First Consideration: Current employees of the District who apply shall be given first consideration prior to other applicants.

(a) Seniority: If the Superintendent determines that two or more current employee applicants are equally qualified, the employee applicant with the most in-district experience will be offered the position.

(b) Substitute/Temporary Employees: Persons who have been hired as substitute/temporary employees and have worked successfully for six (6) months or longer shall be considered at the same time as current employees ~~when-if~~ vacancies occur. No temporary appointment shall become permanent unless it has been advertised in accordance with Article 5.06(1).

1 (c) **Change in Shift:** ~~When-If~~ it is necessary to transfer an employee from or to a day or
2 evening schedule, the supervisor shall, among other job-related considerations, recognize the
3 seniority of the employee. ~~When-If~~ a position becomes vacant and creates an opportunity for
4 a change in work schedule/shift, notice of the vacancy will be posted in a prominent location
5 at the site or school. Employees in the vacant job classification are responsible for notifying
6 their supervisor of their interest in the vacant position. Supervisors shall, among other job
7 considerations, recognize the seniority of employees requesting to be moved to the vacant
8 position.

9 (d) **Notice:** Applicants shall receive timely notice of the hiring decision. If an unsuccessful
10 employee applicant makes a written request to the supervisor responsible for the selection
11 process within ten (10) working days of ~~his-their~~ interview appointment, the supervisor will
12 schedule a conference within ten (10) days of receipt of the written request to discuss ~~his-their~~
13 application and possible changes to enhance the employee's opportunity for future
14 promotion.

15
16 (5) **Summer School Vacancies:** Summer school vacancies will be posted and filled in accordance with
17 Article 5.06 and are subject to job requirements and student needs. The District agrees to meet
18 and consult with SPALC representatives regarding the development of the Summer School handbook
19 as it relates to employment of SPALC members for summer school. Decisions regarding the
20 development of the Summer School handbook as related to filling summer school vacancies will be
21 made in a collaborative manner when possible.

22
23 **5.07 – AMERICANS WITH DISABILITIES ACT:** Any employee that believes that ~~he or she has~~ they have a
24 disability under the ADA may apply for a reasonable accommodation if the employee deems such an
25 accommodation necessary. The request will be reviewed pursuant to the District's ADA review
26 process. The District's application of the ADA review process shall be the sole issue under this article
27 subject to the grievance procedures as outlined in Article 4 of this agreement. The decision and/or
28 outcome of the employee's application or request shall not be the subject of a grievance as outlined
29 in Article 4 of this agreement, but may be appealed pursuant to the District's ADA review process.
30 Information about the ADA, ADA accommodation request forms, and ADA medical certification forms
31 are posted on the District's website.

32 33 **5.08– WORKERS COMPENSATION**

34
35 (1) **Limited Duty:** Employees who have experienced a workers' compensation injury and who have
36 been evaluated and released by an approved physician as physically able to return to work with
37 specific limitations, will return to their job site upon written authorization by Insurance and Benefits
38 Management. Specific work limitation will be forwarded to the employee's supervisor from the
39 treating physician. The employee will remain in ~~his/her~~ their job site, performing appropriate duties
40 as identified by ~~his/her~~ their supervisor for a period of time agreed to by the employee and the work
41 site supervisor. The employee will be evaluated by ~~his/her~~ their physician as necessary based on the
42 course of treatment and, if not released for full duty, will be returned for limited duty for a work
43 period agreed to by the employee and the work site supervisor. At the completion of the second
44 work period, if the employee is not able to return to a full-duty status, he will be evaluated by the
45 physician, principal/supervisor and the Insurance and Benefits Management to determine the
46 employee's status. Alternatives such as returning to workers' compensation off-duty status,
47 continuation of limited duty assignments, Alternate Duty assignments, and/or other assignments will

1 be reviewed with the employee. If a period of limited duty exceeds six months the District will notify
2 the Association of the identity of the employee.

3 4 **(2) Alternate Duty**

5 **(a) Evaluation:** Employees who have experienced a workers' compensation injury and who
6 have achieved maximum medical improvement as determined by an approved physician and
7 are unable to return to their previous position may be eligible for alternate duty assignments
8 in accordance with Article 5.08(2)(d). Employees will be evaluated by a variety of methods for
9 alternate duty within the school district by the Insurance and Benefits Management. The
10 District will not assist finding alternative employment outside of the district. This process
11 does not guarantee future employment within the School District. The alternate duty
12 evaluation is not a 440.441 re-employment assessment as it is not an evaluation to determine
13 whether an employee is capable of returning to suitable, gainful employment in the open
14 labor market. The District shall notify the Association prior to the evaluation of an employee.
15 Employees who do not meet the criteria for Alternate Duty shall lose their employment with
16 the District.

17 **(b) Training Assignment:** Alternate Duty assignments are trainee positions at job sites to be
18 identified by Human Resources after a thorough review of the employee's job history,
19 qualifications, and physical limitations. Positions such as clerk typist, data entry and teachers'
20 assistants are some of the possible opportunities for Alternate Duty training.

21 **(c) Funding:** All Alternate Duty positions will be funded from the Workers' Compensation loss
22 fund budget, as directed by the Insurance and Benefits Management.

23 **(d) Training:** Employees will be placed in an Alternate Duty training position based upon their
24 physical abilities (as determined by their treating workers' compensation physician) and their
25 vocational aptitudes (as determined by vocational testing, educational certifications, etc.).
26 Adjustments may be made to the job duties of the position; however, the employee must be
27 capable of performing the essential functions of the position as described in the job
28 description. Positions related to the employees' current position and/or level of expertise shall
29 also be given consideration when-if being placed in an Alternate Duty training position.

30 **(e) Time Limit:** The total maximum time an employee may remain in an Alternate Duty
31 "training status" is one year. The maximum time may be extended to two years under
32 extenuating circumstances. (Example: illness, language barrier, etc.).

33 **(f) Successful Completion:** Employees will be deemed "trained" when-if they have successfully
34 acquired the minimum skills necessary to qualify for the position for which they are training,
35 as acknowledged by their supervisor and Insurance and Benefits Management.

36 **(g) Failure to Complete:** An employee shall lose their employment with the District if the
37 employee fails to achieve "trained" status within one year (or two years for employees with
38 extenuating circumstances) and no positions exist within the District that meet the physical and
39 aptitude requirements of the employee.

40 **(h) Change in Training:** Employees who are unsuccessful in their initial training position, may
41 make one change of training assignment within the one-year period (two-year period for
42 employees with extenuating circumstances); however, a change of training position will not
43 extend their training timeline.

44 **(i) Application Upon Completion:** Once employees are deemed "trained" by Insurance and
45 Benefits Management, they are required to apply for all positions, for which they have received
46 training, within a reasonable commute.

47 **(j) Placement Upon Completion:** For employees who are unsuccessful in finding a regular

position within 60 working days of achieving "trained" status, Human Resources will begin procedures to place those employees in regular positions.

(k) Refusal: If an employee refuses to be tested for Alternate Duty placement or to participate in ~~his/her~~their assigned Alternate Duty training program, this shall be deemed a voluntary resignation of employment.

(l) Summer Assignments: Employees who worked less than a 12-month schedule at the time of their work-related accident will not be guaranteed summer employment while participating in the Alternate Duty Program.

(m) Covered Employees: This article applies to employees currently enrolled in the Alternate Duty Program at the date of this Agreement. This article applies to all Alternate Duty employees.

(n) Wages: Employees selected for Alternate Duty assignments will be paid in accordance with the appropriate salary schedule, but in no case shall the employee receive less than the amount received prior to the injury. Employees assigned to positions at a higher pay rate shall be paid at the rate of the job performed ~~when-if~~ the employee is fully trained in that position as determined by management.

(o) Continued Employment: Following a successful training period, employees who continue employment in a new assignment and are paid at a rate less than their pre-injury rate shall be reimbursed for any loss of wages which occurs due to the acceptance of the position in accordance with the appropriate wage loss procedures as defined by Section 440, Florida Statutes. Following a successful training period, for those employees with a date of injury occurring prior to January 1, 1994, who continue employment in a new assignment at a rate less than their pre-injury rate shall be reimbursed for any loss of wages in accordance with the appropriate wage loss procedures as set forth in Section 440 F.S. Those employees who sustained injuries subsequent to January 1, 1994, are not eligible for such wage loss benefits.

5.09 – VETERAN'S PREFERENCE: Veteran's Preference shall be granted in accordance with applicable state and federal laws. Nothing herein shall be construed to expand any Veteran's Preference beyond the limits of applicable state and federal law.

5.10 – PERSONNEL FILE

(1) Inspection: Each employee has the right to have another person accompany him to review ~~his~~his-their personnel file, if he so chooses. Such review shall be made before or after the employee's work day or during duty-free lunch, unless the employee is on leave, in the presence of the person responsible for the safekeeping of the personnel files. The Board will provide, within five (5) work days, a copy of as much of the contents of the employee's personnel file as is requested in writing by the employee. The cost of duplication of such records shall be paid by the employee.

(2) Response: Each employee has the right to comment in writing concerning any materials in ~~his~~his-their personnel record.

(3) Copies: An employee will receive copies of any document referred to in Articles 8 and 5.09 within one (1) business day from when ~~s/he~~they signs the document.

ARTICLE 6 – WORKING CONDITIONS

6.01 – PHYSICAL FACILITIES

(1) Safe and Secure Conditions: Adequate, clean, safe and sanitary working conditions shall be provided for all employees. No employee shall be required to work in conditions that are not safe or secure or perform tasks which endanger health and safety. The site supervisor or principal shall, in consultation with the Safety & Security Department whenever possible, make an initial determination as to whether an unsafe working condition exists.

(2) Reporting Unsafe Conditions: An employee who becomes aware of an unsafe or dangerous working condition shall immediately report the situation to the site administrator. A Safety/Security Deficiency Form shall be provided to employees either in an electronic file or by hardcopy, for reporting purposes and shall be located in an easy to find location on the District website. The supervisor shall investigate the report and initiate whatever corrective action [he/she/they](#) deems appropriate with consultation and notice given to the Safety & Security Department. If the employee believes that the condition has not been corrected, [he/she/they](#) may report it to the School or Site Safety/Security Committee in writing on the Safety/Security Deficiency Form. All hard copies of the Safety/Security Deficiency Form shall be directed to the Safety & Security Department and a copy of the report shall be maintained by the site administrator.

(3) Safety/Security Equipment: The District will determine proper and necessary safety and security equipment and devices for employees. An employee who fails to use safety or security equipment as directed may be subject to discipline.

(4) Training: Specific, job-related training shall be provided to employees at the expense of the Board. Qualified employees will be offered an annual training opportunity based on their job duties, seniority, if relevant, and technological advances in the trade. All training required by the Board will carry inservice points and will be paid at the employee's hourly rate. Employees attending required training outside the employee's regular work schedule will be paid at their regular hourly rate or at the overtime hourly rate. If a senior employee believes s/he should have been offered training that was offered to a different employee, s/he may file a grievance to be heard by the supervisor.

(a) Medically Related Procedure: Any employee who is required to administer any medically related procedure shall receive training on such procedures. All required training shall be at the discretion and expense of the Board.

(b) Standardized Assessments: Any employee who is required to administer and/or proctor any statewide standardized assessment or assessments associated with Florida approved courses shall receive training prior to administering and/or proctoring such assessments.

(c) Security Specialists: Security Specialists will receive specific, job related safety and security training beginning in FY16.

(d) Paraprofessionals: The Labor/Management Committee will develop a list of specific, job related training items for paraprofessionals. Paraprofessionals shall receive this training within the first thirty (30) days of their employment.

(e) Clinic Assistants: The District commits to continue to improve training for Clinic Assistants.

1 (f) **Custodians:** The District will provide training on identifying hazardous waste and the steps
2 necessary to report hazardous waste. Emergency phone numbers will be made available to
3 nighttime custodians and will be included in the MSDS Manual.
4

5 (5) Transportation

6 (a) **Safe Driver Plan:** Revisions of the Safe Driver Plan shall be implemented only after
7 consultation with the Association through the SPALC Labor/Management Committee and
8 memorandums of understanding. The Safe Driver Plan shall not prohibit any employee
9 from exercising any rights or privileges provided by law, rule or this Agreement.

10 (b) Student Discipline

11 (1) **Training:** The District will provide training for bus operators/attendants/monitors in
12 methods of maintaining discipline. The training shall include cultural sensitivity. The
13 principal or designee shall meet with employees assigned to buses serving the school
14 no later than three (3) weeks after the start of each school year to review the school's
15 discipline procedures pertaining to transportation of students. These meetings shall
16 be coordinated through the Senior Administrator for each Transportation Zone.

17 (2) **Process:** ~~When-If~~ a transportation employee has exhausted the District bus
18 discipline procedures and a student still requires the attention of the principal or
19 other school or District staff, the transportation employee shall so inform the principal
20 or designee, on the approved referral form. ~~When-If~~ a transportation employee
21 submits a disciplinary referral, the principal or designee shall write the action taken
22 on the form and return a copy to the transportation employee within five (5) work
23 days. If the problem continues, the transportation employee's supervisor will arrange
24 for a meeting with the principal or designee, the transportation employee's supervisor
25 and other parties as deemed appropriate. For Schools with continued problems, the
26 issue will be referred to the Executive Director of Transportation to find a solution.

27 (c) **Bus Ramps:** Transportation employees and any school-based employee who is required to
28 perform bus ramp duties must receive bus ramp safety training.
29

30 (6) Custodians

31 (a) **Safe Environment:** ~~When-If~~ custodians are required to work outside in darkness or in
32 secluded areas, the supervisor shall utilize one of the following options to ensure a safe
33 working environment: Provide a communication device, Assign another person to work in the
34 same vicinity during the same time, Adjust the employee's work schedule to allow the
35 employee to perform required duties during daylight hours.

36 (b) **Safety Equipment:** Provide necessary safety equipment, such as appropriate fitting
37 rubber boots, upon request by school or site supervisor. Necessary safety equipment to be
38 agreed upon by the SPALC Labor/Management Committee and consistent with Article 3.01(4).
39

40 6.02 - PROTECTION OF PERSON:

41
42 (1) **Injury:** The ~~Board-District~~ assures employees of its support ~~when-if~~ employees have followed the
43 laws and regulations of the State and the policies of the Board in carrying out their responsibility. An
44 employee involved in injury to himself, a student or to another employee shall immediately report
45 same to ~~his-their~~ supervisor and thereafter make such written reports as necessary to comply with
46 ~~Board-policy~~ School Board Policy.
47

1 **(2) Workplace Civility:** Employees shall not engage in speech, conduct, behavior (verbal or nonverbal),
2 or commit any act of any type which is reasonably interpreted as abusive, profane, intolerant,
3 menacing, intimidating, threatening, or harassing against any person in the workplace.
4 Bargaining unit employees may address alleged violations of this article through the grievance
5 procedures as outlined in Article 4 of this agreement. The resolution of a complaint under this
6 article may result in the involuntary, temporary transfer of an employee or employees pursuant to
7 Article 5.03(2) of this agreement. Such transfer may become permanent ~~when-if~~ deemed necessary
8 by the Superintendent or the Superintendent's designee.

9
10 **(3) Harassment or Discrimination:** The District is committed to ensuring equity in school programs
11 and employment practices. The District prohibits harassment and discrimination as provided in
12 Florida Statute 100.05 and School Board Policy 1.23. Employees who feel they have been harassed or
13 discriminated against are encouraged to submit a complaint in accordance with board policy.

14
15 **(4) Nursing Mothers:** Protections shall be granted to nursing mothers in accordance with applicable
16 state and federal laws, including Section 7 of the Fair Labor Standards Act. Nursing mothers will be
17 provided with reasonable break time to express breastmilk for one year after a child's birth. The
18 District will provide a place, other than a bathroom, that is shielded from view and free from intrusion
19 by co-workers and the public, which may be used by an employee to express breastmilk. Employees
20 must keep their immediate supervisor informed of their needs so that appropriate accommodations
21 can be made with minimal disruption to the employee and the worksite. Nursing mothers who feel
22 they have been denied appropriate accommodations are encouraged to contact Human Resources.
23 Nothing herein shall be construed to expand these protections beyond the limits of applicable state
24 and federal law.

25
26 **(5) Domestic or Sexual Violence:** Protections shall be granted to employees who are victims of
27 domestic or sexual violence in accordance with Florida Statute 743.313. Employees will be provided
28 with leave in accordance with Article 12. The District will ensure that related public records exemptions
29 are provided, may refer reported cases to the appropriate Threat Assessment Team for review, and
30 will allow employees to request a temporary transfer or reassignment. Employees must keep their
31 immediate supervisor informed of their needs so that appropriate accommodations can be made
32 with minimal disruption to the employee and the worksite. Employees who feel they have been denied
33 appropriate accommodations are encouraged to contact Human Resources. Nothing herein shall be
34 construed to expand these protections beyond the limits of applicable state and federal law.

35 36 **6.03 - PROTECTION OF PERSONAL PROPERTY**

37
38 **(1) Reimbursement for Theft or Damage:** The District shall reimburse employees for personal property
39 theft or damage under the following conditions:

40 **(a) District Purpose:** The employee's personal property must be used for District purpose with
41 the consent of the employee's supervisor.

42 **(b) Timely Report:** An incident report/claim documenting the loss/damage and signed by the
43 supervisor must be submitted to the Insurance & Benefits Management within one business
44 day of the incident.

45
46 **(2) Personal Hand Tools:** The District shall reimburse employees for the replacement cost of hand
47 tools under the following conditions:

1 (a) **Location:** The hand tools must have been stolen from District-owned property, including
2 vehicles.

3 (b) **Due Diligence:** The employee must demonstrate [he/she/they](#) exercised reasonable diligence
4 in the care and protection of the tools.

5 (c) **Timely Report:** An incident report/claim documenting the loss/damage and signed by the
6 supervisor must be submitted to the Insurance & Benefits Management within one business
7 day of the incident.

8 9 (3) Personal Automobile

10 (a) **Theft and Vandalism:**

11 The District shall reimburse employees for theft and vandalism losses to their personal
12 autos under the following conditions:

13 (1) **Timely Report:** An incident report/claim documenting the loss/damage and
14 signed by the supervisor must be submitted to the Insurance & Benefits
15 Management within one business day of the incident.

16 (2) **Police Report:** A police report must be filed documenting theft or vandalism.

17 (3) **Negligence:** Loss must have been the direct result of District negligence.

18 (4) **Reimbursement:** Maximum reimbursement of \$250 toward amount not covered
19 by employee's personal auto insurance deductible.

20 (b) **Collision:** The District shall reimburse employees for collision losses to their personal autos
21 under the following conditions:

22 (1) **District Purpose:** The employee was driving [his/her/their](#) personal auto in the course
23 and scope of employment with the consent of the employee's supervisor.

24 (2) **Timely Report:** An incident report/claim documenting the loss/damage and signed
25 by the supervisor must be submitted to the Insurance & Benefits Management within
26 one business day of the accident.

27 (3) **Reimbursement:** Reimbursement shall be limited to the employee's personal auto
28 insurance collision deductible.

29 (4) **Fault:** Reimbursement shall be limited to accidents in which the other party is at
30 fault (a citation is issued).

31 (5) **Police Report:** A copy of the law enforcement accident report must be submitted
32 to the Department of Insurance and Benefits if and when it becomes available.

33
34 **6.04 – ALCOHOL, TOBACCO, AND DRUG-FREE WORKPLACE:** No employee shall possess, consume
35 or sell alcoholic beverages or manufacture, distribute, dispense, possess or use, on the job or in the
36 workplace, any narcotic, drug, amphetamine, barbiturate, marijuana or any other controlled
37 substance, as defined in the Controlled Substances Act (21 U.S.C. 812), and as further defined by
38 regulations at 21 CFR 1300.11 through 1300.15, or by Florida Statutes, Chapter 893.

39
40 (1) **Notice of Arrest:** As a condition of employment, each employee shall: abide by the terms of this
41 article, and; notify the appropriate director, principal or supervisor of any criminal drug statute
42 conviction for a violation occurring on the premises of the Lee County School Board, at the
43 workplace, or during the conduct of any official activity related to the Lee County School Board no
44 later than five (5) days after conviction.

45
46 (2) **Notice of Conviction:** The [Lee County School Board District](#) shall take one [or more](#) of the following
47 actions, within thirty (30) days of receiving such notice, with respect to any employee who is so

convicted:

(a) **Program Participation:** ~~R~~require such an employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a federal, state or local health, law enforcement, or other appropriate agency, ~~or,~~

(b) **Failure to Participate:** ~~I~~f the employee fails to satisfactorily participate satisfactorily in such a drug abuse assistance or rehabilitation program, the District will recommend non-reappointment, suspension, or termination the employee.~~employee may be non-renewed or his or her employment may be suspended or terminated, at the discretion of the School Board, or~~

(c) **District Other Personnel Action:** ~~T~~ake other appropriate personnel action ~~against such an employee,~~ up to and including termination.

(3) **Alcohol, Tobacco, or Drug Testing:** All alcohol, tobacco, or drug testing shall be conducted in accordance with District policy and procedures.

(a) **Mandatory:** Safety sensitive positions, including those defined by the U.S. Department of Transportation standards, may be required to submit to alcohol, tobacco, or drug testing on a random basis.

(b) **Reasonable Suspicion Testing:** No employee shall be required to submit to drug or alcohol testing without reasonable suspicion except as otherwise required by law or this agreement. All drug and alcohol testing shall be conducted in accordance with District policy and procedures for drug and alcohol testing.

(4) Exemptions

(a) **Prescription Drugs:** Possession or use of prescription drugs by an employee for which ~~he~~ they hold~~s~~ the prescription is exempt from this section.

(b) **Confiscation:** Employees who perform duties which require the disposition or confiscation of alcoholic beverages or controlled substances are exempt from this section ~~when-if~~ performing those specified duties.

(5) **Employee Assistance Program:** Employee assistance will be available through Human Resources and the Employee Assistance Program (EAP).

(6) **Last Change Agreement:** A first-time Alcohol, Tobacco, and Drug-Free Workplace violation will result in an offer of a Last Chance Agreement (LCA) to the employee, a letter of reprimand (LOR), and/or mandatory referral to EAP, except in cases where aggravating factors exist. Aggravating factors may include any conduct that would be independent grounds for disciplinary action.

6.05 - UNIFORMS:

(1) **Required Uniforms:** ~~When-If~~ required, uniforms, footwear or a footwear stipend will be provided for employees. Every employee afforded uniforms, including footwear, shall wear ~~his/her~~ their uniform on every assigned shift or work assignment. School/site spirit or team building theme day uniform substitutions are allowed with the approval of the school/site main administrator.

(a) **Identification Badges:** ~~When-If~~ required, identification badges will be furnished to employees.

(2) **Measurement and Delivery:**

1 (a) **Purchased:** Purchased uniforms for twelve (12) month employees shall be measured by
2 October for targeted delivery in January. Purchased uniforms for ten (10) month employees
3 shall be ordered not later than the second week of the new school year and targeted for
4 delivery within ninety (90) days after the order is placed.

5 (b) **Leased:** Uniforms that are leased shall be provided on an ongoing basis.

6 (c) **Safety Shoes:** Safety shoes will be made available via an on-site mobile shoe fitting
7 company.
8

9 (3) Uniform Purchase Eligibility

10 (a) **New Hires:** New employees shall be eligible to order uniforms no later than thirty (30) days
11 after the first day worked. New employees hired in July, August, September will be fitted
12 according to contract language but will not become eligible again for the annual
13 uniforms/shoes allotments until the following school year uniform/shoes distribution periods.

14 (b) **Current Employees:** After the first issue of uniforms, employees who are provided
15 purchased uniforms shall have the opportunity to select approved accessories provided that
16 the basic uniform is in good condition and that the total price of accessories does not exceed
17 the cost of the uniforms.
18

19 (4) Uniform Allowance: Uniform allowance/allocations for Purchased Uniform employees will be 20 calculated as follows:

21 (a) **Twelve Month Employees:** Twelve-month employees eligible for purchased uniforms will be
22 provided five (5) uniforms in the first year of employment and up to five (5) uniforms
23 each year thereafter. Twelve-month employees eligible for safety shoes will be allocated
24 \$100.00 each school year for the purchase of approved safety shoes.

25 (b) **Less Than Twelve Month Employees:** Less than twelve-month employees eligible for
26 purchased uniforms will be provided five (5) uniforms in the first year of employment and up
27 to four (4) uniforms each year thereafter.

28 (c) **Food Services:** Less than twelve-month Food Service employees eligible for purchased
29 uniforms will be provided five (5) uniforms in the first year of employment and four (4)
30 uniforms each year thereafter. Less than twelve-month Food Service employees will be
31 provided a \$61.00 stipend each school year to be used towards the purchase of required
32 District approved non-slip/slip resistant shoes. The stipend will be paid in the employee's first
33 paycheck of the school year or the first paycheck following eligibility.
34

35 (5) Uniform Orders:

36 (a) **Ordering Uniform Tops:** Eligible "Purchased Uniform" employees will be allowed to order the
37 maximum allowed number of uniform tops allowed according to the employee job
38 status/number of days worked regardless of any style/size cost differences. Should the
39 employee elect not to order the maximum number of allowed tops then they will be credited
40 with an amount equal to the number of tops not ordered multiplied by the lowest priced
41 commonly ordered uniform top of that major department current bid (major department
42 bids for uniforms purposes are the following three: Transportation, Food Service and all other
43 support staff).

44 (b) **Ordering Uniform Bottoms:** Eligible "Purchased Uniform" employees will be able to order
45 the maximum number of uniform bottoms allowed according to the employee job
46 status/number of days worked regardless of any style/size cost differences. Should the
47 employee elect not to order the maximum number of allowed bottoms then they will be

1 credited with an amount equal to the number of bottoms not ordered multiplied by the
2 lowest priced commonly ordered uniform bottom of that major department current bid
3 (major department bids for uniforms purposes are the following three: Transportation, Food
4 Service and all other support staff).

5 **(c) Ordering Accessories:** All orders for accessories must be approved by the employee's
6 immediate supervisor.

7 **(d) Unspent Allowance:** Any unspent uniform top/bottom allocation dollars can be utilized
8 toward the purchase of additional approved accessories, additional uniform tops or additional
9 uniform bottoms.

10 **(e) Orders Exceeding Allowance:** Additional uniforms, shoes or accessories items ordered that
11 exceed the available allowance amount for the eligible employee must be paid for in advance
12 of order placement.

13
14 **(6) Uniform Compliance:** A uniform for count compliance purposes is defined as one garment top
15 plus one garment bottom. An eligible employee may be reimbursed a dollar amount equal to the
16 actual cost of specified shoes, up to a maximum of one-hundred dollars (\$100) if one of the following
17 criteria is met:

18 **(a)** Vendor cannot provide required size;

19 **(b)** Medically documented reason for specified shoes.

ARTICLE 7 – WORK SCHEDULE

7.01 - WORK DAY

(1) Standard Hours: It is the mutual interest of the parties to standardize the hours of employees, where practicable. An appendix will be included that details the following: standard scheduled hours, standard worked hours, paid or unpaid lunch period, and total paid hours for all support staff positions.

(a) Federal Grant Programs: Employees assigned to positions as part of a federal grant may have a work day based on program requirements.

(b) Split Shifts: If academic programming requires the use of split shifts at a worksite, the parties agreed to bargain the impact of a split shift; except for Transportation employees and academic programs or worksites using split shifts prior to July 1, 2012.

(c) Four-Day Work Week: Standard work days may be adjusted during the summer for the purpose of allowing a four (4) day work week.

(d) Lunch Periods: Lunch periods shall be duty-free except as otherwise determined by the supervisor. Lunch periods for employees who work less than seven (7) hours shall be as indicated on the chart below and scheduled as near to the middle of the work shift as possible.

(e) Rest Periods: Rest periods shall be for a maximum of fifteen (15) minutes. Rest periods cannot be combined or taken back to back. Employees shall be entitled to rest periods as indicated on the table in Article 7.01(1)(f)). Breaks for a 10 hour work day apply to locations with a 4-day work week during the summer.

(1) Food and Nutrition Services: Food and Nutrition Services employees who work six (6) or more hours shall receive two (2) rest periods.

(2) Transportation: Bus Operators, Bus Attendants, and Bus Monitors are entitled to rest periods as bus schedules permit.

5 (g) **Mandatory Meetings:** School-based support staff shall meet with school-based
6 administration at least once per quarter during their work day for a minimum of fifteen (15)
7 minutes. Support staff meetings shall be for the purpose of improving communication and to
8 provide job specific training. The SPALC Labor/Management Committee shall review situations
9 where support staff meetings are a concern.
10

11 (2) Non-Standard Hours

12 (a) **Summer Hours:** During the summer, employees may work a 4-day work week in
13 departments and sites where manageable. In such departments and locations, work days
14 will be Monday through Thursday, with the total hours worked to be equivalent to an
15 employee's 5-day work week. Start and end dates of the 4-day work week period will be agreed
16 upon by the SPALC Labor/Management Committee.

17 (b) **Holidays and Non-Scheduled Workdays:** Employees required to work on holidays and non-
18 work days shall be compensated for a minimum of three (3) hours for any such day worked.
19

20 (3) Changes in Allocations

21 (a) **Notice:** ~~When-If~~ allocations at any work site require that any employee have a change in
22 hours, the employee shall be notified of the change five (5) days prior to the effective date of
23 the change, except for the first fifteen (15) days of the school year.

24 (b) **Seniority:** Employees shall be reduced in hours due to changes in work site allocations in
25 order of their District seniority, from least seniority to greatest seniority provided the senior
26 employee has the ability to perform the available work in a satisfactory manner.

27 Employees shall be increased in hours due to changes in work site allocations in descending
28 District seniority provided the senior employee has the ability to perform the available
29 work in a satisfactory manner.

30 (c) **Benefits Eligibility:** The School District recognizes that many employees who work less than
31 six hours per day desire the opportunity to work enough hours to be eligible for health
32 insurance coverage. Where practical, the School District will strive to assist employees in
33 achieving that goal.

34 (d) **Food Service Employees:** Part-time staff may be hired for Food Service positions for peak
35 work load times with agreement of SPALC.
36

37 (4) **Recording Hours:** Each work site will establish an accurate method to document employee work
38 time and attendance. The supervisor of the work site will notify employees of the method and
39 procedure for documenting work time and attendance. The District will inform the Association
40 regarding a specific work site's method and procedure for documenting work time and attendance
41 upon request.
42

43 **7.02 - WORK WEEK:** The workweek shall consist of not more than forty (40) hours. The workweek
44 shall be from Saturday 12:01 a.m. to Friday 12:00 midnight.
45

46 7.03 - WORK YEAR

47

1 **(1) Staggered Work Year:** The Board reserves the right to stagger the work year of 216-day and
2 226-day employees. By March 15, the principal at each school site shall post a schedule of work years
3 for the period of April 16 through April 15 of the next year. Employees may then bid a work year based
4 on seniority between March 15 and April 15. Thereafter, work years shall be assigned to employees
5 on a first-come, first-served basis. If an employee fails to request a work year, one shall be assigned
6 by the principal by April 15. When-if an employee's staggered work year extends beyond the ending
7 date specified on the current Board-approved Instructional Personnel Calendar, the employee shall be
8 required to complete the full 216-day and 226-day schedule of employment prior to September 1.

9
10 **(2) 255-Day Calendar:** The work schedule for twelve (12) month employees shall be 255 day

11 12 **7.04 - CHANGES IN SCHEDULE**

13
14 **(1) Permanent:** When-if it is necessary to change the shift schedule of employees in a job classification
15 at a work site, employees will be given thirty (30) days' notice.

16
17 **(2) Temporary:** Temporary changes in an employee's shift schedule may occur with agreement of the
18 employee and the site supervisor.

19 **(a) Overtime, Extra Hours and Call Backs:** Overtime and extra hours work will be distributed
20 equitably among employees by job classification and organizational unit based on seniority,
21 availability, and qualifications to perform the required task. Senior employees who may not be
22 qualified shall be offered training within ninety (90) days if training is available and practical.
23 The distribution of overtime and extra hours shall not delay or increase the cost of the
24 Board's operation. Temporary imbalances in the distribution of overtime and extra hours
25 will be subsequently corrected as more hours become available. When-if a supervisor does
26 not follow seniority in the assignment of overtime and extra hours, notification shall be
27 provided to the SPALC representative. Should no qualified employee agree to overtime or
28 extra hours work, the employer shall assign overtime or extra hours work in the inverse order
29 of seniority.

30 **(1) Overtime:** All authorized work performed in excess of forty (40) hours in any one
31 week shall be considered overtime and shall be paid at the overtime rate of one and
32 one-half (1-1/2) times the employee's regular rate of pay. Sick leave for one day and
33 paid holidays during the work week shall be counted as time worked for the purpose
34 of computing overtime.

35 **(2) Extra Hours:** All authorized work performed in excess of the employee's regular
36 work day or work year shall be paid at the regular rate of pay, unless in conflict with
37 the applicable supplemental contract. Employees shall receive payment for extra
38 hours worked according to Article 10.05(1)(e).

39 **(3) Call Backs:** Employees who are called back to the job after the end of their
40 workdays shall be compensated at time and one-half for a minimum of two (2)
41 hours. The work site supervisor shall keep a list of employees willing to work
42 overtime and contact these individuals first prior to contacting other employees.
43 This section does not apply to an extended workday.

44
45 **(3) Emergency Schedule Change:** In the event of an emergency or other unusual circumstance as
46 determined by the principal or other immediate supervisor, an employee's work schedule may be
47 temporarily changed. In situations affecting more than one worksite or department or more than

approximately fifty (50) employees, management will notify the Association of the change in schedule. However, undue hardship on an employee will be dealt with on a case by case basis. The Board agrees to meet with the Association to discuss make-up days ~~when-if~~ schools are closed due to an emergency.

(4) Make-Up Due to Suspended Operations or Declared Emergency: If possible, employees will be notified prior to the beginning of the work day ~~when-if~~ it is necessary to close schools as a result of a hurricane or other declared emergency. Failure to make up missed time during the scheduled work year or use appropriate leave on make-up days will result in a loss of corresponding wages, with pay to be deducted from the employee's paycheck for time missed. If an employee terminates employment prior to the end of the work year, pay will be deducted from ~~his or her~~their final paycheck. The SPALC Labor/Management Committee will prepare a schedule for make-up of missed days to be provided to employees as soon as possible following a return to work. The Board reserves the right to waive make-up time.

(a) 186-Day, 187-Day, 190-Day, 196-Day, 201-Day, and 206-Day Calendar: For employees who work 187, 190, 196, 201 or 206 days the time may be made up on the days that students are scheduled to make up school.

(b) 216-Day and 226-Day Calendar: For employees who work 216 and 226 days, the time may be made up by extending the contract year by the number of days missed.

(c) 255-Day Calendar: For employees who work twelve (12) months per year, time may be made up by extending the length of the work day as determined by the Superintendent.

7.05– HOLIDAYS: All full-time employees in the unit shall receive the following paid holidays each year: Independence Day, Labor Day, Thanksgiving (Thursday & Friday), Good Friday and Memorial Day. Employees who work twelve (12) months per year shall receive six (6) consecutive work days' winter vacation. Two of these days shall be Christmas Day and New Year's Day. Employees shall only be paid for holidays that occur during their work year. Employees who work less than twelve (12) months shall receive the following paid holidays: Labor Day, Thanksgiving (Thursday & Friday), Presidents' Day, Good Friday and Memorial Day

7.06 – VACATION: This section shall apply to all full-time twelve-month employees in the bargaining unit.

(1) Accrual: A member of the unit who is employed on a twelve (12) month basis shall be allowed paid vacation leave, exclusive of holidays, as follows:

(a) Less than Five Years: An employee with less than five (5) years of continuous service shall accrue one (1) day per month (12 days per year)

(b) Five to Nine Years: An employee with five (5) years or more of continuous service shall accrue one and one-quarter (1-1/4) days per month (15 days per year)

(c) Ten or More Years: An employee with ten (10) years or more of continuous service shall accrue one and one-half (1-1/2) days per month (18 days per year).

(2) Requests: Vacation will not be granted until it is earned. Each employee who has accrued at least ten (10) days of vacation shall be allowed to take at least two (2) consecutive weeks of vacation during the calendar year. Each supervisor shall develop and post a vacation schedule by March 31. Between January 1 and March 10, employees shall submit requests for vacation time to the supervisor. Requests for vacation will be granted based on seniority. The supervisor may deny specific vacation

1 requests that disrupt the operation of the school or department. Vacation requests received after
2 March 10 will be considered on a first-come, first-served basis and should be responded to within
3 10 business days. Supervisors shall respond in PeopleSoft with a specific reason for denial if a
4 vacation request is not granted. Previous approval of vacation requests may be revoked should an
5 emergency arise at the worksite. An appeal of a revocation of a previously approved vacation
6 request may be made to the Superintendent or Superintendent's Designee. All requests shall be
7 entered into PeopleSoft by the supervisor or ~~his or her~~their designee. If the supervisor chooses, ~~he or~~
8 ~~she~~they may request that the employee enter the request into PeopleSoft.

9
10 **(3) Increments:** Vacation may be granted in increments of thirty (30) minute increments, provided
11 that the request does not disrupt the operation of the work site. All vacation requests must be
12 submitted to the supervisor at least 24 hours in advance of the requested vacation time.

13
14 **(4) Separation:** An employee may accrue a maximum of forty-five (45) work days (360 hours) of annual
15 leave. Annual leave shall not be granted prior to the time it is earned and shall be used only with the
16 approval of the Superintendent upon the recommendation of the employee's supervisor. Upon
17 separation from the Board, an employee shall be paid for accrued annual leave as of the date of
18 separation based on the employee's daily rate of pay at the time of separation. In the case of the death
19 of an employee, payment for accrued annual leave shall be made to the employee's beneficiary of
20 record, or if none, to ~~his~~their estate.

ARTICLE 8 – PERFORMANCE EVALUATION

1 **8.01 – NOTICE:** Each employee will receive a performance assessment, in electronic form, of
2 ~~his/her~~their work at least once during each contract year. The parties agree that the Association will
3 have input into the development of the assessment forms.

5 **8.02 – PROCEDURE:**

7 **(1) Supervisor Meeting:** Each employee's performance assessment shall be discussed with
8 ~~him/her~~them by ~~the~~their supervisor. All discussion of a performance assessment by a supervisor

11 **(2) Employee Acknowledgement:** After discussion of the performance assessment, the employee shall
12 acknowledge the performance assessment, indicating that ~~he/she~~they ~~has~~have been shown the
13 report and that it has been discussed with ~~him/her~~them by the assessor.
14

15 **(3) Supporting Documentation:** ~~When~~If an evaluation includes an "Inconsistent" or
16 "Unsatisfactory" rating or a derogatory comment regarding performance, the supervisor must provide
17 proof that the employee has been counseled prior to the evaluation in the area receiving the
18 "Inconsistent" or "Unsatisfactory" rating or has been counseled in the same performance area of the
19 derogatory comment.
20

21 **(4) Employee Comment:** If the employee disagrees with ~~his~~their performance assessment, ~~he/she~~they
22 may submit a statement in electronic form which shall, upon request of the employee, be attached
23 to the Board's copy.
24

25 **(5) Final Rating:** Each employee shall be given a copy of ~~his/her~~their performance assessment within
26 ten (10) calendar days after completion, ~~;~~ but not later than April 1. Additional performance
27 assessments completed after April 1 will be given to each employee within ten (10) calendar days after
28 completion.
29

30 **(6) Supervisor Acknowledgment:** No employee in the unit shall complete or acknowledge the
31 performance assessment of other employees. Only a supervisor shall complete a performance
32 assessment for an employ~~ee~~.

ARTICLE 9 – DISCIPLINARY PROCEDURE

1 9.01 – PROCEDURE: All employee investigations shall be conducted in a fair and
2 objective manner. Materials and information regarding the investigation shall be
3 relevant to the investigation and reasonable in scope. Such material and information
4 shall remain confidential until the conclusion of the investigation and appropriate
5 notice is provided to the employee that is the subject of the investigation.

6
7 (1) Site-Based Investigation: Allegations of employee misconduct or unsatisfactory
8 job performance shall be reviewed by the site-based or school-based administrator.
9 During the investigation, the District may temporarily reassign the employee. The
10 employee shall be provided an opportunity to be heard regarding all allegations at a
11 meeting with the site-based or school-based administrator.

12
13 (2) District-Based Investigation: Professional Standards may initiate an investigation
14 at the request of the site-based or school-based administrator or Superintendent in
15 response to allegations of employee misconduct or unsatisfactory job performance
16 that may result in suspension without pay or termination of employment. During the
17 investigation the District may temporarily reassign the employee.

18
19 (3) Administrative Reassignment or Suspension: In accordance with Florida Statute
20 1012.796, if an allegation of misconduct involves the health, safety, or welfare of a
21 student, the District must immediately suspend the employee, with pay, from
22 regularly assigned duties and reassign the employee to a position that does not
23 require direct contact with students. An employee may be suspended with pay or
24 reassigned pending the outcome of an investigation for allegations not involving the
25 health, safety, or welfare of a student. Suspension with pay or reassignment pending
26 the outcome of an investigation shall continue until an outcome has been rendered
27 by the District and shall not be subject to the grievance procedure.

28
29 (4) Right to Representation: If an employee has a reasonable belief that discipline or
30 adverse consequences may result from a meeting with management, the employee
31 has the right to request representation of their choice from the following: the
32 employee's attorney, a union representative, or a co-worker that is a member of the
33 bargaining unit. Notice of representation by an attorney or union representative
34 must be provided in writing. Management is not required to inform an employee of
35 their Weingarten rights. It is the employee's responsibility to know their rights and to
36 request representation, if they desire representation.

37
38 (5) Pre-Determination Hearing: Employees will be given at least five (5) days written
39 notice, whenever possible, of a pre-determination hearing. Employees shall have the
40 right to representation and the employee may present relevant information in their
41 defense. Allegations will be reviewed at the pre-determination hearing and the

1 employee will be provided an opportunity to respond. After all information has been
2 considered, a disciplinary outcome will be rendered. The Association shall have the
3 right to attend all District-based pre-determination hearings.

4
5 (6) Progressive Discipline: Disciplinary action shall be progressive in nature, when
6 appropriate, and may include, but is not limited to: no cause, conference summary,
7 written reprimand, last chance agreement, suspension, termination, reassignment,
8 retraining, or other assistance.

9
10 (7) Probationary Period: A new period of probation shall not be used as a form of
11 disciplinary action for an employee who has previously completed their probationary
12 period.

13
14 (8) Use of Technology: Email, audio and video recordings, cell phones, and other
15 forms of technology are common in the workplace and may be used in the course of
16 an investigation. The initial review of security camera footage or other technology for
17 the purpose of monitoring employee performance shall be conducted by the site-
18 based or school-based administrator and shall remain confidential during the
19 pendency of an investigation. All records will be provided to the Association as soon
20 as technologically feasible and in accordance with Florida Statute. If security camera
21 footage is evidence in an investigation of employee misconduct, the Association will
22 have the opportunity to inspect it prior to and/or during a pre-determination hearing.
23 Disciplinary action will be based upon a totality of circumstances rather than solely
24 upon use of technology.

25
26 9.02 - OUTCOME: Any disciplinary action taken while performing duties under a
27 teaching contract or supplemental contract shall be only for just cause, as defined
28 in Florida Statute 1012.33 and 1012.335, and Florida Administrative Code 6A-5.056.
29 Employees with Annual Contract status who are recommended for non-
30 reappointment are not entitled to an appeal or the grievance procedure, but may be
31 eligible for a review of their non-reappoint in accordance with Article 5.01.

32
33 (1) No Finding: If an investigation results in no finding of just cause, written
34 documentation of no finding will be placed in the investigative file and a copy will be
35 provided to the employee. No finding of just cause is a non-disciplinary outcome and
36 shall not be placed in the employee's personnel file.

37
38 (2) Letter of Guidance: If an investigation results in no finding of just cause, a Letter
39 of Guidance may be issued and will be placed in the investigative file and a copy will
40 be provided to the employee. A Letter of Guidance is a non-disciplinary outcome that
41 may be issued to address allegations of potential misconduct that are
42 unsubstantiated but could negatively impact an employee's professional standing. A
43 Letter of Guidance offers advice to the employee on conduct to moderate or monitor
44 in order to ensure the employee meets the high ethical standards of public
45 employment. A Letter of Guidance shall not be placed in the employee's personnel
46 file.

1
2 (3) Administrative Notes: Administrative Notes are any documentation of a meeting
3 that may result in disciplinary action, including but not limited to an administrator's
4 notes regarding a verbal warning.

5
6 (4) Conference Summary: A Conference Summary is site-based or school-based
7 disciplinary documentation. Any Conference Summary shall be provided to the
8 employee and shall be signed by the employee for the sole purpose of indicating that
9 the employee has received a copy and has had an opportunity to discuss it with their
10 immediate supervisor. If the employee refuses to sign, the Conference Summary will
11 be provided to the employee, indicating that the employee refused to sign.
12 Employees have the opportunity to submit a written response, which will be attached
13 to the Conference Summary.

14
15 (5) Written Reprimand: A Written Reprimand is disciplinary documentation that is
16 placed in an employee's personnel file. Any Written Reprimand shall be provided to
17 the employee and shall be signed by the employee for the sole purpose of indicating
18 that the employee has received a copy and has had an opportunity to discuss it with
19 their immediate supervisor. If the employee refuses to sign, the Written Reprimand
20 will be provided to the employee and a copy will be placed in the employee's
21 personnel file indicating that the employee refused to sign. Employees have the
22 opportunity to submit a written response, which will be placed in the employee's
23 personnel file.

24
25 (6) Last Chance Agreement: Last Chance Agreements shall be specific in nature and
26 when appropriate a duration will be specified.

27
28 (7) Suspension: The process for suspension without pay shall be governed by School
29 Board Policy. Suspensions shall be subject to grievance procedure.

30
31 (8) Termination: The process for termination shall be governed by School Board
32 Policy. Employees will receive written notice of a recommendation for termination,
33 which will include the reason for the recommendation. Employees shall be entitled
34 to a hearing before the Board.

35
36 ~~9.01 – PROCEDURE: All employee investigations shall be conducted in a fair and objective manner.~~
37 ~~Materials and information regarding the investigation shall be relevant to the investigation and~~
38 ~~reasonable in scope. Such materials and information shall remain confidential until the~~
39 ~~conclusion of the investigation and appropriate notice is provided to the employee that is the~~
40 ~~subject of the investigation.~~

41
42 ~~(1) Site-Based Investigation: Allegations of employee misconduct or unsatisfactory job performance~~
43 ~~shall be reviewed by the site-based administrator. During the investigation, the District may~~
44 ~~temporarily reassign the employee. The employee shall be provided an opportunity to be heard~~
45 ~~regarding all allegations at a meeting with the site-based administrator. The employee shall have the~~
46 ~~right to representation at the meeting and shall present relevant information in his/her defense.~~

1
2 ~~(2) District-Based Investigation:~~ The District's Department of Professional Standards and Equity may
3 begin an investigation at the request of the site-based administrator or Superintendent regarding
4 allegations of employee misconduct or unsatisfactory job performance that could result in
5 suspension without pay or termination of employment. During the investigation the District may
6 temporarily reassign the employee.

7
8 ~~(3) Right to Representation:~~ If an employee has a reasonable belief that discipline or adverse
9 consequences may result from a meeting with management, the employee has the right to request
10 representation of his or her choice from the list below. Management is not required to inform the
11 employee of his/her Weingarten rights; it is the employee's responsibility to know his/her rights and
12 make the request. Such meetings shall take place in private. Management shall recognize the
13 following individuals as acceptable representatives of the employee: the employee's attorney; a union
14 representative; or a co-worker that is a member of the bargaining unit.

15
16 ~~(4) Pre-Determination Hearing:~~ The final step of a District-based investigation, is a pre-determination
17 conference. Employees will be given at least two days prior written notice, whenever possible, of the
18 pre-determination conference and shall have the right to have a representative accompany them and
19 present relevant information. Allegations will be reviewed at the pre-determination conference and
20 the employee will be afforded the opportunity to respond. After all information has been
21 considered, the Director of Professional Standards and Equity shall make a recommendation of any
22 disciplinary action to the Superintendent. Recommended actions shall be when appropriate,
23 progressive in nature and may include, but are not limited to, verbal warning, letters of warning
24 and reprimand, suspension without pay, retraining or other assistance and termination from
25 employment. A new period of probation shall not be used as a form of action or discipline for an
26 employee that has previously completed his or her probation. Employees subject to disciplinary
27 action as specified in this article shall be entitled to appeal through the grievance process as
28 set forth in Article 4 of the collective bargaining agreement.

29
30 ~~(5) Use of Technology:~~ Modern technology (i.e. e-mail, audio and video recordings via cell phones,
31 etc.) has become common in the work place and may be used in the course of an investigation. The
32 use of these technologies will not replace the traditional use of documentation when discussing
33 and/or investigating matters involving the actions of employees. The initial review of security videos
34 or other technology, for the purpose of monitoring employee performance, shall be conducted by
35 an administrator or specifically trained confidential employee. Technology records will be provided
36 to SPALC, upon request, as soon as technologically feasible and pursuant to state law. During an
37 open investigation, if a video is evidence in the case, SPALC will be provided a copy, if requested.

38
39 ~~9.02 – OUTCOME:~~ The parties agree that termination is the extreme disciplinary penalty, since the
40 employee's job seniority, other contractual benefits, and reputation are at stake. In recognition of this
41 principle, it is agreed that disciplinary action(s) taken against SPALC bargaining unit members shall be
42 consistent with the concept and practice of the collective bargaining agreement and that in all
43 instances the degree of discipline shall be reasonably related to the seriousness of the offense and the
44 employee's record. Any discipline during the contract year, that constitutes a verbal warning,
45 letter of warning, letter of reprimand, suspension, demotion or termination shall be for just cause.
46 When discipline is rendered it shall be done in a manner that respects the privacy and confidentiality
47 of the employee.

1
2 ~~(1) Written Reprimand:~~ Any written reprimand shall be furnished to the employee and the employee
3 shall sign the reprimand for the sole purpose of indicating that he/she has received the statement
4 and has discussed it with the supervisor. If the employee refuses to sign, the reprimand will be
5 provided to the employee and a copy placed in the employee's personnel file. The employee will have
6 an opportunity to submit a written response which will be placed in the employee's personnel file.

7
8 ~~(2) Last Chance Agreements:~~ Last chance agreements shall be specific in nature and when
9 appropriate a duration will be specified.

10
11 ~~(3) Suspension:~~ Suspensions shall be subject to the grievance procedure. In the event that the grievant
12 prevails, the record of the suspension shall be placed in a separate stand-alone personnel file. All
13 notices of suspension shall be in writing and delivered to the employee with a copy to the Association
14 within five (5) days of the decision to suspend.

15
16 ~~(4) Termination:~~ The employee and the Association shall receive written notice of a
17 recommendation for termination. Such notice shall include the reasons for the recommendation to
18 dismiss. The employee shall either be entitled to a hearing before the Board or may file a grievance
19 but may not do both.

ARTICLE 10 – COMPENSATION

10.01 – EXPERIENCE CREDIT: Previous work experience shall be verified as equivalent to the employee's position pursuant to Board policy. Experience credit will be granted upon verification and will be retroactive to the initial hire date or the beginning of the fiscal year it was submitted if submitted during a fiscal year after the fiscal year of the initial hire date. Current employees with less than the maximum step allowed for an entry level position due to a change in the standard in allowable experience credit shall receive the experience credit allowed under the standard upon verification. The SPALC Labor/Management Committee will provide input into the standards on an annual basis. The SPALC Labor/Management Committee may call for subsequent review of an area if a problem occurs.

(1) New Hire

(a) Market Rate: Experience credit does not apply to positions on the Market Rate Salary Schedule.

(b) Grade Step: The first step of each pay grade shall be considered the hiring rate for employees. However, such employees shall be given one additional step for each year of experience, upon verification, up to a maximum of three years.

(2) Change in Position: ~~When~~If an employee changes to a different job classification, the employee is eligible to receive an additional verified work experience credit up to the maximum level credit (Pay Step 4) allowed for initial employment.

(a) Grade/Step to Market Rate: Employees on the Grade/Step Salary Schedule who are hired into positions on the Market Rate Salary Schedule will be paid at the Market Rate, as established by the Market Rate Salary Schedule.

(b) Market Rate to Grade/Step: Employees on the Market Rate Salary Schedule who are hired into positions on the Grade/Step Salary Schedule will be paid based upon verified work experience or their last step on record with the District, whichever is greater.

(c) Market Rate to Market Rate: Employees on the Market Rate Salary Schedule who are hired into a different position on the Market Rate Salary Schedule will be paid at the Market Rate, as established by the Market Rate Salary Schedule.

(d) Grade/Step to Grade/Step: Employees on the Grade/Step Salary Schedule that are hired into a different position on the Grade/Step Salary Schedule will be paid at their last step on record with the District.

(3) Return to Rate of Pay: If an employee terminates ~~his or her~~their employment and is rehired by the District within one year from the date of termination, ~~he or she~~they may be eligible for a return to rate of pay. A break in service will impact longevity pay (see Article 10.03(1)).

(a) Market Rate Salary Schedule:

(1) Same Position: If an employee terminates ~~his or her~~their employment and is rehired by the District into the same position within one year from the date of termination and the position is on the Market Rate Salary Schedule, the employee will be paid ~~his or her~~their base rate (hourly rate) at the time of termination or the Market Rate, whichever is greater.

(2) Different Position: If an employee terminates ~~his or her~~their employment and is rehired by the District into a different position within one calendar year from the date of termination and the position is on the Market Rate Salary Schedule, the employee

will be paid the Market Rate.

(b) Grade/Step Salary Schedule: If an employee terminates ~~his or her~~their employment and is rehired by the District into a position on the Grade/Step Salary Schedule, the employee will be paid based upon verified work experience or ~~his or her~~their last step on record with the District, whichever is greater.

10.02 – SALARY SCHEDULES: All positions that are part of the bargaining unit will be included in a SPALC Salary Schedule appendix, with a distinction to be made between positions on the Grade/Step Salary Schedule and the Market Rate Salary Schedule.

(1) Differential Pay

(a) SAC Chairman Supplement: An employee who is elected as Chairman of the School Advisory Committee (SAC) at ~~his or her~~their school shall be paid an additional amount of \$525.00.

(b) Hygiene-Medical Supplement: An annual salary supplement of \$500.00 will be provided to the Exceptional Student Education Educational Paraprofessionals or Helping Teachers who provide diapering/toileting/medically required procedures on a daily and routine basis. Clinic assistants and clerical employees who provide “back up” on rare occasions are not eligible for this supplement. Completion of an Annual Salary Supplement document will be required each year for employees eligible for the supplement. Annual Salary Supplement cancellations will be required ~~when if~~if the student is no longer assigned to the recipient of the supplement or if an employee transfers to a position not requiring the medically required procedures. Annual notification will accompany the District’s Master Supplement List each year.

(c) Movement to Market Rate: As part of the movement to Market Rate, the Group Leader Supplement, the Licensed Practical Nurse (LPN) Supplement, and the Head Custodian Supplements will be eliminated. Pay for these supplements is now included in the employee’s regular pay and will not be paid separately.

(2) Controlling Document: Employees shall be paid in accordance with the salary schedule. In the event of a discrepancy between the salary schedule and this Agreement, the articles of this Agreement shall prevail.

(3) Reclassifications:

(a) Grade/Step: Employees in job classifications that move down in Pay Grade will retain their Pay Grade at the time of the change.

(b) Market Rate: Employees in job classifications that move down in Market Rate will retain their rate of pay (hourly rate) at the time of the change.

(c) Effective Date: Positions reviewed and recommended for reclassification shall receive compensation effective from the date of Board Approval of the reclassification. Such pay shall not be retroactive.

(4) Promotions: No employee shall be deprived of ~~his~~their seniority as a condition for promotion or as the result of a demotion.

10.03 – INCENTIVE AND BONUS PROGRAMS: The District, with input from the SPALC Labor/Management Committee, will develop and implement a system for awarding all incentive and bonus programs that is in compliance with applicable laws. Availability of funding may impact the

continuation of incentive and bonus programs.

(1) **District Incentive and Bonus Programs:**

(a) ActiveLee Employee Wellness: ActiveLee seeks to provide a healthy work environment and enhance the quality of life for all District employees. ActiveLee provides engaging health programs, support resources, exercise classes, and wellness coaching to empower District employees to make healthier lifestyle choices. Incentives for District employees will be determined annually by the District.

(b) Longevity Recognition: After completing fifteen (15) continuous years of employment, excluding outside credit, an employee shall receive an additional supplement of \$150.00 within thirty days from the fifteenth anniversary date and on the first pay period for the employee each fiscal year thereafter. After completing twenty (20) continuous years of employment, excluding outside experience credit, an employee shall receive an additional supplement of \$700.00 within thirty days from the twentieth anniversary date and on the first pay period for the employee each fiscal year thereafter. After completing twenty-five (25) continuous years of employment, excluding outside experience credit, an employee shall receive an additional supplement of \$950.00 within thirty days from the twenty-fifth anniversary date and on the first pay period for the employee each fiscal year thereafter.

(c2) Safe Driving Award

(1a) Eligibility: An employee shall be eligible for a safe driving award provided that the employee:

(a1) Driving Time: works in a position in which one-half (1/2) the employee's time is devoted to the operation of a motor vehicle;

(b2) Employment Status: is employed and in good standing for a period of at least one (1) work day more than half the school year (Board Policy 5.14).

(c3) Preventable Accidents: has not had a preventable accident as determined by the Safe Driver Plan or received a citation from a law enforcement officer for the moving traffic violation.

(2b) Amount: The annual amount of the safe driver award will increase with each consecutive year the driver maintains a safe record as follows:

2 The safe driving years must be consecutive for the driver to be eligible to move to the
3 next level. The cash award will be mailed to the employee not later than August 30
4 following the fiscal year in which the award is earned.
5

6 **(d3) Professional Development:**

7 **(1a) Tuition-Waiver/Reimbursement:** Tuition shall be waived for employees who enroll
8 in a supplemental vocational program. A supplemental vocational program is one that
9 provides occupational training to maintain or upgrade employee's skills and/or
10 enables the employee to reenter an occupation, including house maker. Tuition shall
11 also be waived for employees who enroll in Adult and Community Education courses.
12 The District shall reimburse tuition for courses previously offered by the District
13 through the Technical Colleges. Reimbursement is subject to successful completion of
14 the course by the employee. The course must also be District work related. The
15 employee must consult with ~~his/her~~their supervisor prior to taking a course for which
16 they will seek reimbursement.

17 **(2b) Trade Certification:** Trades employees who have a current license as a journeyman
18 or who can provide written evidence of completion of comprehensive trade-related
19 certification or degree program in the related area of their employment will receive a
20 \$300.00 supplement annually. This supplement will be paid to the employee on the
21 next scheduled pay date following written notification from the department director
22 to the SPALC Labor/Management Committee. Interested employees are required to
23 seek prior approval of their eligibility for participation by submitting an application to
24 the Principal or Director. Applications will be available upon request. Employees are
25 not eligible to receive the Trade Certification Supplement and Training Incentive for
26 the same activity.

27 **(3e) Training-Incentive:** As an incentive for employees to improve their proficiency on
28 the job, or upgrade and enhance their skills and therefore, their employment
29 opportunities with the District, a \$125.00 stipend will be offered for personnel who
30 have earned twenty-four (24) hours over a two (2) year period through participation
31 in a job related community college course, Staff Professional Development course or
32 Adult and Community Education course. The course must be taken on the employee's
33 personal (non-work) time. Three stipends per employee may be awarded per school
34 year. Stipend(s) will be paid at the successful completion of each twenty-four (24)
35 hours of training and submission of the "SPALC, Confidential, and
36 Supervisory/Technical Training Incentive Application". Interested employees are
37 required to seek verification of eligibility for training incentives by submitting an
38 application to the Principal or Director indicating the course requested and
39 justification of relevance to the employee's position prior to enrolling in the course.
40 Applications will be available at each work site and through the Curriculum and
41 Staff Professional Development Department. Employees are not eligible to receive the
42 compensation for Trade Certification Supplement and the Training Incentive for the
43 same activity.
44

45 **(2) State Incentive and Bonus Programs**

46 **(a) Qualifying Adoptive Employee: Funds associated with this program are to be distributed in**
47 **accordance with Florida Statute 409.1664.**

(1) Child With Special Needs: A qualifying adoptive employee who adopts a child within the Florida child welfare system who has special needs is eligible to receive a lump-sum monetary benefit in the amount of \$10,000.00 per child, subject to applicable taxes.

(2) Child Without Special Needs: A qualifying adoptive employee who adopts a child within the Florida child welfare system who does not have special needs is eligible to receive a lump-sum monetary benefit in the amount of \$5,000.00 per child, subject to applicable taxes.

(3) Disclaimer: Nothing herein shall be construed to expand the Qualifying Adoptive Employee Program beyond the limits of applicable state and federal law.

10.04 – NON-STANDARD RATE OF PAY

(1) Suspended Operations or Declared Emergency: During periods designated by the Superintendent as a Declared Emergency or Suspended Operations, employees shall be compensated as follows:

(a) Suspended Operations: If District operations are suspended, employees in regular full-time or part-time positions will be paid for a regular day. Failure to make up missed time, for which the employee was previously paid, during the scheduled work year or use appropriate leave on make-up days will result in a loss of corresponding wages, with pay to be deducted from the employee's paycheck for time missed. If an employee terminates employment prior to the end of the work year, pay will be deducted from their final paycheck.

(b) Declared Emergency: Employees required to work during a Declared Emergency will receive a one-time bonus by the end of the regularly scheduled work year equal to their base rate of pay (hourly rate) times the number of hours worked during the Declared Emergency. Declared Emergency status will be in effect until the Superintendent returns operations to normal status. Overtime will be paid in accordance with the Fair Labor Standards Act (FLSA).

(2) Asbestos Control Team: Employees who are members of the Asbestos Control Team shall be paid an additional \$5.21 per hour for time spent working in the asbestos abatement area dressed in complete protective gear.

(3) Temporary Reassignment: For Temporary Reassignment, in accordance with Article 5.05(2), employees will be paid according to the appropriate Temporary Reassignment Matrix (see appendix).

10.05 – PAY DELIVERY

(1) Pay Delivery System: The District utilizes a payment in arrears system for employee payroll.

(a) Standard Pay Period: Employees will receive paychecks semi-monthly in an amount equal to their annual rate divided by twenty-four (24) pay periods. Employees may receive a pro-rated non-standard pay period amount, not to exceed the amount paid for a standard pay period.

(1) Bus Operators, Bus Attendants, and Bus Monitors: Bus Operators, Bus Attendants, and Bus Monitors shall be paid for actual hours worked each pay period for twenty (20) pay periods. The pay delivery schedule shall be determined by agreement of the parties in the Transportation Labor/Management Committee. Each paycheck will represent actual hours worked documented prior to the cut-off of the previous pay period.

1 (b) **Summer School:** Employees working summer school shall be paid according to the salary
2 schedule in effect at the beginning of the summer school program and shall be paid consistent
3 with the payment in arrears system for employee payroll.

4 (c) **Payroll Dates:** Paychecks will be issued on the fifteenth and last day of the month. If that
5 day falls on a weekend or holiday, then paychecks will be issued on the business day prior to
6 the weekend or holiday.

7
8 (2) **Payment Method:** All employees shall be paid by direct deposit or District provided pay card.

9
10 (3) **Paycheck Adjustments:** Employees and their immediate supervisor will be notified of a need for
11 paycheck adjustments. Arrangements for handling paycheck adjustments will be made directly with
12 the employee. Every effort will be made to resolve paycheck adjustments within the calendar year to
13 ensure accurate reporting of wages for tax purposes.

14 (a) **Leave Reporting:** Leave shall be reported in the same pay period in which an absence
15 occurs. Late submission of leave may result in an adjustment of pay.

16
17 (4) **Confidentiality:** Information related to pay is sensitive in nature and shall be treated in accordance
18 with Florida Statute, Chapter 119.

19
20 (5) **Overtime:** Overtime shall be reported in the same pay period in which it occurs. Overtime shall be
21 paid no later than the pay period after the hours were worked, provided there are at least eight (8)
22 days between the hours worked and the next pay period. Employees working in two or more positions
23 with different hourly rates will be paid overtime as required by the Fair Labor Standards Act (FLSA)
24 and Board Policy 5.17.

25
26 **10.06 – CHANGES IN COMPENSATION:** Effective February 1, 2021 or later, sSupport staff employed by
27 the District at the time of ratification and payment on July 1, 2019 will be eligible for increases as
28 follows:

29
30 (1) **Two Percent Increase:** All support staff on the Grade/Step Salary Schedule and the Market Rate
31 Salary Schedule will receive a 2.0% increase in base rate of pay (hourly rate).

32
33 (2) **One-time Bonus:** All support staff on the Grade/Step Salary Schedule and the Market Rate Salary
34 Schedule with a District start date in a SPALC bargaining unit position on or before September 1, 2020
35 will receive a one-time bonus of \$294.50, if they remain continuously employed in a SPALC bargaining
36 unit position.

37
38 (3) **Market Rate Salary Schedule:** The District is in the fourth year of a five-year transition to a Market
39 Rate Salary Schedule. The SPALC Labor/Management Committee will make recommendations each
40 year for positions to be moved to the Market Rate Salary Schedule and will consider need and
41 availability of funding. Funding is not available to support moving positions to the Market Rate for
42 FY21 (2020-2021 school year).

ARTICLE 11 –BENEFITS

11.01– **BOARD PROVIDED BENEFITS:** The Board will provide major medical insurance through the District's medical plan and group term life insurance for all eligible employees. Effective April 1, 2015, the Board will provide major medical insurance through a program offered by Aetna Inc. (Aetna).

(1) **Eligibility:** Employees who are regularly scheduled to work thirty (30) or more hours per work week are eligible for Board provided major medical insurance and group term life insurance as described in this article; except that, employees who were employed with the Board as of March 12, 1996, and who were, at that date, and continue to be, regularly scheduled to work twenty (20) or more hours per work week, shall continue to be eligible for Board provided major medical insurance and group term life insurance as described in this article.

11.02 – **FLEX CREDITS:** Effective ~~April 1, 2019~~ April 1, 2021, the Board shall contribute ~~\$7,360.80~~ \$8,104.80 into the Flex Credits for each employee who is enrolled in Board-Provided Benefits.

(1) **Application:** Flex Credits are to be applied by employees toward the purchase of their own major medical insurance, dependent medical insurance, dental insurance, vision insurance, critical illness insurance, accident insurance, and/or cancer insurance.

(2) **HSA Plan:** For employees who elect an HSA plan, any Flex Credits in excess of the employee only medical plan premium will be deposited into the employee's HSA account with the District's HSA vendor and will not be applied to dependent medical insurance, dental insurance, vision insurance, critical illness insurance, accident insurance, and/or cancer insurance.

(3) **Total Contribution:** The total Board contribution for the benefits listed above shall not exceed the Flex Credits amount. Regardless of the benefits elected, the employee shall not receive cash from the Flex Credits.

11.03 – **FLEXIBLE BENEFITS PLAN:** The School District of Lee County shall offer its employees an IRS Section 125 qualified Flexible Benefits Plan (Flex Plan). Voluntary benefits included in the Flex Plan may be purchased pre-tax through payroll deduction or with Flex Credits.

(1) **Enrollment:** Enrollment in the Flex Plan is automatic. New employees eligible for benefits have the option to waive participation in the Flex Plan within the first thirty (30) days of employment. Regular employees eligible for benefits are allowed to change their Flex Plan status during the annual enrollment period or within sixty (60) days following a qualified family status change. Enrollment in any individual benefit included in the Flex Plan remains binding until the employee changes ~~his/her~~their benefit election. Such changes may only be made during the Open Enrollment period for the benefit or within thirty (30) days (to add a benefit) or within sixty (60) days (to drop a benefit) following a qualified family status change, and must be made on the appropriate enrollment change form. Changes made during the Open Enrollment period will become effective the first day of the new benefit plan year. The District will make every effort to ensure employees receive electronic confirmation of their open enrollment selection prior to the first payroll deduction of the plan year.

(2) **Flexible Spending Accounts:** All eligible employees may participate in optional medical and/or dependent care Flexible Spending Accounts, which allow those employees to pay for qualified medical

1 and dependent care expenses with pre-tax payroll deductions. Flex Credits may not be directed to
2 Flexible Spending Accounts.

3
4 **11.04 – MAJOR MEDICAL INSURANCE:** The Board will provide major medical insurance through the
5 District's medical plan to each eligible employee. Effective April 1, 2019, the Board will provide major
6 medical insurance through four (4) Aetna self-insured medical plans: Plan 3769, Plan 5773, Plan 7419,
7 and High Deductible Health Plan (HDHP). Such coverage shall become effective the first of the month
8 following a forty-five (45) day waiting period from the date of employment. The date of employment
9 shall be included as one of the forty-five (45) days.

10
11 **11.05 – OPTION TO DECLINE BENEFITS:** Employees who can verify evidence of medical insurance
12 coverage shall be allowed to decline coverage under the School District's medical plan. Employees
13 shall receive \$25.00 per paycheck (24 pay periods) or \$30.00 per paycheck (20 pay periods) of Flex
14 Credits to spend on voluntary benefits (dental, vision, and/or cancer).

15
16 **11.06 – LIFE INSURANCE:** The Board will provide twenty thousand dollars (\$20,000.00) of group term
17 life insurance for each eligible employee, with an additional twenty thousand dollars (\$20,000.00)
18 accidental death and dismemberment (AD&D) insurance. Coverage shall begin on the first of the
19 month following a forty-five (45) day waiting period from date of employment. The date of
20 employment shall be included as one of the forty-five (45) days.

21
22 **11.07 - VOLUNTARY BENEFITS:** The Board will make optional voluntary group benefits available to
23 all eligible employees. Employees who participate in voluntary benefits must do so at their own
24 expense or with available Flex Credits. Voluntary benefits shall be recommended by the Insurance Task
25 Force and approved by the Board.

26
27 **(1) Eligibility:** Employees who are regularly scheduled to work twenty (20) or more hours per work
28 week are eligible for the optional group voluntary benefits offered by the Board.

29
30 **11.08 – LIABILITY INSURANCE:** The Board will provide liability coverage for employees in an amount
31 not less than one million dollars (\$1,000,000.00) per occurrence.

32
33 **11.09 – SELF-INSURANCE FUND RESERVE:** Self-Insurance Fund reserves shall not be transferred
34 out of the fund without the recommendation of the Insurance Task Force.

35
36 **11.10 – RETIREMENT:** The District participates in the Florida Retirement System (FRS) and contributes
37 on behalf of all eligible employees.

38
39 **11.11 – SOCIAL SECURITY:** The District makes Social Security contributions on behalf of all eligible
40 employees.

ARTICLE 12 – LEAVE

12.01 – USE OF LEAVE: Leave should be requested only ~~when-if~~ necessary.

(1) **Absence Without Leave:** Any absence from duty without leave may subject the employee to termination or other appropriate discipline.

(2) **Absence Without Pay:** The pay deduction for each day of absence shall be determined by dividing the base salary plus any wage supplement by the total number of hours in the employee's work year to determine the hourly rate, then multiplying that rate by the number of hours absent.

For purposes of this paragraph, supplements are those which relate to employee's principal position and exclude those supplements for extracurricular activities.

(3) **Notice of Absence:** Any employee who will be absent from work for any cause except for leave duly authorized and granted in advance shall notify the principal or immediate supervisor of the leave needed as soon as possible prior to ~~his/her~~their absence.

(4) **Leave Request:** All applications for leave, except sick, emergency, vacation (see Articles 7.05 and 7.06) and personal leave shall be submitted to the principal or supervisor in writing at least five (5) days in advance. Leave granted for a school year or for the remaining part thereof will expire at the end of the employee's contract year. An employee having been granted leave for the school year or remaining part thereof, who desires to return to work the next school year shall notify the Superintendent in writing by April 1.

(5) **Return from Extended Leave:** A regular employee who is replacing an employee on leave will be placed in a similar or comparable position within the District upon the return of the employee on leave. Replacement positions will be filled only upon approval by the Superintendent.

(6) **Leave Approval:** All requests for leave shall be submitted on the proper form and shall be subject to approval by the Superintendent.

(7) **Leave Disposition:** All employees shall, if possible, be notified in writing of the disposition of their request prior to the requested leave date. The notification of the leave request shall be submitted by the employee in a timely manner. The employee shall be notified as to the disposition of the leave by the supervisor in a timely manner. If the disposition is not provided to the employee by the date of the leave, the employee shall follow-up with the supervisor prior to taking the leave.

(8) Suspected Abuse of Leave

(a) **Excessive Absence:** Excessive Absence may result in District personnel action including, but not limited to, the use of the discipline or evaluation process consistent with the District's obligation under state and federal law. Excessive absence shall be defined as follows:

(1) **Without Medical Documentation:** Three (3) consecutive days of absence without medical verification in a case where abuse is suspected.

(2) **Within a Twelve-Month Period:** Three (3) unauthorized absences in a twelve (12) month period.

(3) **Continued Pattern:** A continued pattern of absence that affects an employee's

ability to carry out the essential functions of ~~his/her~~their position.

(b) Unauthorized Absence: Unauthorized absence shall be defined as follows:

(1) Failure to Provide Notice: Failure of an employee to give notice of absence may be regarded as an unauthorized absence. Upon reporting back to work, the employee shall be apprised of the unauthorized leave status. However, if the employee can demonstrate that there were extenuating circumstances (e.g., hospitalization, serious emergency), then consideration must be given to changing the status of the leave.

(2) In Excess of Accrued Leave: Absence in excess of accrued sick and personal leave, when such absence is not specifically authorized in advance, is an unauthorized absence.

(3) During Emergency: Personal leave and vacation leave without advanced authorization unless in the case of emergency as defined by Article 12.04(2)(a) is an unauthorized absence.

(9) Abandonment of Position: An unauthorized absence of three consecutive workdays without notice shall be evidence of abandonment of position and subject to termination procedure.

(10) Medical Certification: An employee who has taken sick leave for five (5) days or more, or injury or illness in line of duty leave, or maternity leave, may be required to provide certification from a licensed medical provider stating that the employee is able to perform all of ~~his/her~~their duties or that the employee was entitled to leave.

12.02 – SICK LEAVE: All full-time employees shall be credited with four (4) days of sick leave on the last day of the first month of employment of each contract year and thereafter shall accrue one (1) day of sick credit for each month of employment. The employee must work one day more than half the scheduled work days in the month to earn one day of sick leave for the month. Sick leave shall be credited to the employee at the end of the month and may not be used prior to the time it is earned. No employee may earn more than one (1) day of sick leave times the number of months of employment during the school year. Sick leave shall be accumulated hourly from year to year without limit to the number of hours that may be accrued. Any leave charged against sick leave shall be paid leave. If termination occurs after the employee has used more sick days than ~~he-they~~ earned that contract year, and if ~~he/she has~~they have no sick leave accumulated from prior years, the Board will withhold an amount of the employee's daily rate of pay for each sick day used that has not been earned. Terminal pay benefits for accrued sick leave are defined hereinafter.

(1) Claims: An employee is eligible for sick leave for ~~his-their~~ own illness as well as illness or death of father, mother, brother, sister, husband, wife, child, member of ~~his-their~~ household or other close relative if approved by the Superintendent.

(2) Accrued Sick Leave: The Board shall provide all employees with a cumulative record of accrued sick leave hours on each pay statement.

(3) Summer School: Employees who are hired to work during the summer school session shall earn one day (actual number of hours worked per day in summer session) of sick leave for each three (3) week term. No more than two (2) days sick leave with pay may be used during summer school.

(4) Sick Leave Request: Each employee shall notify ~~his-their~~ supervisor as soon as possible ~~or when if~~

1 it is necessary to use sick leave. A claim for sick leave shall be signed by the employee and filed with
2 the principal or immediate supervisor by the end of the fifth working day following the employee's
3 return to work.

4
5 **(5) Conditions for Sick Leave:**

6 **(a) Increments:** Sick leave may be used in increments of one (1) hour and one quarter (1/4)
7 hours thereafter. In cases of emergency or scheduled health care provider appointments
8 within two (2) hours of the end of the work day, the employee shall be charged only actual
9 time for said emergency leave if he has first reported to work.

10 **(b) No Available Sick Leave:** Any employee who has used all paid sick leave but who is
11 otherwise entitled to sick leave shall be granted leave without pay. The claim for such leave
12 shall clearly state that the leave is without pay.

13 **(c) Abuse of Sick Leave:** In the case of suspected sick leave abuse, the Superintendent may
14 require a medical provider's statement verifying illness.

15 **(d) Validity:** An unfounded claim for sick leave shall be cause for employee discipline up to and
16 including discharge.

17 **(e) Request for Extended Sick Leave:** An application for sick leave due to an extended illness
18 (twenty (20) work days) shall be accompanied by a statement from a medical provider
19 certifying that such leave is essential and indicating the probable duration of the illness.

20
21 **(6) Transfer of Sick Leave:** Any employee shall be entitled to transfer sick leave credit from other
22 Florida school districts. In order to use transferred sick leave credits, an employee must match each
23 day transferred with a sick leave day earned in Lee County.

24
25 **(7) Reinstating Accrued Sick Leave:** ~~When-If~~ an employee interrupts service through termination and
26 subsequently returns to employment in the District without having used ~~his/her~~ their District accrued
27 sick leave credit in another Florida school district, such accrued sick leave credit shall become valid on
28 the first day of reemployment.

29
30 **(8) Terminal Sick Leave Pay:** ~~When-If~~ an employee receives terminal pay benefits based on unused sick
31 leave, all unused sick leave credit shall be canceled.

32
33 **(9) Sick Leave Buy-Out Study:** The parties agree to study the feasibility, scope and impact of a sick leave
34 buy-out incentive plan over the period of this contract. Should the parties agree to an acceptable sick
35 leave buy-out plan option prior to the end of the contract, a memorandum of understanding shall be
36 written to document the agreement with implementation to take place prior to the end of the contract
37 term.

38
39 **12.03 – ILLNESS OR INJURY-IN-THE-LINE-OF-DUTY LEAVE:** Any full-time employee shall, except as
40 otherwise provided in this Agreement, be entitled to illness or injury-in-line-of-duty leave with pay,
41 less any Workers' Compensation payments, for a period not to exceed ten (10) work days in any fiscal
42 year regardless of the number of illnesses or injuries, nor to exceed ten (10) days per any single illness
43 or injury ~~when-if~~ that illness or injury continues or recurs from one fiscal year to succeeding fiscal
44 years, ~~when-if he/she has~~ they have to be absent from work because of a personal injury received in
45 the discharge of ~~his/her~~ their duties. Illness-in-line-of-duty leave is intended to deal with the illnesses
46 normally known as childhood diseases, such as, but not limited to, mumps, measles and chicken pox.
47 This leave does not include normal adult illnesses such as colds and influenza. This leave is non-

1 cumulative. In addition to the conditions listed below, for both illness and injury-in-line-of-duty, the
2 Board reserves the right to request a second medical opinion from a physician designated by the
3 Board. Any additional expense incurred as a result of this requirement will be paid by the Board.
4

5 **(1) Injury-In-Line-Of-Duty Eligibility:** In order to be considered for injury-in-line-of-duty leave, the
6 following conditions must be met:

7 **(a) Written Testimony:** The employee must provide written testimony, in addition to
8 [his/her/their](#) oral testimony, that [his/her/their](#) injury was received in the line of duty.

9 **(b) Written Claim:** The employee must file a written claim, as outlined below, in addition to the
10 injury report claim.

11 **(c) Medical Provider:** The employee must utilize the medical provider selected by the
12 employer. The employee may make a written request to change the medical provider after
13 initial consultation.
14

15 **(2) Illness-In-Line-Of-Duty Eligibility:** In order to be considered for illness-in-line-of-duty leave, the
16 following conditions must be met:

17 **(a) Medical Documentation:** The employee must furnish a letter from a medical doctor, who
18 treated the patient, stating that in [his/her/their](#) opinion, there is a strong probability that the
19 illness was contracted on the job.

20 **(b) Written Claim:** The employee must file a written claim as outlined below.
21

22 **(3) Workers Compensation Claim**

23 **(a) Leave Request:** Any employee who has a claim for compensation while absent because of
24 injury or illness incurred as prescribed herein, shall file a claim on the standard leave form
25 provided by the Board with [his/her/their](#) principal or other immediate supervisor by the end
26 of the fifth working day following the employee's return to duty after the leave for illness or
27 injury-in-line-of-duty.

28 **(b) Sick Leave Accrual:** Effective January 1, 2010, employees who are absent from work
29 exclusively for Workers' Compensation (ILD, Workers' Compensation) shall, upon their return
30 to full duty for no less than 30 days, be credited with sick leave accrual for the period of their
31 Workers' Compensation absence.
32

33 **12.04 – PERSONAL LEAVE:** All employees shall make a written application for personal leave. The
34 employee shall not be entitled to pay while on personal leave except as provided herein. Personal
35 leave is to allow employees to attend to personal business or matters which cannot be attended to
36 outside of the employee's regular work day. Employees who abuse personal leave may be subject to
37 disciplinary action.
38

39 **(1) Invalid Use:** Personal leave, whether without pay or charged to sick leave, shall not be used by
40 school-based personnel or transportation department employees at the following times, except with
41 the specific written permission of the Superintendent:

42 **(a) Prior to Holiday or Vacation:** The day immediately prior to or following a holiday or
43 employee vacation.

44 **(b) First or Last Week of School:** The five (5) work days immediately preceding and following
45 the student's school year.

46 **(c) Summer School:** On any day while summer school is in session.

47 **(d) Standardized Testing:** During District designated, standardized testing periods impacting

major student populations. This applies to Transportation and school-based employees only.
(e) **Charter Schools:** Employees will not be afforded leave to work at Charter Schools.

(2) Personal Leave Charged to Sick Leave

(a) **Five Day Limit:** Each employee may take up to five (5) days of personal leave with pay during each fiscal year which is charged to accumulated sick leave. All requests for personal leave charged to sick leave shall be made at least three (3) work days in advance except in cases of emergency. In cases of emergency, the employee shall be charged only actual time for said emergency leave if he has first reported to work. If the reason for absence is an emergency and prior written request is not possible, the employee shall notify ~~his~~their principal or supervisor as soon as possible prior to the absence.

(b) **Conditions:** The use of personal leave charged to sick leave shall be subject to the following conditions:

(1) **Non-Cumulative:** It is not cumulative.

(2) **Disruption:** It need not be approved if the Superintendent determines that it will create a disruption of the instructional or work setting.

(3) **Increments:** Personal leave charged to sick leave may be granted in increments of 30 minutes, provided that the request does not disrupt the operation of the worksite.

(c) Procedure

(1) **Reason for Request:** Employees are not required to provide the supervisor the reason for the request.

(2) **Disruption:** If personal leave charged to sick leave is disapproved, the employee may:

(a) **Disapproval:** Accept disapproval of the leave request.

(b) **Verbal Statement:** Provide ~~his~~their supervisor with a reason for the request so that the supervisor may try to accommodate the employee ~~when-if~~ the request, based on the reasons given, discloses a situation that cannot be controlled by the employee or postponed to another time. The reason will not be reflected on the leave request form and will be held in confidence.

(3) **Priority:** The principal or supervisor will give consideration to requests in the order in which they are received as determined by the filing date.

(3) **Personal Leave Without Pay:** Personal leave without pay is available only ~~when-if~~ an employee has no appropriate paid leave available. It need not be approved if the Superintendent determines that it will create a disruption of the instructional or work setting.

(a) **Extended Personal Leave:** Personal leave without pay up to thirty (30) days may be granted at the discretion of the Superintendent. Personal leave in excess of thirty (30) days shall be subject to Board approval.

(b) **Adoption of a Child:** An employee who adopts a child may request personal leave without pay at any time during the first year after obtaining actual custody of a child, or as otherwise needed to fulfill the requirements for adoption. Adoption leave is subject to the maternity leave article. Only one adoption leave per household will be granted at one time.

(c) **Paternity Leave:** All employees are eligible for paternity leave subject to the applicable conditions outlined in the section on maternity leave. Only one leave per household for either maternity or paternity leave will be approved at one time. Paternity leave will only be granted for the period following the birth or adoption of the child.

(d) **Return from Board Approved Extended Personal Leave:** Employees on Board approved

1 leave without pay must provide written notice to the District of their intention to return from
2 leave, extend leave or resign within 20 work days prior to the leave return date.

3
4 **12.05 – MATERNITY LEAVE:** All full-time employees shall be eligible for maternity leave.

5 The employee shall submit a written request for maternity leave to the Superintendent. The leave
6 request shall include the date the leave is to commence as determined by the employee in
7 consultation with her licensed provider. Except in the case of an emergency, a request for maternity
8 leave shall be made at least thirty (30) calendar days prior to the date on which the leave is to begin.
9 Maternity leave shall be without pay, except that the employee must file a claim to use accrued sick
10 leave during that period of leave for which a medical disability exists. Approval of a claim for maternity
11 leave shall be contingent upon certification of pregnancy by a licensed medical provider. In the event
12 that the leave request does not specify a return date, the employee shall notify the Superintendent at
13 least twenty (20) working days prior to her intended return date. Such notice shall be given no later
14 than April 1 in order for the employee to be considered for return to duty that school year. The
15 employee may return to duty on the date requested upon receipt by the Superintendent of
16 certification from a licensed provider stating that she is physically capable of performing her job. In
17 the event that leave is approved by the Board effective on or after the first day of the fourth quarter
18 of a school year, a request for the next fiscal year shall not extend beyond the end of the first
19 semester.

20
21 **12.06 – MILITARY LEAVE:** Military leave shall be granted in accordance with applicable state and federal
22 law. Such leave shall be without loss of seniority and shall be credited to the employee for experience
23 credit on the salary schedule. Nothing herein shall be construed to expand any military leave privileges
24 other than those provided by applicable state and federal law.

25
26 **12.07 – JURY DUTY LEAVE:** Any employee, including those employed for summer school, who is
27 subpoenaed for jury duty shall be granted temporary duty leave with pay. The employee shall not be
28 reimbursed for meals, lodging and travel while on leave. Per diem paid by the court for such purposes
29 may be retained by the employee.

30
31 **12.08 – WITNESS LEAVE:** ~~When~~ If an employee is subpoenaed, ~~he~~ they shall be granted temporary duty
32 leave. Temporary duty with pay shall not be granted for court attendance when an employee is a party
33 to the litigation. The employee may retain any fees. In the event no fees are awarded by the court,
34 and the employee is testifying for the Board, ~~he~~ they will be eligible to be paid per diem and travel
35 expenses as provided in Board policy. A request for reimbursement must be filed by the employee.

36
37 **12.09 – TEMPORARY DUTY LEAVE:** An employee may be assigned temporary duty away from ~~his~~ their
38 regular job. Temporary duty may include participation in surveys, meetings, study courses, workshops
39 and similar services. Such assignment may be initiated by the Superintendent or the employee with
40 consideration given to the disruption of the work place that the temporary duty may cause.
41 Temporary duty is not to be charged as personal or sick leave. The employee and the Superintendent
42 must mutually agree on temporary duty.

43
44 **12.10 – FAMILY AND MEDICAL LEAVE:** All articles shall be effective for School Board employees July 1,
45 1994, and shall be interpreted so as to comply with the requirements, including definitions, of the
46 Family and Medical Leave Act (FMLA) of 1993, and any applicable implementing regulations. No
47 articles shall operate to limit or reduce leaves provided under other contract terms.

1
2 **(1) Eligibility:** Any employee who has worked for the Lee County School District for at least twelve (12)
3 months and for at least seven hundred twenty-four (724) hours during the year preceding the start of
4 the leave is eligible.

5
6 **(2) Reasons for Leave:** Eligible employees shall be granted FMLA leave:

7 **(a) Care of Child:** To care for the employee's child after birth, or following placement for
8 adoption or foster care.

9 **(b) Care of Family Member:** To care for the employee's spouse, son or daughter or parent, who
10 has a serious health condition.

11 **(c) Care of Self:** Because of a serious health condition that makes the employee unable to
12 perform the functions of the employee's job.

13 **(d) Care of Service Member:** To care for a covered service member with a serious illness or
14 injury incurred in the line of duty while on active duty. Such eligible employees shall be
15 permitted to take up to twenty-six (26) work weeks of leave in a 12-month period.

16 **(1) Military Exigency:** To use for any qualifying exigency arising out of the fact that a
17 covered military member (member of National Guard and Reserves) is on active duty
18 or called to active duty status in support of a contingency operation. A qualifying
19 exigency is defined as follows: Short-notice deployment; Military events and related
20 activities; Childcare and school activities; Financial and legal arrangements;
21 Counseling; Rest and recuperation; Post-deployment activities; Additional activities
22 not encompassed in the other categories, but agreed to by the Board or employee.
23

24 **(3) Leave Entitlement:** An eligible employee is entitled to take up to a total of twelve (12) work weeks
25 of FMLA leave in a 12-month period, to be measured backward from the commencement date the
26 employee uses FMLA leave. An eligible employee taking leave under Article 12.10(2)(d) shall be
27 permitted to take up to 26 work weeks of leave in a 12-month period.
28

29 **(4) Intermittent Leave for Planned Medical Treatment:** FMLA leave may be taken intermittently
30 whenever it is medically necessary to take care of a seriously ill spouse, child or parent of the
31 employee, or because of the employee's own serious health condition making the employee unable
32 to work. Intermittent leave may be taken in increments of one or more days or partial days.
33 Certification of the need for intermittent leave and the leave schedule shall be provided by the health
34 care provider. Employees needing intermittent FMLA leave must attempt to schedule their leave so as
35 to minimize disruption to the District's operations. The District may assign an employee to an
36 alternative position on a temporary basis with equivalent pay and benefits that better accommodates
37 the employee's intermittent leave schedule. Intermittent FMLA leave must be requested by the
38 employee in writing at least thirty (30) days in advance, or as soon as is practicable.
39

40 **(5) Maintenance of Group Medical Insurance:** The Board shall maintain an employee's medical
41 insurance coverage during FMLA leave to the same extent coverage was provided to the employee
42 prior to taking FMLA leave, for a period not to exceed twelve (12) weeks during the applicable twelve
43 (12) month period and for 26 weeks during the applicable twelve (12) month period if eligible for leave
44 under Article 12.10(2)(d)(1). Medical insurance premiums which has been paid by the employee prior
45 to FMLA leave for any dependent coverage must continue to be paid by the employee during the FMLA
46 leave period. If such payments are not made by the employee, the dependent's insurance coverage
47 will lapse and no benefits will be paid for claims incurred while the policy has lapsed. When-If the

employee is reinstated, and payroll deduction of dependent's premiums resumes, the dependent's insurance will be reinstated with the same coverage as prior to the lapse.

(6) Notice: Employees must request FMLA leave in writing, directed to Human Resources, at least thirty (30) calendar days in advance, or as early as is practicable. The time for the start of the leave may be delayed for up to thirty (30) days for failure to provide timely notice. An employee needing FMLA leave must follow the work site's usual and customary call-in procedures for reporting an absence, absent unusual circumstances.

(7) Job Restoration: Upon return from FMLA leave, an employee shall be restored to the same or an equivalent position. An equivalent position must be at the same pay, benefits, and working conditions, include the same privileges, prerequisites and status, and involve the same or substantially similar duties and responsibilities. The equivalent position must be located at the same or geographically proximate work site unless the employee's request for transfer has been accepted.

(8) Failure to Return: At the start of any FMLA leave, the employee must state whether ~~he~~/she/they intends to return at the end of the leave. If the employee does not intend to return, the employee will be deemed to have resigned voluntarily, and no FMLA benefits will be provided. If the employee states that ~~he~~/she/they intends to return, and then fails to return, for reasons other than (1) the continuation of a serious health condition of the employee or a covered family member or (2) circumstances beyond the employee's control (certification required within thirty (30) days of failure to return for either reason), the employee must promptly reimburse the Board for the cost of insurance provided by the Board during the leave. If the employee fails to do so, the Board may take action to recover the premiums paid.

(9) Use of Paid Leave: Employees are required to use paid accrued sick leave before any FMLA leave is taken as a result of a serious health condition. Employees are required to use any paid accrued vacation before any FMLA leave is taken. Any such paid accrued leave taken will be counted toward the allowable twelve (12) weeks of FMLA leave.

(10) Medical Certification: Employees requesting FMLA leave due to a serious health condition of the employee, or of the employee's spouse, child or parent, are required to submit a certification from a health care provider, verifying that the leave is medically necessary. If the Board deems a medical certification incomplete or insufficient, the Board must specify in writing what information is lacking, and give the employee fourteen (14) calendar days to cure the deficiency. The Board may require an employee to obtain a second medical certification, at the Board's expense. The second health care provider may not be employed on a regular basis by the District. If the opinions of the first and second health care provider differ, the Board may require a third medical certification, again at the Board's expense, from a health care provider selected by the employee from a mutually-agreed upon list maintained by the Director of Insurance and Benefits Management. The third opinion shall be final and binding. In all cases the Board may request a recertification of an on-going condition every six months in conjunction with an absence.

(11) Fitness-for-Duty Certification: As a condition of restoration of an employee who has taken FMLA leave due to the employee's serious health condition, the employee is required to provide certification from the employee's health care provider that the employee is able to resume work, i.e., is fit for duty and has the ability to perform the essential functions of the employee's job. If an employee is taking

intermittent leave and reasonable job safety concerns exist, the Board may require a fitness for duty certification before the employee may return to work.

12.11 – INSURANCE COVERAGE: The insurance coverage of any employee who is granted a leave terminates on the first scheduled pay day that the employee does not receive a paycheck, except as otherwise provided by law or this agreement. To continue insurance coverage during the leave period, the employee is responsible for and must remit all premiums due thereafter ~~when~~if permitted. Employees whose ten (10) day Sick Leave Bank (SLB) waiting period aligns with a pay period, which results in the employee receiving no pay check for the pay period, shall have their Flex Credit contribution for that pay period covered by the Board.

12.12 – TERMINAL PAY BENEFITS

(1) Eligibility: A regular full-time employee, upon application, after ten (10) years of creditable service in a retirement plan established by the Florida Legislature, shall be entitled to terminal pay at the time of:

(a) Retirement: Normal retirement or early retirement.

(b) Disability: Disability retirement.

(c) Termination: Termination.

(d) Death: If termination is by death, the ten (10) years of creditable service in a retirement plan established by the Florida Legislature is not required and payment will be made to the employee's beneficiary.

(2) Payment: Terminal pay shall be paid after ten (10) years of creditable service in a retirement plan established by the Florida Legislature and shall be based on the total number of accrued and valid sick leave days credited to the employee at the daily rate of pay of the employee at the time of termination. The amount of terminal pay shall be computed as follows:

(a) One to Three District Years: during the years of service one through three (1-3) in the District, thirty-five (35) percent of the hours of accumulated sick leave shall be multiplied times the hourly rate of pay

(b) Four to Six District Years: during the years of service four through six (4-6) in the District, forty (40) percent of the hours of accumulated sick leave shall be multiplied times the hourly rate of pay

(c) Seven to Nine District Years: during the years of service seven through nine (7-9) in the District, forty-five (45) percent of the hours of accumulated sick leave shall be multiplied times the hourly rate of pay

(d) Ten to Twelve District Years: during the years of service ten through twelve (10-12) in the District, fifty (50) percent of the hours of accumulated sick leave shall be multiplied times the hourly rate of pay

(e) Thirteen or More District Years: during and after the thirteenth (13th) year of service in the District, one hundred (100) percent of the hours of accumulated sick leave shall be multiplied times the hourly rate of pay

(3) Qualification: Any employee entitled to terminal pay must be under contract for the period immediately preceding termination of employment and shall not be under suspension from duty except for reasons pertaining to health, or have any charges pending which could result in dismissal from employment. All employees must obtain written verification of terminal leave benefits prior to

1 making a claim for same.

2
3 **12.13 – SICK LEAVE BANK:** The District has several Sick Leave Banks (SLB). ~~When-If~~ a Sick Leave Bank
4 member changes positions which would require a change to a new Sick Leave Bank, that person shall
5 be treated as a new member and must give up one sick leave day for membership in the new bank.
6 However, if the member has donated a day within the same fiscal year, that day may be transferred
7 to the new bank. The purpose of the Sick Leave Bank (SLB) is to provide a pool of emergency sick leave
8 days in cases of catastrophic illness. For the purposes of the Sick Leave Bank, catastrophic illness or
9 injury is defined as those illnesses or injuries that require immediate medical attention and cannot be
10 postponed (cannot be scheduled during a work break or during non-work hours). The Sick Leave Bank
11 is not intended to provide benefits to an employee for such things as cosmetic surgery, elective
12 surgery, or other similar claims. Sick Leave Bank time will only be donated for mental illness ~~when-if~~
13 an inpatient hospital stay is required. Contributors may draw days from the Sick Leave Bank after their
14 own accumulated sick leave has been exhausted. Nothing in this section shall be interpreted to
15 change any of the other articles herein pertaining to accrued leave.

16
17 **(1) Membership:** Any full-time employee may enroll in the Sick Leave Bank between August 15 and
18 September 30 provided the following three requirements are met:

19 **(a) Employment:** Continuous employment for at least one (1) year. Only full-time employees
20 are to enroll in and receive benefits from the Sick Leave Bank. Any full-time employee who
21 ceases to work twenty (20) or more hours per week shall become ineligible for membership
22 and benefits until the employee again becomes full-time.

23 **(b) Accrual:** Accrual of six (6) leave days by September 1.

24 **(c) Donation:** Donation of a seventh (7th) or subsequent sick leave day by October 15.

25 **(2) Application:** Enrollment forms shall be provided to employees at each work site. Sick leave days
26 contributed to the Sick Leave Bank will not be returned except as hereafter provided.

27
28 **(3) Contribution:** In the event the number of days in the Sick Leave Bank balance falls below thirty
29 percent (30%) of the number of Sick Leave Bank members, each member of the Sick Leave Bank must
30 contribute one (1) day from ~~his-their~~ accumulated sick leave to the Sick Leave Bank. In the event a Sick
31 Leave Bank member cannot contribute an additional day due to leave exhaustion, he is not then using
32 the Sick Leave Bank, the additional day shall automatically be ~~his-their~~ next accrued sick leave day.

33
34 **(4) Duration:** If membership in the Sick Leave Bank and/or the number of days in the Sick Leave Bank
35 fall below three hundred (300), the Sick Leave Bank shall be discontinued, and all remaining time in
36 the Sick Leave Bank shall be distributed as provided herein.

37
38 **(5) Administration:** The SLB will be administered by Human Resources. An Overview Committee
39 consisting of two (2) employees appointed by the Superintendent and two (2) employees appointed
40 by the Association shall review the administration of the SLB, investigate alleged abuses, and
41 determine eligibility as herein provided. Committee members shall be provided a quarterly report
42 showing the number of SLB members, balance of days, and number of applications for use. The Sick
43 Leave Bank will only grant the number of days that are available in the bank. No sick leave bank days
44 will be granted that would cause a negative balance of days to occur in the Sick Leave Bank. The status
45 of the Sick Leave Bank will be reviewed by the SPALC Labor/Management Committee at the end of
46 each fiscal year to determine if the maximum number of days, used by one person, can be increased
47 to a maximum of fifty (50) days.

1
2 **(6) Benefits:** The SLB shall be used only by a SLB member for ~~his~~-their personal illness or disability and
3 may not be used because of the illness, disability, or death of any other person.

4 **(a) Extended Leave:** In the event of a catastrophic illness of a participating employee which
5 causes the employee to be absent from work for an extended period of time, the employee
6 may receive paid leave as follows:

7 **(1) Use of Leave:** The employee must first use all accumulated sick and vacation leave
8 and all other forms of paid leave available; The employee must then use unpaid leave
9 for ten (10) consecutive work days;

10 **(2) Application:** The employee must make application to the SLB and submit medical
11 justification for the number of required days;

12 **(3) Maximum:** The employee is eligible for up to twenty (20) continuous paid work days
13 in a school year or a total of twenty (20) days for any one illness or disability. ~~When-If~~
14 an employee uses twenty (20) days for any one illness or disability and returns to work,
15 the employee shall again become eligible to use days for the same illness or disability
16 after a three (3) year period from the date of return to work.

17 **(b) Second Extended Leave:** In the event of a second catastrophic illness of a participating
18 employee which occurs within one calendar year of the date the employee returned to work
19 after utilizing the Sick Leave Bank and the employee is approved for sick leave benefits, the
20 ten (10) days of unpaid leave shall be waived.

21 **(c) Denial of Request:** The eligibility of an employee to receive benefits will be reviewed by the
22 Overview Committee which will make the final determination. If an employee is denied SLB
23 benefits, the Overview Committee shall provide written reason(s). The employee may request
24 reconsideration within ten (10) calendar days from date of denial. The Overview Committee's
25 determination is not subject to the grievance procedure.

26
27 **(7) Abuse:** Alleged abuse of the SLB shall be investigated by the Superintendent. Upon a finding of
28 such abuse, the employee shall repay all of the sick leave credits drawn from the SLB and may be
29 subject to disciplinary action.

30 **(a) Ineligibility:** Any employee who receives sick leave bank benefits and is not entitled thereto
31 shall reimburse the District for all benefits received and the Board shall restore the sick leave
32 days to the Sick Leave Bank.

33
34 **(8) Discontinuance:** If it should be necessary to discontinue the SLB, unused sick leave in the SLB will
35 be distributed as follows:

36 **(a) Exceeding the Number of Members:** If the number of unused sick leave days in the SLB
37 exceeds the number of members in the SLB, each member will receive one (1) of the unused
38 days to be credited to ~~his~~-their sick leave account. Those days exceeding the number of
39 members in the SLB will be disposed of by the Board, whose decision will be final and not
40 subject to the grievance procedure.

41 **(b) Equal to the Number of Members:** If the number of unused sick leave days in the SLB is
42 equal to the number of members in the SLB, each member will receive one (1) of the unused
43 days to be credited to ~~his~~-their sick leave account.

44 **(c) More than Half the Number of Members:** If the number of unused sick leave days in the
45 bank is more than one-half (1/2) but less than equal to the number of members in the SLB,
46 each member will receive one-half (1/2) of one of the unused days to be credited to ~~his~~-their
47 sick leave account. Those days exceeding one-half (1/2) of the number of members in the SLB

will be disposed of by the Board, whose decision will be final and not subject to the grievance procedure.

(d) Half the Number of Members: If the number of unused sick leave days in the SLB is equal to one-half (1/2) of the number of members in the SLB, each member will receive one-half (1/2) of one of the unused days to be credited to ~~his~~their sick leave account.

(e) Less than Half the Number of Members: If the number of unused sick leave days in the SLB is less than one-half (1/2) of the number of members in the SLB, all of the days will be disposed of by the Board, whose decision will not be subject to the grievance procedure.

(9) Hold Harmless: The Association, its officers and agents, and the members of the unit shall hold the Board, its officers, employees and agents harmless from any and all claims which may be brought by any of its member(s), member(s) of the unit, or any authorized litigant with respect to the establishment or administration of the SLB.

12.14 – SHARED SICK LEAVE: All employees covered by this contract may donate accrued, earned sick leave to ~~his or her~~their spouse (person to whom the donor employee is legally married at the time of donation), child (natural or adopted, but not step-child), parent (mother or father of the donor employee), or sibling (brother or sister of the donor employee, but not step-sister or step-brother) who is also a regular part-time or full-time District employee (not a temporary employee or substitute).

(1) Transfer: The transfer of sick leave is subject to the following limitations and conditions:

(a) Administration: The transfer of sick leave will be administered by the Payroll Department. Employees wishing to donate sick leave will request the transfer in writing to the Payroll Department. The letter of request must include the total hours requested for transfer, name, and social security number of the intended recipient, the work location of the intended recipient, the relationship of the intended recipient to the employee donating the sick leave, and the social security number and work location of the employee writing the letter of request for transfer of sick leave hours.

(b) Request: The signed, completed letter requesting the transfer must be received in the Payroll Department prior to the current pay period processing cut-off date in order to be reflected on the recipients' current payroll record.

(c) Donor Purpose: The donated sick leave must be used for illness only and must be supported by medical verification from a physician upon request.

(d) Recipient Eligibility: The recipient must be employed in a position eligible to accrue leave time. The recipient may not use donated sick leave until all of ~~his or her~~their accumulated sick and vacation leave is depleted.

(e) Notice of Ineligibility: If the total hours identified on the letter of request from the donor are not eligible for transfer, or if the recipient identified in the letter is not eligible to receive the requested transfer of sick leave hours, the letter will be returned by the Payroll Department to the employee with an explanation included on, or attached to, the letter of request.

(f) Ineligible Hours: Unearned, advanced sick leave hours are not eligible for transfer.

(g) Recipient Accrual: The recipient will not accrue leave while using the sick leave donated by the spouse, child, parent, or sibling.

(h) Record of Denial: The Payroll Department will retain on file, a copy of the returned letters including the explanation preventing the requested transfer.

(i) Maximum: The maximum number of shared sick leave hours to be transferred at one time

1 will be calculated as follows: 20 (days) times the number of recipient work hours per day.

2 **(j) Unused Donation:** Any unused donated sick leave shall revert to the donor employee upon
3 the receiving employee's return to work.

4 **(k) Donor Retirement/Termination:** If a donor employee retires or terminates, any unused
5 shared sick leave of the recipient will revert back to the donor employee as of the last date of
6 employment.

7 **(l) Exemption:** Donated sick leave cannot be used by the recipient for the purpose of terminal
8 pay.

9
10 **(2) Hold Harmless:** The Association, its officers or agents and the members of the unit shall hold the
11 Board, its officers, employees and agents harmless from any and all claims which may be brought
12 by any of its members of the unit or authorized litigant with the establishment or administration of
13 the shared sick leave policy.

14
15 12.15 – REWRITE: The SPALC Labor/Management Committee will bring a recommendation to the
16 bargaining teams for consideration in FY22 (2021-2022 school year) that includes a clear and concise
17 re-write of Article 12 (Leave).

ARTICLE 13 –PARTICIPATORY DECISION MAKING

13.01 – **CONCEPT:** Providing support staff with opportunities to participate in the decision-making process has a positive impact on employee retention, especially whenever there is a potential impact to the work being done in the classroom, school, or department. The interest-based process and good faith efforts to maintain a collaborative relationship through bargaining related committees reduces the likelihood of labor disputes allowing all staff the ability to focus on student achievement.

(1) **Bargaining Related Committees:** Bargaining related committees are made up of both District and SPALC appointed members and each committee is assigned specific duties. Committees are assigned to review contract language to identify potential issues, in order to present recommendations to the bargaining teams or the SPALC Labor/Management Committee. Bargaining related committee meetings are regularly scheduled and records of meetings should be kept.

(2) **Leave:** Employees participating as members of Bargaining Related Committees or School Advisory Councils may, at the discretion of the supervisor, be eligible for Temporary Duty as described in Article 12.09 to attend meetings ~~when-if~~ held away from the employee's work site.

13.02 - **SPALC LABOR/MANAGEMENT COMMITTEE:** The SPALC Labor/Management Committee is a standing committee that meets on a regularly scheduled basis. The SPALC Labor/Management Committee shall be made up of four (4) members, two (2) from management and (2) from labor. Subject Matter Experts may be invited to participate in SPALC Labor/Management Committee meetings. The SPALC Labor/Management Committee is responsible for day to day contract administration, including oversight of bargaining related committees and subcommittees, ensuring the successful implementation of negotiated contract language, and executing memorandums of understanding (MOUs).

(1) **District and Site-Based Committees:** The creation or elimination of bargaining related committees may be done with the approval of the SPALC Labor/Management Committee or the bargaining teams. The SPALC Labor/Management Committee shall assist in scheduling bargaining related committee meetings and shall make every reasonable effort to avoid scheduling meetings during student contact time, while recognizing the need in some instances to meet during the regularly scheduled work day. The SPALC Labor/Management Committee is responsible for the appointment of members to all District-Based Committees, with each side having the final say in the appointment of members to represent their interests. The SPALC Labor/Management Committee shall review the parameters for site-based participatory decision making.

13.03 – DISTRICT-BASED COMMITTEES:

(1) **Insurance Task Force:** The Insurance Task Force is a standing committee that meets on a regularly scheduled basis. The Insurance Task Force shall be made up of sixteen (16) members, eight (8) from management, including the chairperson, and eight (8) from labor, with equal representation for each association representing an affected bargaining unit. The Insurance Task Force shall review existing insurance programs and workers' compensation issues. The Insurance Task Force will explore alternatives, improvements, changes, and specifications to the existing insurance programs. In order to be implemented, any committee recommendations that alter articles of this agreement or any of the medical plan benefit description documents shall be incorporated by reference in the agreement

1 after they have been ratified by both the Board and the Association.

2 (a) **Timelines:** The parties agree to use the Interest Based process ~~when-if~~ requested by a super
3 majority of TALC Bargaining Unit representatives, SPALC Bargaining Unit representatives, or
4 District representatives. ~~When-if~~ using the Interest Based process, the parties will develop a
5 decision-making timeline by mutual agreement of the parties which allows ample opportunity
6 to discuss the issues of concern. In the event that a deadline for decision making lapses, the
7 parties will revert to using majority vote to honor the deadlines in the agreed upon decision-
8 making timeline.

9
10 **(2) District Safety/Security Committee:** The District Safety/Security Committee is a standing committee
11 that meets on a regularly scheduled basis. The District Safety/Security Committee shall be made up
12 of sixteen (16) members, eight (8) from management, including the chairperson, and eight (8) from
13 labor, with equal representation for each association representing an affected bargaining unit. The
14 District Safety/Security Committee shall review district safety plans and unresolved site safety/security
15 issues. Any committee recommendations shall be sent to the Superintendent's designee and the
16 SPALC Labor/Management Committee by the chairperson.

17
18 **(3) Instructional Calendar Committee:** The Instructional Calendar Committee is a standing committee
19 that meets on a regularly scheduled basis. The Instructional Calendar Committee shall be made up of
20 twenty-four (24) members, twelve (12) from management, including the chairperson, and twelve (12)
21 from labor, with equal representation for each association representing an affected bargaining unit.
22 The Instructional Calendar Committee shall review the instructional calendar for the upcoming school
23 year. If necessary, work year calendars will be reviewed by the SPALC Labor/Management Committee
24 or the TALC Labor/Management Committee. Any committee recommendations that alter the articles
25 of this agreement shall be incorporated by reference in the agreement after they have been ratified
26 by both the Board and the Association.

27
28 **(4) Uniform Committee:** The Uniform Committee is a standing committee that meets on a regularly
29 scheduled basis. The Uniform Committee shall be made up of a mutually agreed upon number of
30 members, with equal representation for the parties. Subject Matter Experts may be invited to
31 participate in Uniform Committee meetings. The Transportation Labor/Management Committee is
32 responsible for reviewing and recommending required uniforms and accessories for all appropriate
33 departments. Any committee recommendations shall be sent to the Superintendent's designee and
34 the SPALC Labor/Management Committee by the chairperson.

35
36 **(5) Transportation Labor/Management Committee:** The Transportation Labor/Management
37 Committee is a standing committee that meets on a regularly scheduled basis. The Transportation
38 Labor/Management Committee shall be made up of a mutually agreed upon number of members,
39 with equal representation for the parties. Subject Matter Experts may be invited to participate in
40 Transportation Labor/Management Committee meetings. The Transportation Labor/Management
41 Committee is responsible for continued communication and problem solving of issues impacting
42 Transportation employees. The Transportation Labor/Management Committee is responsible for
43 reviewing the paycheck schedule for Transportation employees and providing the Payroll Department
44 with a recommendation prior to the end of the previous school year. Any committee
45 recommendations shall be sent to the Superintendent's designee and the SPALC Labor/Management
46 Committee by the chairperson.

1 **13.04 – SITE-BASED COMMITTEES:** Support staff that serve on school-based committees represent the
2 interests of individual worksites, therefore committee members will be elected by the support
3 staff assigned to that worksite. Committee members will be elected by secret ballot election, to be
4 counted by the Association's lead representative for the site and a site-based administrator. The
5 Association's lead representative or their designee shall be included on all school-based committees.
6

7 **(1) School or Site-Based Safety/Security Committee:** The School Safety/Security Committee is a
8 standing committee that meets on a regularly scheduled basis. The School Safety/Security Committee
9 shall be made up of no less than four (4) members, two (2) school-based administrators and two (2)
10 members of the support staff. Committee members may make a written request for an emergency
11 meeting of the School Safety/Security Committee. Written requests for an emergency meeting should
12 specify the reason for the request and should include the Safety & Security Department. Requests
13 must be responded to within 5 days.
14

15 **13.05 – WAIVER OF CONTRACT LANGUAGE**

16

17 **(1) Request:** The Instructional Leadership Committee at any site may request a waiver of contract
18 language in Article 5 (General Employment Practices), Article 6 (Working Conditions), and Article 7
19 (Work Schedule). All other articles shall not be altered, modified, or deviated from without the
20 express written consent of SPALC and the District. Any alteration, modification, or deviation shall be
21 memorialized in a Memorandum of Understanding. Requests for a waiver of contract language shall
22 be made to the SPALC Labor/Management Committee.
23

24 **(2) Process:** Requests for a waiver of contract language require that administration at the site allow
25 all support staff the opportunity to review the request, discuss the request, and vote by secret
26 ballot. Administration and an Association representative shall count the ballots together and at least
27 80% of the support staff assigned to the site must vote in favor of submitting the request for review
28 by the SPALC Labor/Management Committee. Approval of the request may be subject to Board
29 approval.

ARTICLE 14 –TRANSPORTATION

14.01 – GENERAL EMPLOYMENT PRATICES

(1) Seniority

(a) Bus Operators: The operator seniority list dated August 31, 2000, shall be retained for the purposes of future bidding. Contract employees hired after August 31, 2000 will be added as follows:

(1) Regular Bus Operator: The most recent date that the operator goes to work as a regular or Unassigned Regular (UAR) employee shall be the seniority date. The drawing of lots in the presence of union representatives will break ties in seniority.

(2) Substitute Bus Operator: Substitute bus operators trained but not assigned shall have as their seniority date the date that the employee accepts the sub-operator's contract. They shall be assigned as vacancies occur. If the bus operator elects to reject the appointment to a regular position, they will not be offered another appointment until such time as all others on the list have been given one opportunity to accept a regular appointment.

(3) Transportation Employees: Transportation Department employees who become trained as bus operators will move to the top of the substitute list.

(4) ESE Status: Drivers who qualify for Exceptional Student Education (ESE) routes shall be identified as such with the letter "S" following their seniority numbers.

(5) Current Employees: Current employees who are not employed as bus operators in the Transportation Department may be transferred to the Transportation Department without serving as a substitute, if they meet all other eligibility requirements and a vacancy exists. An eligible transferred employee's seniority date shall be the date of the personnel action form (PAF) which reflects the Transportation Department's recommendation for transfer to the Superintendent.

(6) Rehires: An operator who is rehired must meet all eligibility requirements, and accept reappointment as an UAR bus operator.

(b) Bus Attendants and Bus Monitors: The date of the initial appointment as a regular bus attendant or bus monitor shall be the same as the bus attendant or bus monitor seniority date. Substitute bus attendants' or bus monitors' seniority will be determined in the same manner as substitute bus operators. Bus attendants and bus monitors will be on separate seniority lists by classification for purposes of bidding. For Summer School bidding, Monitors trained as ESE attendants will be combined with the attendant's seniority list.

(1) Rehires: A bus attendant or bus monitor who is rehired must meet all eligibility requirements and accept reappointment as a substitute.

(2) Current Employees: Current employees who are not employed as bus attendants or bus monitors and who apply and are recommended may be appointed to that position without serving as a substitute if they meet all other eligibility requirements.

(2) Route/Time/Mileage (RTM) Report: A copy of the route, time and mileage sheets shall be given to the attendant/monitor anytime one is submitted to the driver of their bus.

(3) Field Trips

(a) Trip Eligibility

(1) Sign-Up: To be eligible for Field Trips an employee must notify the Transportation

Department in writing on the form provided by the District, prior to the first day of school of his/her/their availability for Field Trips. Employees who become eligible or request assignments or reinstatement after the first day of school, shall be added to the end of the list.

(2) Out-of-County Trips: To be eligible for out-of-county trips, employees must complete one full calendar year of employment as a bus operator, attendant or a monitor to work field trips. When-if requested by the employee in writing, time worked in excess of one-half year or five (5) months as a substitute will be counted toward eligibility.

(3) Removal from List:

(a) Written Request: Upon written request by the employee to the Transportation Department, an employee's name be withdrawn from the list of field trip eligible employees. When-if an employee withdraws his/her/their name from the trip list, he/she/they may not resume trip eligibility for three (3) months and then only upon written request.

(b) Third Rejection: Employees shall be removed from the trip roster for the remainder of the school year after the third rejection of a field trip within a single school year.

(c) Failure to Appear: If an employee fails to appear for a scheduled trip without providing notice 24 hours prior to the trip, the employee may be removed from the trip roster for the remainder of the school year and be subject to further discipline.

(d) Student Abandonment: If an employee abandons students while on a trip, the employee shall be removed from the trip roster and be subject to disciplinary action up to and including termination.

(b) Trip Assignment: Trips will be assigned on the basis of seniority, parking location, and availability as listed below.

(1) Types: Field trips will be classified into three (3) categories: "Hurricanes/Other Emergencies", "Short Notice Trips", and "All Other Trips".

(2) Procedure: The procedure for assignment shall be as follows:

(a) Employee Availability: Employee availability is defined as follows:

(1) Normally Assigned Route: Trip assignment to an eligible employee would not jeopardize the on-time arrival of the employee's normally assigned bus route as determined by the Executive Director of Transportation or designee.

(2) Trip Arrival/Departure: Trip assignment to an eligible employee would not jeopardize the on-time arrival and departure time of the assigned field trip bus as determined by the Executive Director of Transportation or designee.

(b) Employee Absence: Field trips missed by an employee due to an authorized absence will not cause the employee to miss his-or-her/their turn. That employee will be offered the next available field trip, however, no employee will be allowed to bank trips.

(c) Missed Trip: If an employee elects to reject an assignment, he/she/they will be passed over until his/her/their name comes up again in rotation. Any employee who misses an assigned trip or fails to decline a trip within 24 hours from notification of assignment will miss not only that turn, but his/her/their

next turn.

(d) Hurricanes/Other Emergencies: Assignments out of rotation for "Hurricanes/Other Emergencies" will be made in compliance with the above, unless approved by the Executive Director of Transportation.

(e) Weekend or Remote Location: Weekend or remote location trips, up to four hours per day, may be assigned to the same employee. These trips shall be counted as one trip.

(c) Shuttling: While on field trips, employees may be required to shuttle between schools. Rest periods will be as the field trip schedule permits. After four (4) continuous hours of shuttling, the employee will be entitled to a thirty (30) minute rest period. If an employee is not available at the needed time for a trip, another employee can be asked to shuttle part or all of the trip.

(4) Bus Operator Shortage: Field trips will not be assigned by the Transportation Department to other employees or to outside vendors unless one or more of the following conditions apply:

(a) Funding: Funding source for field trip is outside the state funded district operational budget (e.g. internal funds, donations, cooperative organization funds).

(b) Field Trip: Field trip destination is outside the nine-county internal field trip zone of Collier, Charlotte, Desoto, Hendry, Hillsborough, Lee, Manatee, Pinellas, and Sarasota County.

(c) Employee Availability: Bus employee is unavailable. Bus employee availability is defined as follows:

(1) Normally Assigned Route: Trip assignment to an eligible employee would not jeopardize the on-time arrival of the employee's normally assigned bus route as determined by the Zone Director of Transportation or designee.

(2) Trip Arrival/Departure: Trip assignment to an eligible employee would not jeopardize the on-time arrival and departure time of the assigned field trip bus as determined by the Director of Transportation or designee.

(d) Outside Vendors: If any of the above conditions apply, the District reserves the right to utilize other employees or outside vendors for field trips. Bus employees assigned to an out-of-county trip canceled one week or less prior to the day of the trip, due to the use of an outside vendor, shall be compensated for two (2) hours and shall be placed at the top of the trip list.

(5) Bus Attendant Shortage: A shortage of bus attendants shall be resolved in the following manner:

(a) Priority Order: A priority order for the assignment of bus attendants shall be established with input from the ESE Department. Students requiring bus attendants in their IEP will be served first.

(b) Bus Monitors: Bus monitors shall be assigned as bus attendants ~~when-if~~ necessary.

(c) Other Transportation Employees: Other Transportation employees may be assigned as bus attendants in an emergency.

(d) Emergency Plan: An emergency plan will be developed to allow students on buses without bus attendants to be picked up by other buses.

(e) Parent Phone Call: Parents will be called by the Transportation Department and be given the option of driving their own children if a bus attendant is required on their child's IEP and no bus attendant is available.

(f) Wheelchairs: Wheelchair buses may be scheduled late if no bus attendant is available.

(g) School-based Support Staff: Classroom assistants and helping teachers will not replace bus attendants or bus monitors on buses.

1
2 **(6) Route and Zone Bidding:**

3 **(a) Regular School Year Routes:** Route bidding for all regular school year routes shall occur
4 annually no earlier than one week prior to preschool and no later than the last day of the
5 preschool training period. Only regular bus operators have the right to bid on any regular
6 route and the designated parking area of a route may not be changed. Special education
7 routes will be offered to operators and attendants who qualify by experience or training as
8 determined by the Transportation Department. Bus Monitors and Bus Attendants have the
9 right to bid on zones during the regular school year.

10 **(b) Route Posting:** Descriptions of all routes will be posted at a designated location at least
11 forty (40) work hours prior to the beginning of the bidding procedure.

12 **(c) Route Listings**

13 **(1) Assigned Duties:** Routes shall be listed by:

14 **(a) Estimated Route Time:** Estimated route time (Up to a maximum of 8 hours
15 per day. If there is a possibility of scheduled overtime, more than 40 hours per
16 week, it will be noted on the bid sheet).

17 **(b) Bus Information:** Bus number and type of bus.

18 **(c) Bus Location:** Bus parking locations as determined by Transportation
19 Department Administration.

20 **(d) School Information:** Schools served.

21 **(e) Route Start and End Time:** Approximate beginning and ending time.

22 **(f) ESE Status:** Special education.

23 **(2) Additional Assigned Duties:** Routes will include any permanently assigned standby
24 time, intramural runs, activity runs, route preparation, swim team runs, discipline runs
25 and any other additional duties permanently assigned.

26 **(d) Personal Transportation:** All employees must furnish their own transportation to the
27 original bus departure point

28 **(e) Bidding Process:** Employees will receive written notification of their assigned seniority
29 number, along with the time and date to select their routes. Employees who do not appear
30 during their assigned time may select a route at the end of the specified time block during
31 which they appear. Any employee who does not appear will be assigned an available route at
32 the conclusion of the bidding process.

33 **(f) Proxy Bidding:** An employee who is unable to attend the route bidding on the specified day
34 or time may execute a proxy. The proxy must be presented at the employee's assigned time
35 and place for bidding.

36 **(g) Master List:** As routes are filled during the bidding, the name of the employee who elects
37 the route will be placed on the master list, so that employees who have yet to bid will know
38 which routes are available.

39 **(h) Vacant Routes:** Routes that are created or become vacant after all bidding is completed
40 shall be filled in the following order:

41 **(1) Unbundling Routes:** "Unbundling," if possible, those routes (by school – not by stop)
42 and redistributing the schools to other drivers based on availability and seniority. If
43 the route in question is an ESE route, the bus attendant will retain his/her/their initial
44 RTM (route/time/mileage).

45 **(2) Splitting Routes:** When-If a route is split, the senior employee is given first choice
46 between the two new routes created.

47 **(3) Rebidding Routes:** Rebidding vacancies as they occur if the RTM is greater than or

equal to the guaranteed minimum hours. Assign remaining openings from the substitute list, if less than the guaranteed minimum hours.

(4) Eliminating Routes: ~~When-If~~ a bus route is eliminated, the bus employee will become an UAR operator or an unassigned attendant until they bid an available route.

(i) Rebidding Process: All applicable requirements of Article 14.01(6) apply during the rebidding process. The rebidding process shall be as follows:

(1) Route Posting: Descriptions of all routes to be rebid will be posted at a designated location at least forty (40) work hours prior to the beginning of the rebidding process.

(2) Rebidding Location: The designated location of the rebidding process will be posted with the route descriptions to be rebid.

(3) Proxy Bidding: The employee or proxy must be present to participate in the rebidding procedure.

(4) Employee Responsibilities: Employees must sign bids and cannot decline a route once they have submitted a bid.

(5) Management Responsibilities: Representatives from Transportation management, the department responsible for safety, and the Support Personnel Association of Lee County shall be present during the rebidding process.

(6) Vacant Routes: Routes of employees on long term leave (more than 6 calendar weeks) route will be bid as vacant. ~~When-If~~ the employee returns to work, they will be an UAR until they bid on another available route.

(j) Route Adjustments: Bus routes shall be bid as posted. Routes may be adjusted and buses may be reassigned by Transportation administration or designee after bidding is completed. Paid Route Time and Mileage (RTM) reduced during the first two pay periods of the student year will not take effect until the third pay period. Thereafter, reductions in paid time will only occur on the basis of every other pay period. If there is a necessary reduction in the RTM, (in between the actionable pay periods), the reduced time will be made up by the employee serving standby time to perform transportation-related duties. If the bus employee chooses to waive the standby time the reduction in paid time will take place immediately.

(k) Permanent Route Change: ~~When-If~~ the supervisor determines that a permanent route change is necessary, the bus employee(s) affected shall be consulted about the reasons for the change, the new route and the pupil bus load before the change is made. Due to the large number of changes during the first 15 days of school or under other emergency circumstances, such consultation with the employee(s) may not be possible. The supervisor shall then consider the employee's input and shall thereafter notify the employee the day a change is confirmed.

(l) Summer School Routes: Summer School Bidding shall follow the same rules as regular bidding. Summer school route bidding will take place no earlier than two weeks prior to the first day of summer school and no later than two days prior to the first day of summer school. It will be held in an air-conditioned space. Last minute changes in routes shall be posted prominently where all can see before bidding. There will be no supervisor influencing of operators in the choice of routes. The rules of bidding shall be a topic of the April Transportation Labor/Management Meeting.

(1) Bus Attendants and Bus Monitors: Bus attendants and bus monitors have a right to bid on summer routes if they are trained as ESE attendants.

(2) Failure to Complete Summer School: Employees who accept a summer run and fail to complete their commitment to the School District will be ineligible for the following year's summer school bidding.

1 **(3) Bidding Process:** Bus employees assigned who work during the regular school year
2 immediately preceding summer school, shall bid on summer routes prior to transfer
3 or new employees.

4 **(4) Sick Leave:** Sick leave shall be utilized as per Article 12.02. Within 30 days of the end
5 of summer school, employees ineligible for the next summer school bidding will be
6 notified. These employees will have thirty (30) days to appeal their eligibility status
7 with Transportation administration.
8

9 **(7) Light Duty:** Transportation employees placed on light duty may be assigned to other duties to
10 include gate duty where appropriate.
11

12 **(8) Assistance:** Transportation employees may request or be assigned additional training, ask
13 clarifying questions or seek assistance with routing concerns and/or student discipline (route/stop
14 adjustments) without fear of negative repercussions.
15

16 **14.02 – WORKING CONDITIONS** 17

18 **(1) Physical Facilities:** Every effort will be made to equip transportation compounds, whether
19 temporary or permanent, with sanitary, water and waste disposal facilities and paper products.
20 Facilities shall be maintained to ensure proper health and hygiene. ~~When-If~~ sanitary, water, waste
21 disposal or paper products are not available at the compound, bus employees will be notified as to
22 the location of the facilities to be used.
23

24 **(2) Physical Examination:** Bus operator's physical examinations and dexterity tests required by law
25 shall be completed prior to bidding. Physical examinations must be performed by physicians
26 specifically authorized by the District to perform bus driver physicals. Proof of physical must be carried
27 at all times while operating a school bus. In order for the District to pay for the physical, the employee
28 must show up for the physical at the scheduled time. Subsequent physicals will be scheduled during
29 the employee's birth month and in accordance with law. The employee will schedule the physical and
30 must comply with scheduling requirements or be responsible for paying the cost of the physical. The
31 parties agree that SPALC will have a representative on the Request for Proposal (RFP) team related to
32 performing employee physical exams.

33 **(a) Fitness-For-Duty:** Employees must be able to perform all work-related duties, including
34 licensure and physical requirements, at the time of placing their bus bid.
35

36 **(3) Student Discipline:** Bus operators will have input in disciplinary decisions regarding the
37 transportation of students disruptive while on the bus. See Article 6 regarding safety and student
38 discipline.
39

40 **14.03 – WORK SCHEDULE** 41

42 **(1) Work Day (Bus Operators):**

43 **(a) Standard Work Day:** All regular bus operators will be guaranteed a minimum of seven (7)
44 hours per day ~~when-if~~ school is in session. All hours worked beyond 40 hours in the work week
45 will be paid per Article 7.04(2)(a)(1) of this agreement. The minimum requirements shall not
46 apply to summer school.
47

(b) Absence Reporting: All absences must be reported to the Transportation Department no

1 later than one (1) hour prior to the scheduled start of the route.

2 **(c) Breaks:**

3 **(1) As Schedule Permits:** Bus Operators may take a morning (a.m.) and afternoon
4 (p.m.) break as their schedule permits.

5 **(2) Safe Location:** Breaks will be taken at a safe location without deviating from the bus
6 operator's scheduled route.

7 **(3) Route Time:** Route time will not be extended to provide for a break.

8 **(d) Time Reporting:** Bus operators will be paid for all time worked within a pay period per
9 Articles 10.05(1)(d) and 10.05(1)(e), if the employee has accurately reported work time on the
10 prescribed tracking system. Work time not accurately recorded by the employee on the
11 prescribed tracking system, shall be paid after the employee has notified the Transportation
12 Department. Upon notification and verification, the employee will be paid within the next two
13 pay periods.

14 **(e) Pre and Post-Trip Inspection:** The normal workday shall be the bid time, including the one
15 half (1/2) hour for non-route time (pre- and post-trip inspection), up to a maximum of 8 hours.
16 Additional workday hours shall include approved hours on the Route Time & Mileage (RTM)
17 report.

18 **(1) Excess Time:** Any operator whose approved route exceeds six and one-half (6-1/2)
19 hours per day will be paid for excess time to the nearest quarter hour at his-~~their~~
20 regular hourly rate.

21 **(2) Non-Route Time:** The one-half (1/2) hour daily non-route time shall be used by
22 operators for activities needed to perform their normal duties. Duties include, but are
23 not limited to fueling and cleaning of bus, completion of surveys and other paper work
24 and conducting pre- trip/post trip inspections.

25 **(f) Mandatory Meetings or Training Sessions:** Operators who do not have adequate additional
26 duty hours to cover mandatory meetings or training sessions will be reimbursed at their
27 regular hourly rate.

28 **(g) Standard Work Day Exemption:** Operators who prefer to work fewer than thirty-five (35)
29 hours per week may be exempt from the minimum day by submitting a written request to the
30 Transportation Department by the first day of preschool or upon initial employment.
31 Exemptions are subject to approval by the appropriate Assistant Director and shall remain in
32 effect during the school year unless otherwise approved. Operators who are exempt from the
33 minimum day shall not be eligible for field trip assignments and shall be paid for actual route
34 time and an additional one-half (1/2) hour per work day non-route time. No extra duties or
35 standby time will be assigned to these routes.

36 **(h) Pilot Program:** Beginning with the FY-14 (2013-2014 school year) and continuing for the
37 duration of this agreement, the District will implement a pilot program for up to forty (40) bus
38 operators who will be exempt from the seven (7) hour requirement contained in Article 14.04
39 (a) of this agreement. This pilot program will be reviewed by the SPALC Labor/Management
40 Committee prior to its continuation in subsequent years. This pilot will be implemented
41 primarily for activity-related runs and will be bid by zone. Bus operators employed pursuant
42 to this article, are not eligible to be added to the field trip list.

43
44 **(2) Work Day (Bus Attendants and Bus Monitors):**

45 **(a) Standard Work Day:** All regular bus attendants and monitors will be guaranteed a minimum
46 of six (6) hours per day when-if school is in session. All hours worked beyond forty (40) hours
47 in the work week will be paid per Article 7.04(2)(a)(1) of this agreement. The minimum

requirements shall not apply to summer school.

(b) Absence Reporting: All absences must be reported to the Transportation Department no later than one (1) hour prior to scheduled start of the route.

(c) Breaks:

(1) As Schedule Permits: Bus attendants and bus monitors may take a morning (a.m.) and afternoon (p.m.) break as their schedule permits.

(2) Safe Location: Breaks will be taken at a safe location without deviating from the scheduled route.

(3) Route Time: Route time will not be extended to provide for a break.

(d) Time Reporting: Bus attendants and bus monitors will be paid for all time worked within a pay period per Articles 10.05(1)(d) and 10.05(1)(e) if the employee has accurately reported work time on the prescribed tracking system. Work time not accurately recorded by the employee on the prescribed tracking system, shall be paid after the employee has notified the Transportation Department. Upon notification and verification, the employee will be paid within the next two (2) pay periods.

(e) Mandatory Meetings or Training Sessions: Bus attendants and bus monitors who are required to attend area training meetings will be paid their regular hourly rate for time in attendance at such meetings.

(f) Additional Hours: The normal workday shall be the bid time, up to a maximum of eight (8) hours. Additional workday hours shall include approved hours on the Route Time & Mileage (RTM) report.

14.04 – COMPENSATION

(1) Field Trips:

(a) Reimbursement for Expenses: For all out-of-county field trips of one (1) day or less, and for all overnight trips when-if lodging is provided by the school or group, employees will be reimbursed for meals as provided by School Board Policy. For all out-of-county overnight trips when-if lodging is not provided by the school or group, the employee may file a travel expense report for reimbursement as provided by School Board policy. Reimbursement will be based on the time from which the operator begins the trip to the time when-if the operator parks the bus at the end of the trip. Requests for reimbursement shall be processed and paid within thirty (30) days following the submission of required paperwork. The prescribed reimbursement rate for meals when-if on trips shall be as provided to the employee.

(b) Field Trips: For all trips which cannot be accomplished during the minimum day except overnight trips, employees will be paid at their regular hourly rate. Field trips which occur between July 1 and the first student school day of the new school year will be paid at the employee's regular hourly rate for the preceding school year. Employees will receive retroactive pay (when-if negotiated) for field trips occurring after the date of the opening of school. The number of hours to be paid for a field trip will be calculated from the time from which the employee begins the trip to the time when if the employee parks the bus at the end of the trip.

(c) Overnight Field Trips: Compensation for all out-of-county overnight field trips shall be paid at the regular hourly rate, up to a minimum of twelve (12) hours pay for each calendar day the employee is away. Should the employee work more than twelve (12) hours, a log shall be kept and the employee will be paid for the hours recorded on the log.

(d) Field Trip Cancellation: When-if a field trip is canceled, and notification is not given to the

1 employee until the actual day of the trip, the employee shall receive two (2) hours pay or actual
2 time worked, whichever is greater, based on the regular hourly rate. Field Trip cancellations
3 shall not count as a trip taken.
4 **(e) Bus Preparation/Clean Up:** Operators shall be paid one (1) additional hour per field trip for bus
5 preparation and cleaning for out-of-county trips.

ARTICLE 15 – DURATION AND ACCEPTANCE

1 **15.01 – EFFECTIVE:** Following ratification by the bargaining unit, this Agreement shall be effective the
2 day after ratification by the Board.
3

4 **15.02 – SCOPE:** The parties acknowledge that during the negotiations that resulted in this Agreement,
5 each had the unlimited right and opportunity to make demands and proposals with respect to any
6 subject or matter not removed by law from the area of collective bargaining. The parties
7 acknowledge that the understandings and agreements arrived at, after exercise of that right and
8 opportunity, are set forth and solely embodied in this Agreement. The parties agree, therefore, that
9 they shall not be obligated to negotiate or bargain collectively with respect to any subject or matter
10 whether referred to herein or not except as otherwise specifically required in this Agreement,
11 even though such objects or matters may not have been within the knowledge or contemplation of
12 either or both of the parties at the time they negotiated or signed this Agreement.
13

14 **15.03 – DURATION:** The duration of this agreement is three (3) years: [FY19 \(2018-2019 school year\),](#)
15 [FY20 \(2019-2020 school year\), and FY21 \(2020-2021 school year\),](#) [FY21 \(2020-2021 school year\),](#) [FY22](#)
16 [\(2021-2022 school year\), and FY23 \(2022-2023 school year\).](#)
17

18 **(1) Re-opener:** The parties agree to commence negotiations of a re-opener no later than March 1,
19 [2020/2021, and March 1, 2022.](#)
20

21 **(2) Successor Agreement:** The parties agree to commence negotiations for a successor agreement no
22 later than June 30, [2021/2023.](#)
23

24 **(3) Windfall or Shortfall:** If state funding is inadequate or in excess of the funding necessary to account
25 for the fiscal impact of this agreement, the parties agree to an emergency re-opener to negotiate
26 impact. Articles will be reopened, as appropriate, so that the impact of any windfall or shortfall in
27 District funding may be negotiated and appropriate increases or decreases may be discussed. The
28 parties agree to commence negotiations upon written request of either party to re-open due to a
29 windfall or shortfall.
30

31 **15.04 – MODIFICATION:** The terms and conditions of this Agreement may be altered or modified
32 only through the voluntary mutual consent of the Parties in a written and ratified amendment.
33

34 **15.05 – SEVERABILITY:** If any article of this Agreement is declared illegal by a court of competent
35 jurisdiction, or as a result of a change in state or federal law, the Parties shall meet as soon as
36 practicable to modify the article to the extent necessary to bring it into legal compliance. The
37 remaining articles shall remain in full force and effect for the duration of this Agreement.
38

39 **15.06 – EXPIRATION:** This Agreement, together with all the terms, conditions and effects thereof,
40 shall expire on June 30, [2021/2023](#), and in no event shall any other articles contravene the
41 expiration of this Agreement.

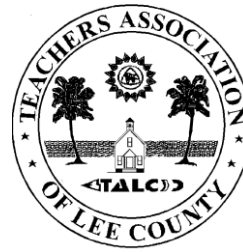
