Background Information:

ITN No. N177276LN is for removal and installation of new non-coded, UL listed intelligent analog addressable fire alarm systems, with multiplexed signal transmission, on an as needed basis. It is recommended that the award be made to All Digital Technology, Integrated Fire and Security Solutions, Inc., and SimplexGrinnell LP, as indicated on the attached tabulation sheet. It is recommended that the ITN be effective for three years beginning June 27, 2017 through June 26, 2020, with renewal options for three additional one year periods, upon the written agreement of the vendors and the District, at an estimated expenditure of \$1,000,000.00. Twenty seven vendors were notified of the ITN; four vendors submitted a response, and 23 vendors did not respond. Details of projects to be supported by this ITN include:

- Allen Park Elementary School - Complete fire alarm system removal and replacement.
- Cypress Lake Middle School - Complete fire alarm system removal and replacement.
- Southwest Public Service Academy - Complete fire alarm system removal and replacement.
- Three more facilities will be added to have complete fire alarm system removal and replacement.
