Recommended Action Approval to award ITB No. B187337RC for classroom, office & specialty furniture to ELB US, Inc. - ELB Education; Ernie Morris Enterprises, Inc.; Hertz Furniture Systems, LLC; Lakeshore Learning Materials; MeTEOR Education, LLC; Prison Rehabilitative Industries & Diversified Enterprises (PRIDE); R. George & Associates, Inc.; School Outfitters, LLC; School Specialty, Inc.; Schoolhouse Products, Inc.; Signature Products, Inc.; United Data Technologies, Inc.; Universal Seating Company; Virco, Inc.; and Wenger Corporation as indicated on the attached tabulation sheet. This ITB will be effective for three years beginning October 23, 2018 through October 22, 2021, at the estimated expenditure of \$2,000,000.00, for the first year of the base contract period of October 23, 2018 through October 22, 2019, with renewal options for three additional one year periods, upon the written agreement of the vendors and the District. Approval authorizes the Superintendent to execute all related documents.

Goals Become a Model Continuous Improvement Organization.

ITB No. B187337RC is for Classroom, Office & Specialty Furniture for use throughout the District. This ITB is separated into seven categories: Classroom Furniture; Office Furniture; Cafeteria Furniture; Science Furniture (STEM); Media Furniture; Outdoor Furniture; and Miscellaneous Furniture. This Bid is intended to replace multiple piggybacks the District currently has in place. It is recommended that the award be made to ELB US, Inc. - ELB Education; Ernie Morris Enterprises, Inc.; Hertz Furniture Systems, LLC; Lakeshore Learning Materials; MeTEOR Education LLC; Prison Rehabilitative Industries & Diversified Enterprises (PRIDE); R. George & Associates, Inc.; School Outfitters, LLC; School Specialty, Inc.; Schoolhouse Products, Inc.; Signature Products, Inc.; United Data Technologies, Inc.; Universal Seating Company; Virco, Inc.; and Wenger Corporation as indicated on the attached tabulation sheet. This bid will be effective for three years beginning October 23, 2018 through October 22, 2021, with renewal options for three additional one year periods, upon the written agreement of the vendors and the District, at the estimated expenditure of \$2,000,000.00 for the first year of the base contract period of October 23, 2018 through October 22, 2019. One hundred fifty-seven vendors were notified of the ITB; 17 vendors submitted a responsive bid, three vendors submitted a no bid, one vendor was non-responsive and 136 vendors did not respond.
