Background Information:

On December 6, 2016, RFP No. R167287CN for interior and exterior painting services was awarded to Florida Painters of Lee County, Inc., Hein Brothers LLC, Karras Painting Company, Steve's Painting, Inc. and Vic's Painting & Reconstruction, for the period of December 7, 2016 through December 6, 2019, with renewal options for three additional one year periods, upon the written agreement of the vendors and the District.
