Products include awards, banners, lanyards, logo items, name tags, t-shirts, trophies, etc. It is recommended the award be made to 4imprint, Inc., Authentic Promotions.com, BSN Sports, Passon's Sports & US Games, Crown Trophy of Cape Coral, DCP Holdings, Inc. d/b/a Image Depot Express, Educational Products, Inc., Fred's Award World, Life's A Logo Express Yourself, Inc., Matteo Graphics, Inc., MTM Recognition d/b/a Jostens Awards, Neff Motivation, Inc., Sallee Promotions, Inc., South Seas T's, LLC, The Little Sign Company, Inc. and World of Promotions, as indicated on the attached tabulation sheet, effective for three years, beginning July 30, 2019 through July 29, 2022, at the estimated expenditure of \$100,000,000, for the first year of
