Roofing North Fort Myers High School as follows:

2. O-A-K/Florida, Inc. d/b/a Owen-Ames-Kimball Company

3. Gulfpoint Construction Company, Inc.

4. Chris-Tel Company of Southwest Florida, Inc. d/b/a Chris-Tel Construction

Approval authorizes the District to enter the negotiation process and authorizes the Superintendent to execute all related documents. In the event negotiations with the top ranked firm are not successful, approval is recommended to proceed with negotiation and

execution of a contract according to the order of the ranking.

Request for Qualifications No. CQ19-0028TA is for Construction Management Services for Re-Roofing North Fort Myers High School. The RFQ Selection Committee met publicly on November 13, 2019, to evaluate and score qualifications of eight responses received, and on November 19, 2019, to score and rank presentations of the firms submitting the four top ranked responses. The final ranking of the firms is recommended as follows:

- 1. Target Builders Construction
- 2. O-A-K/Florida, Inc. d/b/a Owen-Ames-Kimball Company
- 3. Gulfpoint Construction Company, Inc.
- 4. Chris-Tel Company of Southwest Florida, Inc. d/b/a Chris-Tel Construction
