#### **GENERAL CONDITIONS**

Proposer: to ensure acceptance of the proposal follow these instructions.

- 1. Electronic Proposal Requirements: The "Proposer Information Sheet", page 2 of the ITN, must be completed, signed, and returned with each proposal. Proposers must submit one electronic proposal, electronically signed by a representative authorized to legally bind the Proposer to the provisions herein; and all attachments and forms completed as required herein. Unless otherwise specified, Proposers must use the form(s) furnished by the District. Proposals received that fail to comply with these submittal requirements may not be considered for award.
- <u>Definitions:</u> For the purpose of this Invitation to Negotiate (ITN), the following words and phrases shall have these meaning:
  - a) "District" shall mean The School Board of Lee County, Florida.
  - b) "Proposer" shall mean any person, firm or corporation 8. who submits a proposal pursuant to this ITN.
  - c) "Contractor" shall mean the successful Proposer(s), whether a corporation, partnership, individual or any combination thereof, and its, their or his successors, personal representatives, executors, administrators, and assignees.
- 3. Proposer's Responsibility: It is the responsibility of the Proposer to obtain all pages of the ITN package and all attachments thereto, together with any addenda to the ITN package that may be issued prior to the ITN due date. Proposers are required, before submitting a proposal, to obtain and carefully examine the ITN specifications and to completely familiarize themselves with all of the terms and conditions. Ignorance on the part of a Proposer will in no way relieve them of any of the obligations and responsibilities which are a part of this proposal.
- 4. Proposal Submittal: All proposals electronically submitted using the Bonfire Platform. Proposals having erasure or corrections must be initialed by the Proposer. All proposals must be signed by an officer or employee having authority to 9. legally bind the Proposer. All proposal pricing shall be on the response form provided herein and signed by an authorized officer of the company. By signing, Proposer attests that they fully understand there will be no recourse for negligence or oversight for not doing so. Completed proposal must be submitted in the Bonfire Platform.
- 5. **Special Conditions:** If a conflict exists between the general conditions and the detailed specifications, then the detailed specifications shall prevail.
- 6. Public Entity Crime: Pursuant to Florida Statute 287.133, a person or affiliate who has been placed on the convicted Contractor list following a conviction for a public entity crime may not submit a proposal on a contract to provide any goods or services to a public entity, may not submit a proposal on a contract with a public entity for the construction or repair of a public building or public work, may not submit proposals on leases of real property to a public entity, may not be awarded or perform work as a Contractor, supplier, Subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the

- threshold amount provided in Section 287.017, for CATEGORY TWO, for a period of 36 months from the date of being placed on the convicted Contractor list. Proposers shall complete and submit with their Proposal the complete, accurate, and notarized statement required by Section 287.133, Florida Statutes, Public Entity Crimes Statement, provided herein. Failure to submit a properly completed and notarized form shall be cause for submittal to be judged non-responsive.
- 7. Specification Variances: For purpose of evaluation, the Proposer shall indicate any and all variances from specifications, terms and/or conditions regardless of how slight. If variations are not stated in the proposal, it shall be assumed that the proposed product or service fully complies with the specifications, terms and conditions herein.
- **Requests for Clarifications:** Any and all questions regarding this ITN, whether technical, procedural or otherwise, must be submitted in writing to the attention of the Procurement Agent designated herein, ten (10) business days prior to the ITN due date, or as otherwise specified in the detailed specifications. All such interpretations and supplemental instructions will be in the form of written addenda to the ITN documents and posted on the Bonfire Platform. No correction or clarification of any ambiguity, inconsistency or error in the ITN terms, conditions or specifications will be made to any Proposer orally. Only the interpretation or correction so given by the Procurement Agent, in writing, shall be binding. Proposers are advised that no other source is authorized to give information concerning, explaining, or interpreting the ITN documents. If a Proposer should be of the opinion that the meaning of any part of the proposal specifications are uncertain, obscure, or contains errors or omissions, they should report such opinion to the Procurement Agent in writing no more than three (3) days after the receipt of the documents.
- 9. <u>Submission of Proposal:</u> One proposal must be electronically submitted in the School District of Lee County's Bonfire Platform no later than the date and time specified on the cover sheet of this ITN, to be considered. Proposals shall be organized and shall include necessary information as to be in full compliance with the ITN specifications. The District reserves the right to reject and not consider any proposal that is not submitted in accordance with the ITN general conditions, specifications or ITN submittal requirements.
- Proposal Opening: Proposal openings shall be public at the date and time stated in the ITN at the Department of Procurement Services of The School District of Lee County, 2855 Colonial Blvd., Fort Myers, Florida 33966-1012, unless otherwise indicated.
- 11. Proposals Received Late: It is the Proposers responsibility to assure that the proposal is received by the Department of Procurement Services, Bonfire Platform prior to the opening date and time specified. The Bonfire electronic platform will not allow submissions after the due date and time and therefore will not be considered for award.

- 12. Processing Time: It is understood that the normal proposal processing time shall be 120 days after the opening date of this ITN, and that prices reflected by the proposal will be firm through the proposal processing time and the delivery of items awarded.
- 13. Original and Renewal Term: The award resulting from this ITN shall be in effect for the term defined in the detailed specifications commencing upon Board approval or until new this ITN (or any portion thereof) has the option of being renewed as defined in the detailed specifications, or extended for a period up to 180 days, upon mutual agreement of both parties, under the same terms and conditions as the original award. The District, through its Department of Procurement Services, will, if considering a renewal or extension, request a letter of intent to renew or extend from one or more awardees, prior to the end of the current contract period. The awardees will be notified when the recommendation has been acted upon by the District. The Proposer agrees to these conditions by signing its proposal.
- 14. Lobbying: From the time that a formal solicitation is released until such time as an award is made by the School Board, Contractors are prohibited from lobbying School Board Members, District employees, or any community member appointed to serve on the relevant selection committee, regarding the formal solicitation. All inquiries must be written and directed to the Department of Procurement Services.
  - (a) Lobbying is defined as any action taken by an individual, firm, association, joint venture, partnership, syndicate, corporation, and all other groups who seek to influence the governmental decision of School Board Members, District employees, or any community member appointed to serve on the relevant selection committee, on the award of a contract. Lobbying by any Proposer or any individual on behalf of a Contractor will result in rejections/disqualification of said response.
  - (b) Violation of the provision regarding lobbying may also result in debarment of the Contractor as provided in Policy 6.071.
- 15. Prompt Payment Discount: Cash discount for prompt payment of invoices, if offered, shall not be considered in evaluating proposals and making awards. Cash discount terms, if offered in the proposal, must be clearly indicated on each invoice.
- 16. **Brands:** Proposers shall indicate, for each item proposed, the name and model of the brand being proposed. Use of brand names, trade names, make, model, manufacturer, or Contractor catalog number in the specifications is for the purpose of establishing a grade or quality of material only. It is not the District's intent to rule out other competition; therefore, the phrase "OR APPROVED EQUAL" is added, unless otherwise indicated in the specifications. However, if a product other than specified is proposed, it is the Proposer's responsibility to submit, with the proposal, samples, descriptive literature and/or detailed specifications which illustrate the product sufficiently for evaluation. Proposals received without this information, or with insufficient information, as determined by the evaluation committee, may not be considered. If the words "ONLY" or "NO

- SUBSTITUTES" appear in the specification, then no other brands, trade names, makes, models or manufacturers shall be considered. The District shall be the sole judge concerning the merits of proposals submitted. If a Proposer does not indicate what he is offering in the proper blank and if the Proposer is successful in being awarded the item(s) then the Proposer shall be obligated to furnish the item(s) specified by the District.
- proposals are taken and awarded. The award resulting from 17. Warranty/Guarantee: All materials and/or services furnished under this proposal shall be warranted by the Contractor, distributor and manufacturer to be free from defects and fit for the intended use. Unless otherwise requested, the items proposed must be new and equal to or exceed specifications. The manufacturer's standard guarantee or warranty shall During the guarantee or warranty period, the Contractor must repair and/or replace the unit without cost to the District with the understanding that all replacements shall carry the same guarantee or warranty as the original equipment. The Contractor shall make any such repairs and/or replacements immediately upon receiving notice from the District.
  - 18. Proposal Evaluation and Award: Proposals shall be reviewed in accordance with the ITN specifications and conditions and the best interest of the District. The District reserves the right to accept or reject any or all proposals in part or in whole, waive minor variations, informalities, irregularities, omissions or technicalities, request new proposals, and/or consider alternate proposals which meet the general specifications set forth. Proposals which contain any alteration, addition, conditions, limitations, unauthorized alternates or show irregularities of any kind may be rejected by the District. The District reserves the right to award proposals on such products and/or services it deems will best serve the District's best interest from the standpoint of price (including any applicable preference pursuant to Section 287.084, F.S.), quality, and suitability for the intended purpose, including product life cycle costs, and any other determining factors.
    - Proposals will be evaluated, scored and ranked based on the written responses to the proposal grading criteria specified herein. Based on the rankings, one or more firms may be selected to commence negotiations. The District reserves the right to create, and select Proposers from a "short list" in order to enter into final contract negotiations with one or more Proposers, with the intent of awarding a contract and producing terms and conditions to reflect the outcome of the negotiations.
    - b) The District reserves the right to conduct optional interviews/presentations with none, some or all Proposers.
    - The District reserves the right to negotiate individually or collectively with one or more top ranked firms, and to evaluate, score and rank Proposers who enter into final contract negotiations, based on the grading criteria specified herein. Proposers invited to negotiate shall make available at each and every negotiation their representatives with the responsibility and authority to legally commit the Proposer to final terms and conditions. Proposers are cautioned to present their best

- offer with their proposal as the District may select a proposal for award without further negotiation.
- d) After final evaluation, ranking, and/or negotiation of one or more proposals, a tabulation of the responses with intent to award shall be posted for review by interested parties on the School District of Lee County's website http://www.leeschools.net/procurement for a period of no less than three (3) days.
- e) A recommendation for award will be presented to the Superintendent, and subsequently to the School Board for consideration. The School Board exercises the authority to accept or reject proposals.
- Upon Board 19. Notification of Award/Purchase Orders: approval to award a contract, participating Proposers, successful and unsuccessful, shall be notified of the award configuration in writing by the Department of Procurement Services. Proposers who are awarded a contract resulting from this ITN are cautioned not to provide goods or services to any District site or to any District employee prior to receiving purchase orders issued by the District's Department of Procurement Services. Notification of Award is not to be construed as authorization to provide goods or services.
- 20. Contract Documents: The submission of a proposal constitutes an offer by the Proposer. Upon Board approval the Department of Procurement Services will issue a letter of award. This ITN, any addenda to this ITN, the submitted proposal, revisions to such documents agreed upon by both parties in writing during the negotiation process, and the corresponding purchase order(s) and change order(s) will constitute the complete agreement between the successful Proposer and the District. If a specific contract document is requested by the District, it shall be included with the abovementioned items as part of the contract agreement. Each proposal is received with the understanding that an acceptance in writing by the District of the offer to furnish any or all of the services and materials described shall constitute a contract between the Proposer and the District. This contract shall bind the Proposer to furnish and deliver the services and materials quoted, at the prices stated and in accordance with the terms conditions of said accepted proposal. It is agreed that the Proposer will not assign, transfer, convey or otherwise dispose of the contract or its right, title or interest in or to the same, or any part thereof, without previous consent of the District and any sureties.
- 21. General Information about the District: The District and its School Board of Lee County were created pursuant to Section 4, Article IX of the Constitution of the State of Florida. The District is an independent taxing and reporting entity controlled, operated, administered, supervised by District school officials in accordance with Chapter 1001, Florida Statutes.
  - a) The School Board consists of seven elected officials responsible for the adoption of policies, which govern 24. Contractor Performance: The Contractor shall provide the operation of District public schools. Superintendent of Schools is responsible for the administration and management of the schools within the applicable parameters of State Laws, State Board of Education Rules, and School Board policies. Superintendent is also specifically delegated the

- responsibility of maintaining a uniform system of records and accounts in the District by Section 1001.51, Florida Statutes as prescribed by the State Board of Education.
- The District serves the entire area of the county, including the cities of Bonita Springs, Cape Coral, Fort Myers, Fort Myers Beach, Sanibel and the Village of Estero. The District's enrollment is approximately 95,000 With approximately 12,000 pre-k-12 students. employees (including full-time, part-time, substitutes, short-course instructors, and hourly employees), the District is the second largest employer in Lee County.
- 22. Price Adjustments: The District may, in its sole discretion, make an equitable adjustment in the contract terms and/or pricing if pricing or availability of supply are affected by extreme and unforeseen volatility in the marketplace, that is, by circumstances that satisfy all of the following criteria:
  - The volatility is due to causes wholly beyond the Contractor's control
  - b) The volatility affects the marketplace or industry, not just the particular Contractor's source of supply
  - The effect on pricing or availability of supply is substantial
  - The volatility so affects the Contractor that continued performance of the contract would result in substantial loss or financial hardship.

The determination as to whether a situation represents "extreme" volatility of the marketplace and/or whether the effect on pricing or availability is "substantial" shall be solely at the discretion of the District. Requests for adjustments must be made to the Director of Procurement Services within twenty-four hours after receipt of an order from the District for the affected product and will not be considered more than once in a 120-day period. For contracts with an initial award period exceeding one (1) year, prices shall remain firm for the first year.

- 23. **Substitutions:** Should a particular product become unavailable after award due to discontinuance by manufacturer, extreme market demand or inability of manufacturer to produce the product for a certain period of time, or quality or compatibility as solely determined by the District, Contractor may propose a substitute product to the District. The Contractor shall provide specifications for the proposed substitute product, or if requested by the District, a sample of the proposed substitute. Contractor will also provide documentation as to the unavailability of the original awarded product to the District for its review. Such a substitute will only be considered if the District has a continued need for the product within a specified time frame where the original awarded product unavailable. Whether a substitute is necessary and whether the proposed substitute is acceptable are solely within the discretion of the District.
- competent, suitable, qualified personnel to perform any project required by the ITN. The Contractor shall at all times maintain good discipline and order while on District property. Contractor employees and Subcontractor employees (if authorized) assigned to this contract must be pre-screened

and will be thoroughly reviewed for but not limited to current certification and documentation. When on District property:

- a) The Contractor shall furnish all equipment, labor, transportation, construction equipment and machinery, tools, appliances, fuel, power, heat, light, telephone, water and sanitary facilities and incidentals necessary for the execution, testing, initial operation and completion of any project unless otherwise specified.
- b) The Contractor shall be responsible for the appearance and demeanor of all personnel assigned to the project and shall require that all employees wear shirts with visible company logo and personal identification of the individual employee while on District property. Uniforms and/or dress code shall be inclusive of, but not limited to, neat and clean company uniforms or attire that are appropriate and easily identifiable. District identification badges shall be worn and clearly visible while on any District property.
- c) The Contractor's personnel shall have no contact with students or school staff, other than administrative staff or designated representatives, with the exception of emergency situations. The Contractor employees shall refrain from using foul, abusive, or profane language on District property.
- d) Upon arrival and departure onto any District school campus, the Contractor's employees shall enter their company information into the School Log Book provided in the Administrative office of each campus.
- e) The Vendor's personnel shall be aware that all District sites are smoke free areas. The use of tobacco products is prohibited on any property owned by the District. Vendor's personnel shall be aware that it is illegal to have in one's possession any firearm, illegal drug or alcoholic beverage while on District property; or be under the influence of any illegal drug or alcoholic beverage while on District property.
- f) When on District property, the Contractor shall strictly limit its operations to the designated work areas and shall not permit any employees to enter any other portions of District property without District's expressed prior written consent.
- g) All employees are prohibited from distributing any papers or other materials upon District property, and are strictly prohibited from using any District telephones or other office equipment.
- h) All employees shall enter and leave District facilities only through the ingress and egress points designated, from time to time, by the District.
- The Contractor shall be responsible for the removal of all trash and debris occasioned by this contract. Failure to adhere to this requirement will result in the costs of the performance of this work by others being charged to the Contractor.
- j) The Contractor shall be responsible for all damages caused by the Contractor, its Subcontractors and employees of each, and shall be held responsible for replacing or repairing any damage due to negligence on their part to any person(s) and/or property. The District may withhold payment or make such deductions as

- deemed necessary to insure reimbursement or replacement for loss or damage to property.
- k) Any existing surface or subsurface improvements, including, but not limited to, pavements, curbs, sidewalks, pipes, utilities, footings, structures, trees and shrubbery, not indicated in the contract documents to be removed or altered, shall be protected by Contractor from damage during the prosecution of any project. Any such improvements so damaged shall be restored by Contractor to condition at least equal to that existing at the time of Contractor's commencement of any project.
- I) Contractor acknowledges that work may be performed at a particular project site where the District simultaneously is conducting and continuing its operations upon the same site. In such event, Contractor shall coordinate its work so as to cause no unreasonable interference with or disruption to the District's operations. The District may perform other work related to any particular project at the site by the District's own forces, have other work performed by utility owners or let other direct contracts.
- m) If during the performance of any project, Contractor or any Subcontractor, sub-Subcontractor, agent, employee or anyone else for whom Contractor is legally liable, causes a disruption to any utilities service to other facilities or customers within a project area, Contractor shall take all actions necessary and required to immediately restore such utilities service. If Contractor fails to take such immediate actions the District shall have the right to take whatever actions it deems necessary and required to immediately restore the disrupted services, and all costs incurred by the District as a result thereof shall be reimbursed to the District by Contractor within five (5) business days of written demand for same from the District.
- n) Contractor is responsible for the safety and protection of all persons and property on or about the project site during the progress of any project. Further, it is Contractor's responsibility to protect from damage or loss all material and equipment to be incorporated into any project which may be stored off the project site. Contractor shall develop and implement, in accordance with the requirements of the contract documents (including any District rules or regulations), a safety plan for any project, as required. Contractor shall comply with all applicable codes, laws, ordinances, rules and regulations of the District and any public body having jurisdiction over any project, including all of their safety codes, laws, ordinances, rules and regulations. If Contractor observes that the Contract Documents are at variance therewith, it shall promptly notify the District in writing.
- o) When requested, Contractor shall cooperate with any ongoing District investigation involving personal injury, economic loss or damage to the District's facilities or personal property therein.
- Proper safety barricades, protective, and covering devices shall be used to divert traffic and protect personnel. Normal safety signs, necessary lighting and

- temporary fencing/barricades around work areas shall be installed and maintained in accordance with OSHA requirements while the work is in progress. Materials must be secured in accordance with OSHA regulations when not in use.
- The Contractor shall be responsible for instructing their employees in all safety measures. All equipment used by the Contractor shall be free from defects or wear that may in any way constitute a hazard to any person or persons on District property. At no time shall equipment be operated without guards, shields, or other manufacturers recommended safety accessories in place and functioning as intended by the manufacturer. All current OSHA safety standards shall be reinforced including, but not limited to, the following rules:
  - All OSHA and Federal required safety equipment shall be installed and functioning on all equipment.
  - All equipment shall be in sound working condition and must meet all OSHA Safety Standards. All workers shall be aware of and trained in the operation of all safety equipment required for this
  - iii. The Contractor shall ensure that employees are equipped with proper safety items such as glasses, hard hats, gloves, etc.
  - All incidents on campus involving District property or personnel shall be reported to the Director of Maintenance Services Department and the Campus Administrator immediately upon occurrence.
  - All debris shall be removed to an environmentally approved landfill or recycling center.

#### PERFORMANCE REQUIREMENTS MAY **RESULT TERMINATION OF CONTRACT.**

- 25. Inspection, Identification and Acceptance: Contractors shall be responsible for delivery of items in new condition meeting specification at point of destination. Contractor shall file with the carrier all claims for breakage, imperfections and other losses. If the material and/or services supplied to the District is found to be defective or does not conform to specifications, the District reserves the right to cancel the order upon written notice to the seller and return the product to the seller at the seller's expense.
- 26. Bid Bonds: Bid bonds, when required, shall be submitted with the bid in the amount specified in the detailed specifications. Bid bonds will be returned to unsuccessful Proposers.
- 27. Performance Bonds: When required and after acceptance of a proposal, the District will notify the successful Proposer to submit a recorded payment and performance bond in the amount specified in the detailed specifications.
- 28. Worker's Compensation: Contractors shall obtain and maintain during the life of the contract Workers' Compensation Insurance in compliance with Chapter 440, Florida Statutes for all of their employees employed on the project. In case any work is sublet, Contractor shall require Subcontractors similarly to provide Workers' Compensation
- 29. **Supplier Diversity Plan:** The School Board of Lee County has a goal to expand participation opportunities for Minority

- Businesses in the construction and providing of goods and services to construction projects. Minority Business participation goals, along with reporting compliance procedures will be set during the negotiation process.
- 30. **Scrutinized Companies:** By submitting a proposal, Proposer certifies that it complies with House Bill 545 which prohibits a company that is on the Scrutinized Companies that Boycott Israel List or that is engaged in a boycott of Israel from bidding on, submitting a proposal for, or entering into or renewing a contract with an agency or local government entity for goods or services of any amount. The bill also requires a contract with an agency or local governmental entity for goods or services of any amount entered into or renewed on or after July 1, 2018, to contain a provision that allows for the termination of the contract at the option of the awarding body if the company has been placed on the Scrutinized Companies that Boycott Israel List or is engaged in a boycott of Israel. An agency or local governmental entity is authorized to make a case-by-case exception to the prohibition of contracting with companies that are on the Scrutinized Companies that Boycott Israel List or that is engaged in a boycott of Israel if certain conditions are met. Additionally, the bill requires a company to provide certification that it is not engaging in a boycott of Israel before submitting a bid or entering into or renewing a contract with an agency or local governmental entity. The bill provides for preemption of any ordinance or rule of any agency or local governmental entity involving public contracts for goods or services of any amount with a company that has been placed on the Scrutinized Companies that Boycott Israel List or is engaged in a boycott of Israel.
- FAILURE TO COMPLY WITH ANY OF THE ABOVE 31. Cancellation/Termination: In the event any of the provisions of the contract awarded as a result of this ITN are violated by the Contractor, the Superintendent or designee shall give written notice to the Contractor stating the deficiencies and unless the deficiencies are corrected within ten (10) calendar days, recommendation may be made to the Board for immediate cancellation. Upon cancellation hereunder, the Board may pursue any and all legal remedies as provided herein and by law. The Board reserves the right to terminate any contract resulting from this invitation at any time and for any reason, upon giving seven (7) days prior written notice to the other party. If said contract should be terminated for convenience as provided herein, the Board will be relieved of all obligations under said contract. The Board will only be required to pay to the Contractor that amount of the contract actually performed to the date of termination. Repeated instance of failure to perform may result in cancellation of the contract and removal of the Proposer from consideration on other District contracts for the duration of the document contract period or for three years, whichever is longer, at the discretion of the Director of Procurement. The contract may be terminated in accordance with Section 287.135, Florida Statutes, by the District if:
  - a) Contractor is found to have submitted a false certification concerning inclusion on a Scrutinized Companies List;

- b) Contractor has been placed on the Scrutinized Companies that Boycott Israel List, or is engaged in a boycott of Israel;
- c) Contractor has been placed on the Scrutinized Companies with activities in Sudan List or the Scrutinized Companies with activities in the Iran Petroleum Energy Sector List; or
- d) Contractor has been engaging in business operations in Cuba or Syria.
- e) The District may at any time by written notice to the Contractor stop all or any part of the work for this ITN award. Upon receiving such notice, the Contractor will take all reasonable steps to minimize additional costs during the period of work stoppage. The District may subsequently either cancel the stop work order resulting in an equitable adjustment in the delivery schedule and/or the price, or terminate the work in accordance with the provisions of the ITN terms and conditions.
- f) Failure of the Contractor to provide products within the time specified in the ITN shall result in the following: The Buyer shall notify Contractor in writing within five (5) calendar days via the Contractor Performance Form and provide five (5) calendar days to cure. If awarded Contractor cannot provide product, the District reserves the right to purchase product from the next lowest responsive and responsible awarded Contractor. The defaulting Contractor may be responsible for reimbursing the District for price differences.
- 32. <u>Default:</u> In the event that the awarded Proposer should breach this contract, the District and the School Board reserve the right to seek all remedies in law and/or in equity.
- 33. Liability: Where Contractors are required to enter or go onto District property to deliver materials, perform work or provide services as a result of a proposal award, the awarded Contractor assumes full duty, obligation and expense of obtaining all necessary licenses, permits and insurance, and shall be fully responsible for its own negligent or willful acts or omissions. Refer to the Attachment C (Insurance Requirements form) for the District's insurance requirements.
- 34. Indemnity: This General Condition of the ITN is NOT subject to negotiation and any proposal that fails to accept these conditions may be rejected as "non-responsive", unless Contractor is entitled to sovereign immunity by action of the Florida Legislature. The District agrees to assume liability in the amounts and for the cause established in Section 768.28, Florida Statutes for only injuries or damage caused by the negligence of the District, its agents or employees in performance of the duties of this contract. Nothing herein is intended to serve as a waiver of sovereign immunity by the District. Nothing herein shall be construed as consent by the District to be sued by third parties in any matter arising out of any contract. Contractor shall hold harmless and defend the District and its agents and employees from all suits and actions, including attorney's fees and all costs of litigation and judgments of any name and description arising out of or incidental to the performance of this contract or work performed there under. This provision shall also pertain to any claims brought against the District by an employee of the

- named Contractor, any Subcontractor, or anyone directly or indirectly employed by any of them. The Contractor's obligation under this provision shall not be limited in any way by the agreed upon contract price as shown in this Contract or the Contractor's limit of, or lack of, sufficient insurance protection.
- 35. <u>Taxes:</u> The District is exempt from any Taxes. State Exemption Certificate certified on request. State Sales Tax Exemption Certificate is No. 85-8012622066C-4, and Federal Tax Identification is No. 59-6000701.
- 36. Laws and Regulations: Contractors will comply with all applicable Federal, State and Local laws, statutes and ordinances including, but not limited to the rules, regulations and standards of the Occupational Safety and Health Act of 1970, the Federal Contract Work Hours and Safety Standards Act, and the rules and regulations promulgated under these Acts. Contractors agrees not to discriminate against any employee or applicant for employment because of race, gender, religion, color, age or national origin. Lack of knowledge of applicable laws, statutes and ordinances by the Proposer shall not constitute a cognizable defense against actual or potential damages caused thereby.
- 37. Occupational Safety Hazards Act Requirements: The Proposer certifies that all material, equipment, etc., contained in the Proposal meets all Occupational Safety Hazards Act (OSHA) requirements. The Proposer further certifies that if he or she is the successful Proposer and the material, equipment, etc., delivered is subsequently found to be deficient pursuant to any OSHA requirement in effect on the date of delivery, all costs necessary to bring the material, equipment, etc. into compliance with aforementioned requirements shall borne solely by the Contractor.
- 38. Governing Law & Venue: All agreements as a result of an award hereto and all extensions and modifications thereto and all questions relating to its validity, interpretation, performance or enforcement shall be governed and construed in conformance to the laws of the State of Florida. In the event of a legal proceeding, the venue for state court shall be in Lee County Florida or for federal court shall be United States District Court, Southwest District of Florida.
- 39. <u>Drug-Free Workplace/Identical Tie Proposals:</u> Whenever two or more proposals, which are equal with respect to price, quality and service, are received for the procurement of commodities or contractual services, a proposal received from a business that certifies that it has implemented a drugfree workplace program shall be given preference in the award process. In order to have a drug-free workplace program, a business shall comply with the requirements of Florida Statute 287.087. If all tied businesses comply with the Drug-Free Workplace requirement, a coin flip will break the tie.
- 40. <u>Ethics:</u> All awarded Contractors shall comply with the requirements of law regarding ethics as set forth in Chapter 112, Florida Statutes, rules promulgated by the Florida Commission of Ethics, and District Purchasing and Bidding Policies.
- 41. <u>Conflict of Interest:</u> Proposer is subject to the provisions of Chapter 112 Florida Statutes. The Proposer must disclose with their response the name of any company owner, officer,

- director, agent or representative who is also an employee of the School District of Lee County or their immediate family which owns any interest of any amount in the Proposer's company, partnership or agency.
- 42. Use of Other Contracts: The District reserves the right to utilize other District contracts, State of Florida Contracts, school boards, other agencies, other community college/state university system cooperative proposal agreement, or to directly negotiate/purchase per School Board policy and/or State Board Rule 6A-1.012(5) in lieu of any offer received or award made as a result of this proposal, if it is in its best interest to do so. The District also reserves the right to separately propose any single order to purchase any item on this proposal if it is in its best interest to do so.
- 43. Authority to Piggyback: The School District of Lee County is a member of S.W. Florida Cooperative Purchasing Consortium. Other members include governmental entities in Charlotte, Collier, Hendry and Lee Counties. The District is also a member of the Bay Area Schools Purchasing Consortium; other members include the school boards of Brevard, Charlotte, Florida Virtual Schools, Hernando, Hillsborough, Lake, Manatee, Osceola, Pasco, Pinellas, Polk, Sarasota, and Seminole; and additional Florida school boards may join the Consortium. Upon award of this proposal, if mutually agreed upon between the successful Proposer(s) and governmental entity, submission of any proposal in response to this request constitutes a proposal made under the same conditions, for 48. Maintaining Public Records: Parties awarded a contract as a the same price, and for the same effective period as this proposal, to any other participating members of the above referenced Consortium entity.
- 44. **Invoicing and Payment:** Orders shall be processed or work performed only upon receipt of authorized purchase orders issued by The School District of Lee County Procurement

- d) The Contractor will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding, a Record Retention and access requirements to all records. The Contractor will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding, a notice, to be provided by the agency contracting officer, advising the labor union or workers' representative of the Contractor's commitments under Section 202 of Executive Order No. 11246 of September 24, 1965, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
- e) The Contractor will comply with all provisions of Executive Order No. 11246 of Sept. 24, 1965, and of the rules, regulations, and relevant orders of the Secretary of Labor.
- f) The Contractor will furnish all information and reports required by Executive Order No. 11246 of September 24, 1965, and by the rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to his books, records, and accounts by the contracting agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
- g) In the event of the Contractor's noncompliance with the nondiscrimination clauses of this contract or with any of such rules, regulations, or orders, this contract may be cancelled, terminated, or suspended in whole or in part and the Contractor may be declared ineligible for further Government contracts in accordance with procedures authorized in Executive Order No. 11246 of Sept. 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order No. 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.
- h) The Contractor will include the provisions of paragraphs (a) through (h) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to Section 204 of Executive Order No. 11246 of September 24, 1965, so that such provisions will be binding upon each Subcontractor or Contractor. The Contractor will take such action with respect to any subcontract or purchase order as may be directed by the Secretary of Labor as a means of enforcing such provisions including sanctions for noncompliance:

Provided, however, that in the event the Contractor becomes involved in, or is threatened with, litigation with a Subcontractor or Contractor as a result of such direction, the Contractor may request the United States to enter into such litigation to protect the interests of the United States.

#### Structured Cabling & Phone Systems Installation & Support

1. Overview: One electronic proposal for Structured Cabling & Phone Systems Installation & Support, must be received from eligible Proposers, submitted to the School Board's Procurement Services Department, Bonfire Platform no later than 2:00 PM EST, on November 5, 2021, to be considered. Proposers that do not comply with the School Board's procedures or deadlines will not be considered. The School Board will retain all proposer information received. The Bonfire electronic platform will not allow submissions after the opening date and time, and therefore late proposals will not be accepted or considered for award.

The District desires to secure firm prices for the purchase of services related to the Structured Cabling and Phone Systems Installation and Support used for telecommunications at approximately 100 facilities including schools and administrative sites. Contract pricing will be based on time and materials and shall be inclusive of all bonding and labor charges regardless of time of day or day of week that the work is performed. There are two (2) categories of required services:

The compilation of written questions and official responses will be issued by the Department of Procurement Services in the form of addenda and placed on the Procurement Department <u>Bonfire Portal</u>. Proposer shall be responsible for the acknowledgement of each addendum on Attachment D, the Addenda Acknowledgement Form.

# SCOPE OF WORK

#### ITN No. N217415DG

#### **Structured Cabling & Phone Systems Installation & Support**

#### 1. Preparation

#### A. Quotations:

Quotations shall be provided in a timely manner by the Contractor(s) at the request of the District. Quotations shall include:

- (1) Estimate of the time to complete the work.
- (2) Itemization of anticipated materials and bond fees.
- (3) Identification of materials as to "new" or "refurbished".

#### B. Bonding Requirements

Requirements for performance and payment bonds will be determined on a case-by-case basis and at the District's discretion.

#### C. Permitting Requirements

The Contractor(s) shall apply and obtain permits, if required by current or future statute, ordinance or regulation, through the District's building official.

#### D. Scope of Work

- (1) Prior to starting any work, the District shall clearly communicate the scope of work and any specific requirements that apply. This includes whether or not drawings will be provided to Contractor or whether or not submittals and/or as-built drawings are required to be submitted to the District by the Contractor.
- (2) Contractor acknowledges the responsibility to fully understand the scope of work and any specific requirements that apply.

#### E. Submittals

Shop drawings may be required at the discretion of the District. Telecommunication systems shop drawings shall include:

- (1) Manufacturer's data (specifications, "cut sheets").
- (2) Wiring diagrams for all installed cabling.
- (3) Equipment rack/cabinet layouts.
- (4) Proposed labeling schemes and labeling method.
- (5) List of cabling distances (typical and maximum) for all structured cabling.

#### F. Drawings

Drawings may be provided to the Contractor(s) at the discretion of the District.

#### 2. Execution

#### A. General Terms

- (1) The Contractor(s) shall be an authorized distributor for all equipment being provided with full manufacturer's warranty privileges.
  - a) Contractor(s) shall provide, within two business days upon request from the District, a letter from the manufacturer certifying the relationship at any time during the contract period.
- (2) Contractor(s) shall take direction only from the District's Information Technology Support (ITS) department or the ITS department's designee.
  - a) The ITS department's designee shall determine and approve if and when it is appropriate for Contractor(s) to take direction from school staff or other District staff.
  - b) Contractor(s) will be provided a District user account and access to the District's IT Support online help system. Work orders will be assigned to the vendor using this system. Vendor is responsible for periodically checking this system and acknowledging receipt of assigned work orders in a timely manner. Routine work orders should be accomplished within three business days. Emergency work orders will be accompanied by a phone call from the District and will require online presence in two hours or less.
- (3) If Contractor(s) discovers that any material, product, apparatus, or method of installation used to perform installation, maintenance of other related work is believed to be inadequate, incorrect, omitted, or in violation of applicable codes, standards or regulations, Contractor shall promptly inform the District in writing

- of same and shall not proceed with the work until a written response is received from the District. Any work performed contrary to this provision may result in termination of this award, non-payment for the work performed and/or correction of the work at the Contractor's expense.
- (4) Any property, equipment or work to be provided by the successful Contractor(s) under this contract will remain at the Contractor's risk until written acceptance by the District and the Contractor(s) will replace at the Contractor's expense, all property, equipment or work damaged or destroyed by any cause whatsoever prior to written acceptance by the District.
- (5) All systems shall be installed in accordance with manufacturer's written instructions and with recognized industry practices.

#### B. Delivery, Storage, and Handling Logistics

(1) Materials delivered to the construction site shall be stored in a dry, secure area, preferably indoors. Storage temperature of materials shall adhere to manufacturer's recommendations. Movement of packaged materials shall be in a manner to avoid damage of contents. On-site storage, either indoors or trailer, shall have permission by District, and shall not interfere with other construction activity.

#### C. Cable pathways and Firestops

- (1) Cable pathways, including conduit, cable trays, ladder rack, slots, sleeves, etc. shall be located and mounted according to contract drawings (where applicable) and manufacturer's instructions. These devices shall be installed and properly bonded/grounded per applicable codes and standards. Pathways shall not be installed in or transit through wet areas. Cable tray shall not be modified for installation in such a manner as to void warranty or become non-compliant with applicable codes or standards.
- (2) Cable pathway fill ratio, bend radius, run length, number of bends, and proximity to EMI sources shall be in accordance with ANSI/TIA/EIA-569-B. Maximum cable count of the initial installation shall not exceed 40% fill ratio in any pathway.
- (3) In accordance with NEC 2011, power wiring and communications cabling shall not share the same pathway or outlet unless separated by a physical barrier.
- (4) Cable pathways shall be secured to a structural member of the building, or permanent wall studs. Wall surfaces for raceway mounting should be finished complete.
- (5) Metallic pathways shall be electrically continuous, free of sharp edges, and properly bonded to an approved ground. EMI sources such as ballasts, motors, and bus conductors shall be avoided by using proper separation distances.
- (6) Pathways that penetrate fire-rated barriers shall be fire stopped according to local codes and recognized practices. Fire stop materials or devices shall be qualified to UL-1479, in accordance with ASTM E814. Fire stop method shall have P.E. approval.
- (7) Core drilling of holes for fire-rated poke-through outlet devices shall have approval by a structural engineer or THE DISTRICT P.E. on the contract drawings prior to start of work.
- (8) Pathways for vertical cable runs, such as slots and sleeves, shall be installed in the proper location in accordance with applicable codes and standards.

#### D. Protection

- (1) Contractor(s) shall provide all necessary transient protection on the AC power feed and on all station lines and trunk lines leaving or entering the building at all main termination cabinets, to include voice, speaker, C/O trunks, etc.
- (2) A power line surge protection must be installed at the dedicated electrical receptacle to minimize the effects from high static voltage, low level transients, and ripple effects.
- (3) Contractor(s) shall note the type and location of these protection devices in the as-built drawings when required.

### E. Change Orders

- (1) Any deviation from the scope determined by the District shall be submitted as a written change order. No work indicated in the change order shall be performed without District approval.
- (2) The District reserves the right to specify documentation requirements for change orders.
- (3) Significant changes may require a written quotation from the Contractor(s) subject to the quotation requirements.

#### 3. Inspections and Closeout

#### A. Inspection Requirements

- (1) Jobs that may in any way affect fire alarm or fire suppression systems will require a final inspection by the District's fire official.
- (2) Upon completion of the installation of equipment, the contactor shall verify that the equipment is operating properly in accordance with these specifications and the equipment manufacturer's operating instructions. This verification shall be accomplished in conjunction District personnel. The verification shall include both a physical inspection and appropriate tests to verify switch and station equipment performance.

#### B. Quality Assurance and Testing

- (1) All work performed shall comply with ANSI/EIA/TIA 568-B "Commercial Buildings Telecommunications Cabling Standard" and EIA/TIA TSB-36 "Additional Cable Specifications Unshielded Twisted Pair Cables."
- (2) All methods of installation are shall be subject to control and approval by the District.
- (3) Compliance with respect to all of the following is required for all work:
  - a) FCC Compliance:
    - Comply with Part 68 and Subpart J of Part 15, Federal Communications Commission Rules, pertaining to telephone equipment and Class A computer registration by manufacturer.
    - Provide telephone and computer equipment with FCC labels indicating applicable FCC registration and numbering. Must be NANP compliant.
  - b) NEC Compliance Comply with NEC as applicable to communication system materials and installations.
  - c) IEEE Compliance Comply with STD 241, "IEEE Recommended Practice for Electric Power Systems in Commercial Buildings" pertaining to communication systems.
  - d) NEMA Compliance Comply with NEMA's Pub. No. 250, "Enclosures for Electrical Equipment" (1000 Volts maximum).
  - e) EIA Compliance Comply with EIA Standards RS-453, "Dimensional, Mechanical and Electrical Switching Equipment for Voiceband Applications", 455 and 464 pertaining to installation of telephone systems.
  - f) Rural Electrification Administration (REA) Telephone Engineering and Construction Manuals REA Specifications and Bulletins Spec PE22, Spec PE39, Spec PE89, Spec PE72, Spec PC2, Bul 345-13, Bul 345-28, Bul 345-61, Bul 345-63, Bul 345-6, Spec PC4.
  - g) 26 05 33 Raceway and Boxes for Electrical Systems.
  - h) 27 13 00 Communication Backbone/Horizontal Cabling.
- (4) The Contractor(s) shall correct punch list items determined to be in violation of drawings, specifications, codes, standards or regulations at no cost to the District.
- (5) The Contractor(s) shall be responsible for timely re-work of faulty cabling or hardware installation.
- (6) The District reserves the right to withhold final payment until punch list items are resolved satisfactorily.
- (7) Category 6 Cable
  - a) Installed category 6 balanced UTP cabling systems and field test results shall strictly adhere to requirements of ANSI/TIA/EIA-568-c.1 and ANSI/TIA/EIA-568-c.2.
  - b) All wiring shall be certified to meet or exceed the specifications as set forth in TIA/EIA-568B for Category 6 requirements for permanent link.
  - c) Installed category 6 balanced UTP, STP, and fiber cabling systems, pathways and distribution facilities shall adhere to manufacturer's instructions, drawings (where applicable), specifications, applicable codes, standards, and regulations.
  - d) Category 6 cabling systems shall be tested as an installed horizontal permanent link configuration.
  - e) All tests shall be performed to 250MHz.
  - f) Field Testing shall include the following for each pair of each cable installed:
    - Name of the person performing the test.
    - Test equipment manufacturer and model number.
    - Cable I.D. The test sheets will be in numerical order by cable ID.
    - Date of test.
    - Wire map (pin to pin connectivity and polarity check)
    - Length (in feet)
    - Insertion Loss.
    - Near End Crosstalk (NEXT).

- Power Sum Near End Crosstalk (PSNEXT).
- Equal-Level Far End Crosstalk (ELFEXT).
- Power Sum Equal-Level Far End Crosstalk (PSELFEXT).
- Return Loss.
- Delay Skew.
- Attenuation to Crosstalk ratio (ACR).
- g) A "PASS" indication shall be obtained for each link, using at minimum a level III tester that complies with TIA/EIA-568-B.2 field test requirements.
- h) A link warranty may be required at the discretion of the District. The following requirements apply to Link warranties.
  - The length of the extended warranty shall be a minimum of twenty-five (25) years.
  - A warranty covering all components, equipment and workmanship shall be submitted in writing with system documentation.
  - The warranty period shall begin on the system's first use by the District.
  - Should the cabling system fail to perform its expected operation within this warranty period due to inferior or faulty material and/or workmanship, the Contractor shall promptly make all required corrections without cost to the District.
  - Upon completion of the project the Telecommunication Contractor shall forward the signed Warranty Registration Form and warranty certificate to the Owner.
  - Record test results for each cable and turn over to the District upon completion of the job. Correct malfunctions when detected, and re-test to demonstrate compliance.

#### (8) Optical Fiber

- a) Installed optical fiber cabling systems and field test results shall strictly adhere to requirements of ANSI/TIA/EIA-568-c.3.
- b) Test procedures shall be as described by the TIA/EIA-568-B: Commercial Building Telecommunications Cabling Standard, Parts 2 and 3 and TIA/EIA-526-14-A Optical Power Loss Measurements of Installed Multimode Fiber Cable Plant-OFSTP-14A.
- c) Each terminated fiber strand in the horizontal or backbone infrastructure shall be tested individually as a permanent link. A fiber permanent link is defined as a length of individual fiber strand with a connector terminated on each end.
- d) Testing for multimode shall be at 850 and 1300 nanometers. Total link insertion loss (dB) shall be within the specified link loss budget.
- e) Tier 1 testing for each installed singlemode link shall be performed as an optical power insertion loss measurement, as defined by ANSI/TIA/EIA-526-7. Testing for singlemode shall be at 1310 and 1550 nanometers. Total link insertion loss (dB) shall be within the specified link loss budget.
- f) Tier 2 testing, if required for each installed singlemode or multimode link, shall be performed as an OTDR measurement, as defined in TIA-TSB-140. We require Tier 2 testing on all fibers installed in the facility for future troubleshooting.
- g) Multimode optical fiber attenuation shall be tested on all individual fibers of each cable segment using an LED light source and power meter to determine the actual loss. These tests shall be performed at the 850nm and 1300nm windows in both directions. Test set up and performance shall be in accordance with ANSI/TIA/EIA-526-14A, Method B.
- h) A reference power measurement shall be obtained by connecting one end of test jumper 1 to the light source and the other end to the power meter. After recording the reference power measurement, test jumper 1 shall be disconnected from the power meter without disturbing the light source and attached to the cable plant. The power meter shall be moved to the far end of the cable plant and attached to the cable plant with test jumper 2.
- i) Readings must not be higher than the "Optimal Attenuation Loss." The OAL will be calculated using the manufacturer's factory certified test results, (db/km) converted to the actual installed lengths plus the manufacturer's best published attenuation losses for the connector and/or splice installed on this project. (0.30+/-0.30 for Connectors and 0.10 for splices).
- j) Test results must be completed and turned over to the District prior to active equipment installation.

#### (9) Test Results Documentation

- a) All test results are to be saved electronically. Test documentation submitted on disk shall be clearly marked on the cover with the words "Project Test Documentation", the project name, and the date of completion (month and year). For multiple buildings, the building name, including floor or wing I.D. should also be included on the test results disk.
- b) File names of the test results recorded for each link shall match the official identification. Test results shall include a complete record for each link, including type of test, cable type, cable/port I.D., measurement direction, reference setup, date, and technician's name(s).
- c) The test equipment name, manufacturer, model number, serial number, software version and last calibration date shall also be provided in the test results documentation.
- d) When repairs and re-tests are performed, the problem cause and corrective action taken shall be noted, and both the failed and passed test data shall be documented.
- e) The District reserves the right to request verification of test results with a re-test of installed cables, on a sampling basis. Re-testing shall be at the expense of the Contractor(s).

#### (10) Drawings

- a) As-Built drawings may be required at the discretion of the District. The District shall specify prior to requesting work whether the work requires additions to drawings or submission of as-built drawings.
  - As-built drawings shall at minimum include detailed cable and pathway layouts, exact locations of workstation outlets, and cable distribution hardware locations. Workstation outlets shall have alphanumeric identifiers on the drawings as specified by the District.
  - Field changes that are completed without issuance of revised drawings shall be clearly denoted on the working as-built drawing.

#### 4. Safety Requirements

- A. Contractor will comply with all requirements of Sections 1012.32 1012.465,1012.467, and 1012.468, Florida Statutes, by certifying that the Contractor and all of its employees, its subcontractors and their employees who provide services under this contract have completed the background screening required by the referenced statutes and meet the standards established by the statutes. This certification will be provided to the District in advance of the Contractor providing any services on campus while students are present. The Contractor will bear the cost of acquiring the background screening, and any fee imposed by the Florida Department of Law Enforcement to maintain the fingerprints provided with respect to Contractor and its employees. Contractor will provide The District a list of its employees and subcontractors and their employees who have completed background screening as required by the referenced statutes and meet the statutory requirements. Contractor will update these lists in the event that any employee listed fails to meet the statutory standards or new employees who have completed the background check and meet standards are added. Contractor agrees that in the event the Contractor or any employee, subcontractor or subcontractor employee who the Contractor has certified as completing the background check and meeting the statutory standards then is arrested for of any disqualifying offense, the Contractor will notify The District within 48 hours of such. The parties agree that in the event that Contractor fails to perform any of the duties described in this paragraph, this will constitute a material breach of the contract entitling The District to terminate immediately with no further responsibility to make payment or perform any other duties under this contract. Contractor agrees to indemnify and hold harmless The District, its officers and employees from any liability in the form of physical injury, death, or property damage resulting from The District's failure to comply with the requirements of this paragraph or Sections 1012.32, 1012.465, 102.467, and 1012.468 Florida Statutes.
- B. Contractor acknowledges that Work may be performed at a particular Project site where The District simultaneously is conducting and continuing its operations upon the same site. In such event, Contractor shall coordinate its Work so as to cause no unreasonable interference with or disruption to The District's operations. The District may perform other work related to any particular Project at the site by The District's own forces, have other work performed by utility owners or let other direct contracts.
- C. Contractor acknowledges that the Work may be progressing on a Project site which is located upon or adjacent to an existing District facility. In such event, Contractor shall comply with the following:
  - (1) All District facilities are smoke free. Smoking is strictly prohibited. Alcohol, drugs and all illegal substances are strictly prohibited on any District property. All employees of Contractor, as well as those of all

- subcontractors and those of any other person or entity for whom Contractor is legally liable (collectively referred to herein as "Employees"), shall not possess or be under the influence of any such substances while on any District property. Further, Employees shall not bring on to any District property any gun, rifle or other firearm, or explosives of any kind;
- (2) Contractor shall strictly limit its operations to the designated work areas and shall not permit any Employees to enter any other portions of The District's property without The District's expressed prior written consent;
- (3) All Employees are prohibited from distributing any papers or other materials upon The District's property, and are strictly prohibited from using any of The District's telephones or other office equipment;
- (4) All Employees shall at all times comply with OSHA regulations with respect to dress and conduct at the Project site. Further, all Employees shall comply with the dress, conduct and facility regulations issued by The District's officials onsite, as said regulations may be changed from time to time;
- (5) All Employees shall enter and leave District facilities only through the ingress and egress points designated, from time to time, by The District;
- (6) When requested, Contractor shall cooperate with any ongoing District investigation involving personal injury, economic loss or damage to District facilities or personal property therein;
- (7) Interaction between the Employees and the teacher and student population is strictly prohibited;
- D. Contractor agrees to keep each Project site clean at all times of debris, rubbish and waste materials arising out of the Work. If Contractor fails to keep a Project site clean, The District has the right, after providing a twenty-four (24) hour written notice, to perform any required clean up and to back charge Contractor for the costs of such clean up. At the completion of the Work Contractor shall remove all debris, rubbish and waste materials from and about that Project site, as well as all tools, appliances, construction equipment and machinery and surface materials, and shall leave the Project site clean and ready for occupancy by The District.
- E. Any existing surface or subsurface improvements, including, but not limited to, pavements, curbs, sidewalks, pipes, utilities, footings, structures, trees and shrubbery, not indicated in the Contract Documents to be removed or altered, shall be protected by Contractor from damage during the prosecution of the Work. Any such improvements so damaged shall be restored by Contractor to condition at least equal to that existing at the time of Contractor's commencement of the Work.
- F. If during the performance of the Work, Contractor or any subcontractor, sub-subcontractor, agent, employee or anyone else for whom Contractor is legally liable, causes a disruption to any Utilities service to other facilities or customers within a Project area, Contractor shall take all actions necessary and required to immediately restore such Utilities service. If Contractor fails to take such immediate actions The District shall have the right to take whatever actions it deems necessary and required to immediately restore the disrupted services, and all costs incurred by The District as a result thereof shall be reimbursed to The District by Contractor within five (5) business days of written demand for same from The District.
- G. Contractor is responsible for the safety and protection of all persons and property on or about the Project site during the progress of the Work. Further, it is Contractor's responsibility to protect from damage or loss all material and equipment to be incorporated into the Work which may be stored off the Project site. Contractor shall develop and implement, in accordance with the requirements of the Contract Documents (including any District rules or regulations), a safety plan for the Work. Contractor shall comply with all applicable codes, laws, ordinances, rules and regulations of Owner and any public body having jurisdiction over the Work, including all of their safety codes, laws, ordinances, rules and regulations. If Contractor observes that the Contract Documents are at variance therewith, it shall promptly notify The District and Design Professional in writing.
- H. Safety Standards All current OSHA safety standards shall be enforced. The Contractor shall ensure that their employees are equipped with proper safety items. The Contractor shall be responsible for the supervision and direction of the work performed by their employees. The Contractor shall be responsible for instructing their employees in all safety measures. All equipment used by the Contractor shall be maintained in safe operating condition at all times, and be free from defects or wear that may in any way constitute a hazard to any person or persons on school district property. All current OSHA safety standards shall be reinforced including the following rules:
  - (1) All OSHA and Federal required safety equipment shall be installed and functioning on all equipment.
  - (2) All equipment shall be in sound working condition and must meet all OSHA Safety Standards. All workers shall be aware of and trained in the operation of all safety equipment required for this project.

- (3) The Contractor shall ensure that employees are equipped with proper safety items such as glasses, hard hats, gloves, etc.
- (4) All incidents on campus involving district property or personnel shall be reported to the designated school contact immediately upon occurrence.
- (5) All debris shall be removed to an environmentally approved landfill or recycling center.
- (6) Normal safety signs, necessary lighting and temporary fencing/barricades around work areas shall be installed and maintained in accordance with OSHA requirements while the work is in progress. Materials must be secured in accordance with OSHA regulations when not in use.
- (7) Proper safety barricades, protective, and covering devices shall be used to divert traffic and protect personnel.
- (8) Services shall comply with all governing codes and regulations and shall meet or exceed the accepted standards of the industry. No statement within this proposal request shall negate compliance with any applicable governing regulation.
- (9) The Contractor shall ensure that employees comply with the District's policies and guidelines regarding COVID-19-related PPE (Personal Protective Equipment), including face masks and social distancing guidelines.
- The Contractor is required to be familiar with and comply with all current federal, state and local laws, codes, rules and regulations. All work shall conform to all laws, ordinances, codes, rules and regulations including state, local and federal. Services shall comply with all governing codes and regulations and shall meet or exceed the accepted standards of the industry. NO STATEMENT WITHIN THIS DOCUMENT SHALL NEGATE COMPLIANCE WITH ANY APPLICABLE GOVERNING REGULATION.
