Budget Source	Up to \$3,500,000.00 will be funded from budgeted Transportation Services Department funds. This agenda item is specifically for the approval of the award. Funds will only be expended within the existing resources of the applicable location.
Recommended Action	Approval to award ITN N227424DO for Vehicle Parts and Services, to Florida Transportation Systems, Inc., IEH Auto Parts, LLC d/b/a AutoPlus Auto Parts, J&K Auto Parts, Inc. d/b/a NAPA Auto Parts, Rechten International Trucks, Inc., and Southeast Power Systems of Fort Myers, Inc., as indicated on the attached tabulation sheet. This ITN will be effective for three years, beginning January 24, 2023 through January 23, 2026, with renewal options for three additional one-year periods, upon the written agreement of the vendor and the District, for up to \$3,500,000.00, for the first year of the base contract period of January 24, 2023 through January 23, 2024. This ITN supports the purchase of vehicle parts for District buses and District white fleet vehicles at a discounted rate. This ITN also supports the servicing of District buses and District white fleet vehicles that are beyond the qualifications of District technicians. Approval authorizes the Superintendent to execute all related documents.
Goals	Objective 5 - Increase Operational Efficiency and Effectiveness

Invitation to Negotiate No. N227424DO is for Vehicle Parts and Services. This ITN supports the purchase of vehicle parts for District buses and District white fleet vehicles at a discounted rate. This ITN also supports the servicing of District buses and District white fleet vehicles that are beyond the qualifications of District technicians. It is recommended the award be made to Florida Transportation Systems, Inc., IEH Auto Parts, LLC d/b/a AutoPlus Auto Parts, J&K Auto Parts, Inc. d/b/a NAPA Auto Parts, Rechten International Trucks, Inc., and Southeast Power Systems of Fort Myers, Inc., as indicated on the attached tabulation sheet, effective for three years, beginning January 24, 2023 through January 23, 2026, with renewal options for three additional one-year periods, for up to \$3,500,000.00, for the first year of the base contract period of January 24, 2023 through January 23, 2024. Eighty-five (85) vendors were notified of the ITN, five (5) vendors submitted a Proposal, zero (0) vendors submitted a No Bid and eighty (80) vendors did not respond.
