Public Content

Invitation to Negotiate No. N207380RC is for Paving Services. This ITN is utilized by the Maintenance Services Department for District-wide paving services that include: blacktop overlay, seal coat, resurfacing of parking lots, driveways, D-curbings, borders of parking lots, car stops for parking areas, running tracks, tennis courts and other paving projects. This ITN also includes products such as pavers, top soil, ball field clay, base rock, sand, gravel and fill. On April 13, 2021, this ITN was awarded to Bateman Contracting, LLP in Fort Myers, Big League Builders, Inc. in Fort Myers, Pavement Maintenance, LLC in Fort Myers and Tobler Construction, Inc. in Fort Myers, for a three-year period, beginning April 19, 2021 through April 18, 2024, with renewal options for three additional one-year periods, upon the written agreement of the vendors and the District. The anticipated projects include, but are not limited to:

- \$1,500,000.00 – Day-to-day repairs (Capital Project Fund)
- \$150,000.00 – Cypress Lake High School (Capital Project Fund)
- \$125,000.00 – Pinewoods Elementary (Capital Project Fund)
- \$75,000.00 – Bonita Springs Elementary School (Capital Project Fund)

It is recommended the Board approve the renewal with Bateman Contracting, LLP in Fort Myers, Big League Builders, Inc. in Fort Myers, Pavement Maintenance, LLC in Fort Myers and Tobler Construction, Inc. in Fort Myers, for the first renewal period of April 19, 2024 through April 18, 2025, for up to \$1,850,000.00, pursuant to the same terms and conditions as previously approved by the Board.
