Budget Source	The increase of up to \$1,000,000.00 will be funded from budgeted Maintenance Services Department funds. This agenda item is specifically for a one-time approval to increase the previously Board approved amount of \$475,000.00 by \$1,000,000.00, for up to \$1,475,000.00. Funds will only be expended within the existing resources of the applicable location.
Recommended Action	Approval to increase the previously Board approved amount of \$475,000.00 by \$1,000,000.00, for up to \$1,475,000.00, with All Digital Technology, located in Fort Myers; Integrated Fire & Security Solutions, Inc., located in Fort Myers; Johnson Controls Fire Protection located in Fort Myers; Summit Fire & Security, LLC, located in Fort Myers and Total Fire Protection d/b/a Total Fire Protection of Michigan, located in Fort Myers, for the period of March 26, 2024 through November 16, 2024, pursuant to the same terms and conditions as previously approved by the Board. The \$1,000,000.00 increase is requested by Maintenance Services for additional projects that were requested in the Capital Plan that was approved in December 2023. Approval authorizes the Superintendent to execute all related documents.

ITN No. N217403ES is for Fire Alarm Systems - Maintenance and Repairs. Services and products include installation, maintenance and repairs of fire alarm systems software; purchase and replacement of defective parts associated with fire alarm systems; performing the necessary reprogramming of software and/or equipment; and making warranty repairs throughout the District. On November 16, 2021 the School Board of Lee County approved this ITN, awarded to All Digital Technology, located in Fort Myers, FL; Integrated Fire & Security Solutions, Inc., located in Fort Myers, FL; Johnson Controls Fire Protection located in Fort Myers, FL; Summit Fire & Security, LLC, located in Fort Myers, FL and Total Fire Protection d/b/a Total Fire Protection of Michigan, with location in Fort Myers, FL, beginning November 17, 2021 through November 16, 2024. The \$1,000,000.00 increase is requested by Maintenance Services for additional projects that were requested in the Capital Plan that was approved in December, 2023. The anticipated projects include, but are not limited to:

- \$189,000.00 – Estero High School – Fire Alarm Upgrades (Capital Funds)
- \$189,000.00 – Skyline Elementary School – Fire Alarm Upgrades (Capital Funds)
- \$179,000.00 – Villas Elementary School – Fire Alarm Upgrades (Capital Funds)
- \$170,000.00 – Maintenance Services Department – Day to Day (Capital Funds)
- \$150,000.00 – Gateway Elementary School – Fire Alarm Upgrades (Capital Funds)
- \$123,000.00 – Caloosa Elementary School – Fire Alarm Upgrades (Capital Funds)

It is recommended the Board approve the increase to the previously Board approved expenditure amount of \$475,000.00, by \$1,000,000.00, for up to \$1,475,000.00, with All Digital Technology, located in Fort Myers, FL; Integrated Fire & Security Solutions, Inc., located in Fort Myers, FL; Johnson Controls Fire Protection located in Fort Myers, FL; Summit Fire & Security, LLC, located in Fort Myers, FL and Total Fire Protection d/b/a Total Fire Protection of Michigan, with location in Fort Myers, FL, for the period of March 26, 2024 through November 16, 2024, pursuant to the same terms and conditions as previously approved by the Board.
