Recommended Action	Approval to renew ITB No. B207396JC for Custodial Tools for District Warehouse Operations (DWO), awarded to Agni Enterprises, LLC d/b/a Head to Heels Safety Supplies, in Miami, FL; All Florida Paper, Inc., in Miami, FL; Imperial Dade, in Miami, FL; and Pyramid School Products, in Tampa, FL, for the third and final renewal period of July 27, 2024 through July 26, 2025, for up to \$200,000.00, pursuant to the same terms and conditions as previously approved by the Board. Approval authorizes the Superintendent to execute all related documents.

Invitation to Bid No. B207396JC is for Custodial Tools for District Warehouse Operations (DWO). Products include brooms, mops, trash cans and lids, mop buckets and floor squeegees, and other items. On July 27, 2021, this ITB was awarded to Agni Enterprises, LLC d/b/a Head to Heels Safety Supplies, in Miami, FL; All Florida Paper, Inc., in Miami, FL; Imperial Dade, in Miami, FL; Pyramid School Products, in Tampa, FL; Sam Tell & Son, Inc., in Farmingdale, NY; and Tranzonic d/b/a CCP Industries, Inc., in Richmond, OH, for a one-year period, beginning July 27, 2021 through July 26, 2022, and renewed through July 26, 2024. It is recommended the Board approve the renewal with Agni Enterprises, LLC d/b/a Head to Heels Safety Supplies in Miami, FL; All Florida Paper, Inc., in Miami, FL; Imperial Dade in Miami, FL; and Pyramid School Products in Tampa, FL, for the third and final renewal period of July 27, 2024 through July 26, 2025, for up to \$200,000.00, pursuant to the same terms and conditions as previously approved by the Board. On July 27, 2021, Sam Tell and Son, Inc., in Farmingdale, NY; was originally awarded and withdrew their bid. On April 10, 2023, Tranzonic d/b/a CCP Industries, in Richmond, OH; chose not to renew.
