Recommended Action Approval to award ITN No. N237447AN for Voluntary Group Legal Plan, to MetLife Legal Plans, Inc., as indicated on the attached tabulation sheet. This ITN will be effective for three years, beginning April 1, 2024 through March 31, 2027, with renewal options for three additional one-year periods, upon the written agreement of the vendor and the District. The School Board of Lee County offers employees working twenty (20) or more hours per week, in a regular position, a menu of voluntary (employee paid) benefits. Legal services include, but are not limited to advice and consultation, consumer protection matters, etc. The Insurance Task Force (ITF) subcommittee, comprised of ITF members, including representatives from Insurance and Benefits Management and the Florida Education Association, reviewed the scoring committee recommendation in their August 3, 2023 meeting.
