Budget Source	Up to \$185,000.00 will be funded from budgeted Maintenance Services Department funds. This agenda item is specifically for the approval of the renewal. Funds will only be expended within the existing resources of the applicable locations.
Recommended Action	Approval to renew ITN No. N197365RC for Waste Removal (Grease Traps, Sewer Plants and Lift Stations), awarded to Wind River Environmental, LLC d/b/a A-1 Gator, in Fort Myers, FL for the second renewal period of January 23, 2024 through January 22, 2025 for up to \$185,000.00, pursuant to the same terms and conditions as previously approved by the Board. Services include removal/pumping out of grease, refuse, dregs, scraping of sides; cleaning and washing of kitchen grease traps; and the complete cleaning of all waste, refuse, debris and dregs, etc., from wastewater plants and lift stations. Approval authorizes the Superintendent to execute all related documents.

Invitation to Negotiate No. N197365RC is for Waste Removal (Grease Traps, Sewer Plants and Lift Stations). Services include removal/pumping out of grease, refuse, dregs, scraping of sides; cleaning and washing of kitchen grease traps; and the complete cleaning of all waste, refuse, debris and dregs, etc., from wastewater plants and lift stations. On December 10, 2019, this ITN was awarded to Wind River Environmental, LLC d/b/a A-1 Gator, in Fort Myers, FL as the primary vendor and Rockfill Associates, LLC d/b/a Crews Environmental, in Fort Myers, FL as the secondary vendor, for a three-year period, beginning January 23, 2020 through January 22, 2023, and renewed through January 22, 2024, with two more renewal options available. It is recommended the Board approve the renewal with Wind River Environmental, LLC d/b/a A-1 Gator, in Fort Myers, FL for the second renewal period of January 23, 2024 through January 22, 2025, for up to \$185,000.00, pursuant to the same terms and conditions as previously approved by the Board. Rockfill Associates, LLC d/b/a Crews Environmental, in Fort Myers, FL did not renew.
