This agenda item is specifically for a one-time approval to increase the previously Board approved amount of \$100,000.00 by \$50,000.00, for a total amount up to \$150,000.00. Funds will only be expended within the existing resources of the applicable locations.
Recommended Action	Approval to increase the previously Board approved amount of \$100,000.00 by \$50,000.00, for a not to exceed amount up to \$150,000.00, with Affordable Carts Holdings, LLC of North Fort Myers, B&W Golf Cars, Inc. of Naples, Coastal Carts of Fort Myers, Gator Golf Cars & Utility Vehicles, LLC of Fort Myers and Wesco Turf, Inc. of Sarasota, for the period of August 8, 2023 through January 9, 2024, pursuant to the same terms and conditions as previously approved by the Board. The \$50,000.00 increase is being made to the first year of the base contract period and is requested due to additional services needed under this contract. Approval authorizes the Superintendent to execute all related documents.

Invitation to Negotiate No. N227422MG is for Golf Cart Purchase, Repairs and Services. This ITN will be utilized for the purchase, maintenance, parts and services of golf carts, utility vehicles, speciality vehicles, accessories and equipment, parts, and related products and services on an as needed basis. On January 10, 2023 this ITN was awarded to Affordable Carts Holdings, LLC of North Fort Myers, B&W Golf Cars, Inc. of Naples, Coastal Carts of Fort Myers, Gator Golf Cars & Utility Vehicles, LLC of Fort Myers and Wesco Turf, Inc. of Sarasota. for the period of January 10, 2023 through January 9, 2026, with renewal options for three additional one-year periods. The \$50,000.00 increase is being made to the first year of the base contract period and is requested due to additional services needed under this contract. It is recommended the Board approve the increase to the previously Board approved expenditure amount of \$100,000.00, by \$50,000.00, up to \$150,000.00, with Affordable Carts Holdings, LLC, B&W Golf Cars, Inc., Coastal Carts, Gator Golf Cars & Utility Vehicles, LLC and Wesco Turf, Inc., for the period of August 8, 2023 through January 9, 2024, pursuant to the same terms and conditions as previously approved by the Board.
