The \$700,000.00 increase is requested due to additional services needed to cover staff shortages. Approval authorizes the Superintendent to execute all related documents.

Invitation to Negotiate No. N247468MG is for Plumbing Repair Services. Services will support plumbing needs throughout the District. On January 23, 2024 the School Board of Lee County approved this ITN, awarded to Ackerman Plumbing, Inc., in Sarasota, FL, Page Mechanical Group, LLC, in Fort Myers, FL, and United Mechanical, Inc., in Fort Myers, FL, beginning January 23, 2024 through January 22, 2027, with renewal options for three additional one-year periods. The \$700,000.00 increase is requested due to additional services needed to cover staff shortages. The anticipated projects include, but are not limited to:

- \$500,000.00 Day-to-day repairs (Capital Funds)
- \$150,000.00 North Fort Myers Academy for the Arts: Re-pipe project (Capital Funds)
- \$50,000.00 S.W. Florida Public Service Academy: Re-pipe project (Capital Funds)

It is recommended the Board approve the increase to the previously Board approved expenditure amount of \$330,000.00, by \$700,000.00, for up to \$1,030,000.00, with Ackerman Plumbing, Inc., in Sarasota, FL, Page Mechanical Group, LLC, in Fort Myers, FL and United Mechanical, Inc., in Fort Myers, FL, for the period of July 30, 2024 through January 22, 2025, pursuant to the same terms and conditions as previously approved by the Board.
