- Five (5) years of Highly Effective/Effective teaching experience with English Language Learner (ELL) students.
- Valid Florida teaching certificate.
- Bilingual/biliterate in English and in a minimum of one (1) target language (Spanish, French, Creole, etc.).
- Proven experience successfully managing business/department functions and staff preferred.
- Industry certification preferred.
- Lean Six Sigma Certification preferred.

Such alternatives to the above qualifications as the Board may find acceptable.

KNOWLEDGE, SKILLS, AND ABILITIES:

- Clear and concise oral and written communication skills; analytical, mathematical, organizational, and prioritization skills; flexibility and adaptability in dealing with rapidly changing priorities and demands; interpersonal skills.
- Written and oral linguistic skills in English and in a minimum of one (1) target language (Spanish, French, Creole, etc.).
- Knowledge of and the ability to interpret and enforce pertinent regulations, policies, and procedures for the functional area of assignment.
- Knowledge of and experience using multiple project management tools and methodologies.
- Knowledge of HIPAA, Public Records, Sunshine Law, FERPA, and other laws/regulations related to student and employee privacy, public information, and records retention.
- Ability to translate as needed in English and in a minimum of one (1) target language (Spanish, French, Creole, etc.).

- Provide training to teachers, ESOL educators, assistants, and administrators.
- Assist schools with Department of Education's annual monitoring of ESOL programs, full-time equivalency (FTE), and data issues.
- Update and distribute the ESOL procedural manual.
- Provide technical assistance regarding the Multicultural Education, Training, and Advocacy, Inc. (META) Consent Decree and Title III (Immigrant Entitlement).
- Conduct the Parent Advisory Council meetings and Parent Leadership Council meetings as required by the Department of Education for compliance.
- Adhere to good safety procedures.
- Assist with the revision of the District's ELL Plan as required by the Department of Education.
- Contribute to the monthly ESOL newsletter.
- Assist with state and federal reports.
- Perform Medicaid administrative claims reimbursable activities as directed in accordance with Chapter 3 of the federally approved School District Administrative Claiming (SDAC) Guide.

This factor is important if the amount of balancing exceeds that needed for ordinary locomotion and maintenance of body equilibrium.	10%

This factor is important if the amount and kind of climbing required exceeds that required for ordinary locomotion.	10%

<input checked="" type="checkbox"/> Crouching	Bending the body downward and forward by bending leg and spine.	10%
<input checked="" type="checkbox"/> Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips.	80%
