MAJOR FUNCTION:

Serve as liaison between school personnel, parents, and District ESE/Gifted Department personnel.

MINIMUM QUALIFICATIONS:

- Valid Florida teaching certificate.
- Current employee of the School District of Lee County.

Such alternatives to the above qualifications as the Board may find acceptable.

KNOWLEDGE, SKILLS, AND ABILITIES:

- Interpersonal skills.
- Ability to relate to and inspire confidence in students.
- Knowledge of and experience with organizing student activities and events.
- Organizational, leadership, and managerial skills.
- Oral and written communication skills.
- Ability to lead diverse groups of people.
- Knowledge of and experience with industry-standard computer applications.

REPORTS TO: Designated Supervisor or Designated Administrator

ESSENTIAL JOB FUNCTIONS:

- Gather documentation throughout the school year of enrichment/differentiation within core instruction in student's portfolio.
- Provide classroom teacher with nomination form and oversee accurate completion.
- Ensure recent hearing/vision evaluation is complete prior to referral for assessment.
- Send home parent letter to request signature for permission to evaluate along with Parent Gifted Information Tool.
- Upon return of the above forms, schedule and screen students using COG-AT Form 7, consulting with the school psychologist as needed.
- Notify parent if student does not meet COG-AT criteria.
- If student does meet criteria, send Optional LSS Status Form for Gifted Plan B Matrix to parent if appropriate.
- Review Nomination Form, add COG-AT score, and send completed package including nomination form, signed parent letter, completed parent tool,

and optional LSS Status Form if completed to District ESE/Gifted Department.

- Assist with obtaining completed gifted characteristics checklist from classroom teacher.
- After student is evaluated and staffed, receive the folder from the District ESE/Gifted Department and review to determine if the student is eligible or ineligible.
- If ineligible, file the student folder in the cumulative folder.
- If eligible, notify teacher of gifted to write an Education Plan (EP) for the student detailing the gifted services to be provided to the student.
- Serve as contact person between the District and the school's administration and teachers for all gifted education matters.
- Provide answers to parents' questions and concerns regarding the gifted identification process.
- Receive updated class lists of students who are gifted and distribute to teachers.
- Work with District staff and teachers to ensure that all EPs are in compliance for FTE and Student Assignment purposes.
- Adhere to District policies and procedures.

OTHER JOB FUNCTIONS:

- Attend staff meetings and participate in conferences and other trainings to enhance job performance.
- Seek out professional development opportunities and maintain professional licensure and certifications.
- Promote the District's interest in increasing student achievement by working with the educational interests of students in mind at all times.
- Maintain positive communication with colleagues, community members, parents, and students to promote an increase in community engagement in education.
- Support the retention of Highly Effective and Effective employees by exhibiting professionalism and making positive contributions to workplace morale.
- Promote a culture of high performance and continuous improvement by valuing learning and making a commitment to quality.

Physical Requirement	Description	Percent of Time
<input checked="" type="checkbox"/> Balancing	Maintaining body equilibrium to prevent falling and walking, standing or crouching on narrow, slippery, or erratically moving surfaces. This factor is important if the amount of balancing exceeds that needed for ordinary locomotion and maintenance of body equilibrium.	10%
<input checked="" type="checkbox"/> Climbing	Ascending or descending ladders, stairs, scaffolding, ramps, poles and the like, using feet and legs and/or hands and arms. Body agility is emphasized. This factor is important if the amount and kind of climbing required exceeds that required for ordinary locomotion.	10%
<input checked="" type="checkbox"/> Crawling	Moving about on hands and knees or hands and feet.	10%
<input checked="" type="checkbox"/> Crouching	Bending the body downward and forward by bending leg and spine.	10%
<input checked="" type="checkbox"/> Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips.	30%
<input checked="" type="checkbox"/> Finger Dexterity	Picking, pinching, typing or otherwise working, primarily with fingers rather than with the whole hand as in handling.	70%

<input checked="" type="checkbox"/> Hearing	Perceiving the nature of sounds at normal speaking levels with or without correction. Ability to receive detailed information through oral communication, and to make the discriminations in sound.	100%

<input checked="" type="checkbox"/> Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position-to-position. This factor is important if it occurs to a considerable degree and requires substantial use of upper extremities and back muscles.	10%
<input checked="" type="checkbox"/> Pulling	Using upper extremities to exert force in order to draw, haul, or tug objects in a sustained motion.	10%
<input checked="" type="checkbox"/> Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward, or outward.	10%
