Budget Source	Up to \$425,000.00 will be funded from budgeted Maintenance Services Department funds. This agenda item is specifically for the approval of the award. Funds will only be expended within the existing resources of the applicable location.
Recommended Action	Approval to award ITN No. N257513LA for Landscaping Services, to 12 Stones Landscaping, LLC, in North Fort Myers, FL; BMG Lawn Professionals, in North Fort Myers, FL; Green Technologies of SWFL, LLC, in North Fort Myers, FL; and Gulf Lawn Services, Inc., in North Fort Myers, FL, as indicated on the attached tabulation sheet. This ITN will be effective for three years, beginning February 10, 2026 through February 9, 2029, with renewal options for three additional one-year periods, upon the written agreement of the vendor and the District, for up to \$425,000.00, for the first year of the base contract period of February 10, 2026 through February 9, 2027. Approval authorizes the Superintendent to execute all related documents.

Invitation to Negotiate No. N257513LA is for Landscaping Services. Services and Products include and are not limited to: Category A - mowing, weed whacking, and edging; Category B - landscaping services; and Category C - tree trimming and removal. It is recommended the award be made to 12 Stones Landscaping, LLC, in North Fort Myers, FL; BMG Lawn Professionals, in North Fort Myers, FL; Green Technologies of SWFL, LLC, in North Fort Myers, FL; and Gulf Lawn Services, Inc., in North Fort Myers, FL, as indicated on the attached tabulation sheet, effective for three years, beginning February 10, 2026 through February 9, 2029, with renewal options for three additional one-year periods, for up to \$425,000.00, for the first year of the base contract period of February 10, 2026 through February 9, 2027. Ninety-four (94) vendors were notified of the ITN, five (5) vendors submitted a Proposal, and eighty-nine (89) vendors did not respond.
