Approval to piggyback Broward County Public Schools FY21-113, for Furnish and Install Stage Draperies, awarded to Luxout Products, Inc., in Richmond, VA, with locations in Florida (Primary), Heritage Products Resources, Inc., in Mulberry, FL (Alternate), and Solotech, Inc., (Formerly Miami Stagecraft, Inc.) in Miami, FL (Alternate), for the period of October 1, 2024 through September 30, 2025, for up to \$175,000.00, with an option to cancel if deemed to be in the best interest of the District. Approval authorizes the Superintendent to execute all related documents.

Goals Strategic Priority: Improving Internal Operating Systems

Broward County Public Schools FY21-113, for Furnish and Install Stage Draperies, was awarded to Luxout Products, Inc., in Richmond, VA, with locations in Florida (Primary), Heritage Products Resources, Inc., in Mulberry, FL (Alternate), and Solotech, Inc., (Formerly Miami Stagecraft, Inc.) in Miami, FL (Alternate), for the period of October 1, 2020 through September 30, 2023 and extended through September 30, 2025. This piggyback will be utilized for the replacement of stage curtains. The anticipated projects include, but are not limited to:

- \$65,000.00 Day-to-day (Capital Funds)
- \$30,000.00 Mariner High School: Replacement stage curtains (Capital Funds)
- \$30,000.00 Cypress Lake High School: Replacement stage curtains (Capital Funds)
- \$25,000.00 Estero High School: Replacement stage curtains (Capital Funds)
- \$25,000.00 Mariner Middle School: Replacement stage curtains (Capital Funds)

It is recommended the Board approve this piggyback, for up to \$175,000.00, for the period of October 1, 2024 through September 30, 2025, with an option to cancel if deemed to be in the best interest of the District.
