Budget Source	Up to \$756,625.00 will be funded from budgeted Maintenance Services Department funds. This agenda item is specifically for the approval of the piggyback. Funds will only be expended within the existing resources of the applicable location.
Recommended Action	Approval to piggyback The School District of Manatee County ITB No. 26-0041-MR, for Park and Playground Equipment, awarded to multiple vendors including, but not limited to, PlayCore Wisconsin, Inc., d/b/a GameTime, in Longwood, FL; Playmore West, Inc., in Fort Myers, FL; and Swartz Associates, Inc., in Naples, FL, for the period of December 1, 2025 through August 31, 2026, for up to \$756,625.00, with an option to cancel if deemed to be in the best interest of the District. Approval authorizes the Superintendent to execute all related documents.

The School District of Manatee County ITB No. 26-0041-MR, for Park and Playground Equipment, was awarded to multiple vendors including, but not limited to, PlayCore Wisconsin, Inc., d/b/a GameTime, in Longwood, FL; Playmore West, Inc., in Fort Myers, FL; and Swartz Associates, Inc., in Naples, FL, for the period of September 1, 2025 through August 31, 2030. This contract supports District sites for the purchase of bleachers, park and playground equipment, outdoor furniture, and associated parts and hardware on an as-needed basis when funds are available. The anticipated projects include, but are not limited to:

- \$250,000.00 – Maintenance Services Department Day-to-Day Expenses (General Fund)
- \$157,500.00 – Lehigh Elementary School (playground ages 5 - 12)(Referendum Fund)
- \$105,000.00 – J. Colin English Elementary School (playground ages 2 - 5) (Referendum Fund)
- \$82,687.50 – Lehigh Elementary School (playground ages 2 - 5)(Referendum Fund)
- \$82,687.50 – Pelican Elementary School (Referendum Fund)
- \$78,750.00 – Hancock Creek Elementary School (playground ages 2 - 5)(Referendum Fund)

It is recommended that the Board approve this piggyback, for up to \$756,625.00, for the period of December 1, 2025, through August 31, 2026, with an option to cancel if deemed to be in the best interest of the District.
