MAJOR FUNCTION:

Support and supervise individual school-based mentors through strengthening school program implementation, engaging in continuous improvement, and submitting timely student outcome data.

MINIMUM QUALIFICATIONS:

- Bachelor's degree from an accredited institution.
- Valid Florida teaching certificate.
- Three (3) years of Highly Effective/Effective teaching experience with at least one (1) year within the School District of Lee County.

Such alternatives to the above qualifications as the Board may find acceptable.

- Organizational, leadership, interpersonal, and managerial skills.
- Ability to establish collaborative relationships with students, parents, and school and District staff.
- Ability to relate to and inspire confidence in students and staff.

- Ability to assess student attendance, behavior, and course performance data.
- Oral and written communication skills.
- Ability to work with and lead diverse groups of people.
- Knowledge of and experience with industry-standard computer applications.

<input checked="" type="checkbox"/> Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips.	80%
