February 5, 2026, for up to \$3,200,000.00, with an option to cancel if deemed to be in the best interest of the District. Approval authorizes the Superintendent to

execute all related documents.

Goals Strategic Priority: Improving Internal Operating Systems

Lee County Board of County Commissioners ITB No. B230548WCD, for Athletic Turf Maintenance and Reconstruction, was awarded to JSM Services, Inc., in Fort Myers, FL, for the period of February 6, 2024 through February 5, 2027. This piggyback will allow for athletic field maintenance work including, but not limited to, reconstructing turf surfaces and laser-level sports fields; aerating; top dressing; fertilizing; and spraying for weeds, herbicides, pesticides, etc. The anticipated projects include, but are not limited to:
